Analysis of Candidates Contesting in Punjab 2012 Assembly Elections

- 61 candidates out of the 408 candidates analyzed with self declared pending criminal cases against them are contesting the Punjab 2012 Assembly Elections.
- Out of these 61 candidates, 22 candidates have declared serious pending criminal cases such as murder, attempt to murder, kidnapping, robbery etc against them.
- All major parties have given tickets to candidates with pending criminal cases. INC has 23 out of 116 (20%), SAD has 18 out of 93 (19%), BSP has 9 out of 61 (15%), PPP has 7 out of 89 (8%) candidates analyzed with pending criminal cases.
- A total of 266 candidates out of 408 analyzed i.e. 65% are crorepati. In the Assembly Elections of 2007, a total of 184 candidates out of 462 analyzed (40%) were crorepati.
- Out of 408 candidates analyzed for Punjab Assembly Elections 2012, only 29 (7%) candidates are women; the number of women candidates for INC is 10 out of 116 (9%), for SAD it is 10 out of 83 (12%), for PPP it is 4 out of 89 (4%), for BSP it is 2 out of 61 (3%) and for BJP it is 2 out of 21 (10%).

Chandigarh /Delhi, January 23rd, 2011: Association for Democratic Reforms (ADR) and Punjab Election Watch (PEW), the Punjab chapter of National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, has been working on electoral reforms, improving democracy and governance in India. Punjab Election Watch (PEW) has analyzed affidavits of 408 candidates contesting in Punjab 2012 Assembly Election. This report is based on the analysis of these affidavits. There are a total of 117 constituencies going for polls in Punjab 2012 Assembly Elections. The following pages give party- wise and candidate-wise analysis of criminal, financial, education, age, gender and other background information of the contesting candidates.

Executive summary of Candidates

- Punjab Election Watch (PEW) has analyzed affidavits of 408 candidates out of 1078 candidates who are contesting the 2012 Assembly Elections.
- Out of these 408 candidates analyzed, 61 candidates (15 %) declared pending criminal cases against them. INC has 23 out of 116 (19%), SAD has 18 out of 93 (19%), BSP has 9 out of 61 (15%), PPP has 7 out of 89 (8%) candidates analyzed with pending criminal cases. In the 2007 assembly elections, 66 candidates out of 462 analyzed had declared pending criminal cases against them. INC had 14 out of 92 (7%) and BJP had 2 out of 23 (9%) candidates analyzed with pending criminal cases, cases against them.
- Out of these 61 candidates with pending criminal cases, 22 had serious criminal cases like murder, attempt to murder, kidnapping, robbery etc against them. INC had 8 , BSP had 5 , SAD had 5, PPP had 2 , CPI had 1 .
- A total of 266 candidates out of 408 analyzed (65%) are crorepati. In the 2007 assembly elections, a total of 184 candidates out of 462 analyzed (40%) were crorepati.
- A total of 42 candidates out of 408 analyzed declared liabilities above 1 crore.
- Among major parties, the average asset per candidate for INC is 9.8 crore, for SAD it is 6.9 crore, for BJP it is 6.5 crore and for PPP it is 3.3 crore.
- 190 out of 408 candidates analyzed i.e. 47% are graduates or with higher educational qualifications.
- Out of 408 candidates analyzed for Punjab Assembly Elections 2012, only 29 (7%) candidates are women; the number of women candidates for INC is 10 out of 116 (9%), for SAD it is 10 out of 83 (12%), for PPP it is 4 out of 89 (4%), for BSP it is 2 out of 61(3%) and for BJP it is 2 out of 21 (10%).

Number of parties and candidates in Punjab Elections

In 2007 Punjab Assembly Elections, 36 parties had contested the elections. Compared to this, in the 2012 elections, approximately 37 parties are contesting elections; this reflects an increase of approximately 3% in the number of contesting parties.

A total of 1055 candidates contested in 2007 while 1078 candidates are contesting in 2012 Assembly Elections. There is a very minute increase of 2% in the number of candidates contesting the elections from Punjab 2007 Assembly Elections to Punjab 2012 Assembly Elections.

Analysis based on pending criminal cases- candidates

A total of 408 affidavits were analyzed by Punjab Election Watch (PEW) for 2012 Assembly Elections. Out of these 408 analyzed candidates, 61 (15%) declared that they have criminal cases against them. Out of these 61 candidates with criminal cases, 22 had serious criminal cases like murder, attempt to murder, kidnapping, robbery etc against them.

A comparison between candidates with pending criminal cases in Punjab Assembly Elections held in 2007 and 2012 respectively shows that for major parties like INC, BJP, BSP and the number of candidates with pending criminal cases has increased in 2012 elections as compared to the 2006 Assembly Elections.
