# **Punjab 2012 Assembly Elections**

Punjab 2012 Assembly Elections was held on Feb, 2012. A total of 1078 candidates contested in Punjab Assembly Elections. This report includes the analysis of criminal, financial, educational and other details of 117 newly electesd MLAs. Information provided by the Election Commission of India and CEO Punjab and details from the affidavits filed by the candidates have been used for the analysis.

# **Representation of political parties and candidates**

A total of 1078 candidates contested Punjab 2012 Assembly Elections representing 37 parties. In 2007, 1043 candidates contested representing 37 parties for Punjab Assembly Elections.

This reflects an increase of 3.35% in the number of candidates contesting election from Punjab 2007 Assembly Elections to Punjab 2012 Assembly Elections while the ratio of political parties contested remained same.

A total of 1078 candidates contested in Punjab 2012 Assembly Elections representing 37 parties. Out of these, only 3 parties (i.e. SAD, INC and BJP) managed to reserve places in 2012 Punjab Assembly.

# **Executive summary of MLAs**

# **Summary of MLAs**

- Affidavits of all 117 MLAs are analyzed by Punjab Election Watch (PEW).
- Out of 117 MLAs analyzed, 22 (19%) have pending criminal cases against them. Comparing this to Punjab 2007 Assembly Elections, out of 117 MLAs analyzed, 21 (18%) had pending criminal cases against them.
- Out of these 22 (19%) MLAs with pending criminal cases, there are pending serious criminal cases against 8 MLAs (7%).
- Out of 22 MLAs with pending criminal cases in Punjab 2012 Assembly, 11 MLAs are from INC, 9 from SAD and 2 are independent.
- MLAs with pending criminal cases have slightly increased from 21 in Punjab Assembly 2007 to 22 in Punjab Assembly, 2012.
- There are a total of 14 IPC charges of heinous nature on the MLAs. These included murder, kidnapping, extortion, etc.
- The number of crorepati MLAs has increased from 77 (66%) in Punjab 2007 Assembly Elections to 101 (86%) in Punjab Assembly, 2012.
- Out of 101 crorepati MLAs in Punjab 2012 Assembly, 47 are from SAD, 41 from INC, 10 from BJP and 3 are independent MLAs.
- Among major parties, the average asset per MLA for INC is Rs. 13.97 crores, for SAD is Rs 7.93 crores, and for BJP is Rs.4.68 crores.
- Average asset for a MLA from Punjab is Rs 9.92 crores.
- Out of 117 MLAs analyzed, 4 have not declared their PAN details.
- A total of 12 MLAs (10.3%) out of 117 MLAs have declared that they have never filed Income Tax returns.





- Out of the above 12 MLAs who have never filed ITR, 4 have not given their PAN details.
- A total of 64 (55%) MLAs (out of 117 analyzed) in Punjab 2012 Assembly Election are graduate and above.
- Out of 93 women candidates contested, only 14 won. Hence only 12% of MLAs in current Punjab Assembly are women.

# Analysis based on pending criminal cases

# Analysis based on the pending criminal cases –MLAs

PEW has analysed affidavits of all 117 MLAs. 22 MLAs out of these 117 MLAs from Punjab Assembly, 2012 have pending criminal cases against them. Of these 22 MLAs, there are pending serious criminal cases against 8 MLAs. Comparing this with Punjab Assembly Elections 2007, 6 MLAs had serious criminal cases pending against them.

# Party- wise break up of MLAs with pending criminal cases

Out of total 22 MLAs with pending criminal cases, 9 MLAs are from SAD and 11 are from INC. The partywise break-up of MLAs is given below:

The table below gives a summary of all serious violent offences related to murder, kidnapping, extortion, theft, robbery and dacoity. As can be seen from the table MLAs of SAD has 6 serious IPC counts against them, while MLAs from INC have 3 serious IPC counts each pending against them.

The election results seemed to be highly influenced by the money power of candidates.
