Rajasthan 2008 Assembly Elections

Rajasthan Assembly Elections, 2008 was held during the month of December, 2008. This report includes the analysis of criminal, financial, educational background and other details of the candidates and winners of these elections. Information provided by the Election Commission of India and details from the affidavits filed by the candidates have been used for the analysis.

Growth of political parties

In 2003 Rajasthan Assembly Elections, 34 political parties contested which rose to 45 in 2008 Rajasthan Assembly Elections. This reflects a rise of 32% in the number of political parties contested from Rajasthan 2003 Assembly Elections to Rajasthan 2008 Assembly Elections.

Executive summary of MLAs and candidates

Summary of MLAs

- Affidavits of 199 MLAs out of 200 MLAs were analyzed by REW.
- Out of 199 MLAs analyzed 30 (15%) have pending criminal cases against them. INC has 15 out of 95 (16%) MLAs with pending criminal cases, BJP has 5 out of 78 (6%), BSP has 3 out of 6 (50%), CPM has 1 out of 3 (33%) and LSWP has 1 out of 1 (100%) MLAs with pending criminal cases.
- Out of these 30 MLAs with pending criminal cases, there are pending serious criminal cases against 8 MLAs. BSP has 2, INC has 5 and CPM has 1 MLAs with pending serious criminal cases.
- Out of 87 (44% of 199 analyzed) crorepati MLAs in 2008 Rajasthan Assembly, 43 are from INC, 36 are from BJP, 2 from BSP, 5 are independent and 1 is from LSWP.
- Average asset for an MLA from Rajasthan is Rs 1.88 crores.
- Among major parties, the average asset per MLA for BSP is Rs 3.44 crores, for BJP and for INC is Rs. 1.66 crores.
- Out of 199 MLAs analyzed, 48 MLAs have not declared their PAN details.
- Out of 199 MLAs analyzed, only 28 are women. Hence only 14% of MLAs in current Rajasthan assembly are women.

Summary of Candidates

- Rajasthan Election Watch (REW) analyzed affidavits of 397 candidates out of 2194 who contested in 2008 Assembly elections.
- Out of these 397 candidates analyzed, 56 (14%) candidates declared pending criminal cases against them. INC had 23 out of 171 (13%), BJP had 16 out of 168 (10%) and BSP had 6 out of 16 (38%) candidates with pending criminal cases.
- Out of these 56 candidates with pending criminal cases, 14 (4%) had pending serious criminal cases like murder, attempt to murder, kidnapping, extortion etc. INC had 6, BJP had 3, BSP had 3 and CPM had 1 candidate with pending serious criminal cases against them.
- There were 37 IPC charges of heinous nature on the candidates analyzed which included murder, attempt to murder, kidnapping, extortion, etc.
- A total of 165 candidates out of 397 analyzed i.e. 42% were crorepatists.

- A total of 118 candidates out of 397 analyzed, had declared liabilities of Rs 5 lakhs or above.
- Among major parties, the average asset per candidate for INC was Rs. 2.05 crores, for BJP it was 1.53 crores and for BSP it was 1.74 crores.
- 25% of candidates (98 out of 397 analyzed) had not furnished PAN card details.
- Number of women candidates were just 154 (7%) as compared to 2040 of men (93%).
- More than 58% of candidates (229 of 397 analyzed) were graduates or with higher educational qualification.

Analysis based on pending criminal cases – MLAs

REW has analysed affidavits of 199 MLAs out of 200 MLAs. 30 MLAs out of the 199 MLAs analyzed from Rajasthan Assembly in 2008 have pending criminal cases against them. Of these 30 MLAs, there were pending serious criminal cases against 8 MLAs.

Party- wise break up of MLAs with pending criminal cases

Out of total 30 MLAs with pending criminal cases, INC has 15 out of 95 (16%) MLAs with pending criminal cases, BJP has 5 out of 78 (6%), BSP has 3 out of 6 (50%), CPM has 1 out of 3 (33%) and LSWP has 1 out of 1 (100%) MLAs with pending criminal cases.

Analysis based on pending criminal cases- candidates

Affidavits of 397 candidates were analyzed by Rajasthan Election Watch (REW) for 2008 Assembly elections. Out of the 397 candidates, 56 or 14% declared pending criminal cases against them. Out of these 56 candidates with pending criminal cases, 14 had pending serious criminal cases like murder, attempt to murder, kidnapping, extortion, etc. pending against them.

Party-wise break up of candidates with pending criminal cases

A total of 56 candidates contesting elections from Rajasthan had pending criminal cases against them. Out of 171 candidates of INC, 23 (13%) had pending criminal cases, out of 168 candidates of BJP, 16 (10%) had pending criminal cases, out of 16 candidates of BSP, 6 (38%) had pending criminal cases, out of 3 candidates of CPM, 1 (33%) had pending criminal case, out of 2 candidates of LSWP, 1 (50%) had pending criminal cases against them.
