



# Criminal, Financial and other details of MPs (LS & RS) of Uttarakhand

## Summary of Uttarakhand MPs - Lok Sabha

- There are a total of 5 Lok Sabha members from Uttarakhand and all of them are from INC.
- Harish Rawat from INC is the only member of Lok Sabha from Uttarakhand who has a pending criminal case against him.
- 4 out of the 5 MPs (80%) are crorepatis.
- Satpal Maharaj has the highest assets worth Rs 11 crores.
- Pradeep Tamta with about 16 lakhs has the lowest assets
- The average asset of these 5 MPs is Rs. 3.66 crores.
- INC MP K.C.Singh Baba has the highest liabilities of Rs.6.49 lakhs
- 3 out of 5 MPs are graduates and above with Mr. Pradeep Tamta being a post graduate. Mr. K.C. Singh Baba and Mr. Satpal Maharaj are 12th pass.
- There are no women MPs from Uttarakhand in Lok Sabha.

### Summary of Uttarakhand MPs - Rajya Sabha

- There are 3 MPs in Rajya Sabha from Uttarakhand. 2 are from BJP and 1 from INC.
- None of the Rajya Sabha MPs have criminal cases pending against them.
- Sri Satyavrat Chaturvedi of INC has the highest assets of Rs. 2.63 crores. Also he is the only crorepati MP in Rajya Sabha from Uttarakhand.
- Koshyari Shri Bhagat Singh from BJP has the lowest assets worth Rs. 23.7 lakhs
- Average asset per MP is Rs. 1.06 crores
- Tarun Vijay of BJP has declared the highest liabilities of Rs. 4.04 lakhs followed by Sri Bhagat Singh Koshyari with Rs 1.2 lakhs.
- 2 of the 3 MPs from Rajya Sabha are graduates and above.
- There are no women MPs from Uttarakhand in the Rajya Sabha.

Mr. Harish Rawat from INC is the only MP from Uttarakhand of Lok Sabha who has a pending criminal case.
