Executive summaries of MLAs

Mizoram Election Watch (MEW) has analyzed affidavits of the 38 MLAs (out of the maximum 40) in the current assembly.

Criminal

- **MLAs with Criminal Cases:** Out of these 38 MLAs analyzed for Mizoram Assembly Elections, 2 MLAs or 5% have declared criminal cases against them. Both the MLAs are from INC and none have declared serious criminal cases against them.

Financial

- **Average Assets:** Average Asset per MLA (of 38 analyzed MLAs) in current Assembly is **Rs. 57.85 lakhs**. Among major parties, the average asset per MLA for **INC** is **52.44 lakhs** (30 MLAs), for **MNF** is **1.04Crores**(3 MLAs), and for **ZNP** is **98.94 lakhs** (2 MLAs).
- **Cronepati MLAs:** A total of 13 (34%) out of 38 MLAs analyzed are crorepatis.
- **Highest Asset MLAs:** **Zodintluanga** of **INC** from Thorang constituency has declared the highest assets worth **Rs 2.28Crore**, followed by **Lalthanhawla** of **INC** from Serchhip with declared assets worth **Rs 2.22 Crore** and **S.Hiato** of **INC** from Saiha constituency with assets worth **Rs 2.01Crore**. From MNF the MLA with maximum assets is **Dr.R.Lalthangliana** from Lunglei west constituency with assets worth **Rs. 1.72crores**.
- **Low Assets:** 6 MLAs have declared assets of less than Rs 15 lakhs.
- **MLAs with low assets:** **Lalrobiaka** of **INC** from Dampa constituency has declared the lowest assets of **Rs. 5.81 lakhs**. **R.L.Pianmawia** of **INC** from Tuivawl constituency has declared assets of **Rs. 6.85 lakhs**. **H.Zothangliana** of **INC** from Lawngtlai East constituency has declared assets of **Rs. 8 lakhs**. From MNF the MLA with lowest assets is **C.Ramhluna** from Lawngtlai west constituency with assets worth **Rs. 15.33 lakhs**.
- **Liabilities:** A total of 5 (13%) MLAs out of 38 analyzed have declared liabilities of Rs. 10 lakhs or above.
- **High Liability MLAs:** The top three MLAs with highest liabilities are **Joseph Lalhimpua** an **INC** MLA from Lunglei East with declared the highest liabilities worth **Rs. 25.14 lakhs** followed by **H.Zothangliana** of **INC** from Lawngtlai East constituency with liabilities of **Rs. 20.60 lakhs** and **LalrinlianaSailo** an **INC** MLA from Tuichang constituency with liabilities worth **Rs 11.80 lakhs**.
- **MLAs with no PAN:** None of the MLAs has declared their PAN card details.

Analysis based on declared criminal cases – MLAs

Mizoram Election Watch (MEW) has analyzed affidavits of 38 elected MLAs. Out of the 38 MLAs analyzed for Mizoram Assembly election, 2 MLAs or 5% have declared criminal cases against them.

Party- wise break up of MLAs with declared criminal cases

Out of these 38 MLAs analyzed for Mizoram Assembly Elections, 2 MLAs or 5% have declared criminal cases against them. All 2 MLAs who have declared criminal cases are from INC and none have declared serious criminal cases against them.
