Asset Comparison of Re-Contesting Candidates in Mizoram 2013 Assembly Elections

Summary of asset comparison of re-contesting candidates

Mizoram Election Watch and Association of Democratic reforms (ADR) have analysed self-sworn affidavits of all **142 candidates** contesting in the Mizoram Assembly Elections 2013.

66 re-contesting (candidates who fought elections in 2008 and now in 2013 are again in the fray) candidates have been analyzed for the Mizoram Assembly Elections 2013

- The average assets of these 66 re-contesting candidates fielded by various parties in 2008 was **Rs.74,54,894 (74.54 Lakhs)**
- The average assets of these re-contesting candidates now in 2013 is **Rs.2,61,26,335 (2.61 Crores)**
- The average asset growth for these re-contesting candidates is **Rs.1,86,71,441 (1.86 Crores)**
- Average percentage growth in assets for these re-contesting candidates is **250%**

Summary of asset comparison of re-contesting MLAs

- **MLAs Contesting Again:** Mizoram Election Watch and Association for Democratic Reforms analyzed 36 outgoing MLAs who are contesting again in the 2013 Mizoram Assembly Elections.
- **Average Assets in 2008 Elections:** The average asset of these 36 re-contesting MLAs fielded by various parties in 2008 was **Rs 82.81 Lakhs**.
- **Average Assets in 2013 Elections:** The average asset of these 36 re-contesting MLAs now in 2013 is **Rs 2.62 Crores**.
- **Average Asset growth in 5 years (2008-2013):** The average asset growth for these 36 re-contesting MLAs, between the Mizoram Assembly Elections of 2008 and 2013, is **Rs 1.79 Crores**.
- **Percentage growth in 5 years (2008-2013):** Average percentage growth in assets for these 36 re-contesting MLAs is **217%**.
- **Highest growth In Assets in 5 years (2008-2013):** Lal Thanhawla of INC from Hrangturzo constituency has declared maximum increase in assets with an increase of **Rs 6.92 Crores** i.e from Rs 2.22 Crores in 2008 to Rs. 9.15 Crores in 2013. Assets of **John Rotluangliana** of INC from Mamit constituency has increased by **Rs 5.40 Crores**, from Rs 1.03 Crores in 2008 to Rs 6.44 Crores in 2013. Assets of **C.Ramhluna** of MNF from Lawngtlai West has risen by **Rs 5.14 Crores**, from Rs 15.33 Lakhs in 2008 to Rs 5.29 Crores in 2013.

Asset Comparison of Re-Contesting MLAs in Chhattisgarh 2013 Assembly Elections

Average asset increase of re-contesting MLAs: Party-Wise

Financial details of 36 re-contesting MLAs fielded by political parties have been taken from the recently filed affidavits by these MLAs and the values of these financial assets have been compared to the corresponding values of the assets that the MLAs showed in their affidavits in 2008. 2 MNF MLAs have shown the highest asset increase of **Rs 3.80 Crores** followed by 30 INC MLAs with an average asset increase of **Rs. 1.80 Crores**. Following table showcases the party wise assortment of the average increase in assets of the re-contesting MLAs:

Top 5 re-contesting MLAs with highest asset increase (Percentage - wise)

The highest percentage increase (**3355%**) in assets has been declared by C.Ramhluna of MNF from Lawngtlai West constituency. C.Ramhluna's assets increased from **Rs. 15.33 Lakhs in 2008 to Rs 5.29 Crores** in 2013. Lalrobiaka of INC from Dampa constituency has declared an increase in assets of **2306%**; his assets have risen from **Rs.5.81 Lakhs in 2008 to Rs 1.40 Crores** in 2013. H.Zothangliana of INC from Lawngtlai East constituency has shown third highest growth with **1351%** increase in assets; his assets have grown from **Rs 8.0 Lakhs in 2008 to Rs 1.16 Crores** in 2013.

Lal Thanhawla of INC from Hrangturzo constituency has declared maximum increase in assets with an increase of Rs 6.92 Crores i.e from Rs 2.22 Crores in 2008 to Rs. 9.15 Crores in 2013. Assets of John Rotluangliana of INC from Mamit constituency has increased by Rs 5.40 Crores, from Rs 1.03 Crores in 2008 to Rs 6.44 Crores in 2013. Assets of C.Ramhluna of MNF from Lawngtlai West has risen by Rs 5.14 Crores, from Rs 15.33 Lakhs in 2008 to Rs 5.29 Crores in 2013.
