Analysis of income, expenditure and donations received by major political parties of Maharashtra [FY 2012-13]

This report, prepared by Association for Democratic Reforms (ADR) and Maharashtra Election Watch (MEW), focuses on various sources of income and items of expenditure of National Political Parties and the regional parties of Maharashtra during the financial year 2012-13. The National Parties include Indian National Congress (INC), Bharatiya Janata Party (BJP), Bahujan Samaj Party (BSP), Nationalist Congress Party (NCP), Communist Party of India (CPI) and Communist Party of India (Marxist) (CPM). The regional parties include Shiv Sena (SHS), Rashtriya Janata Dal (RJD) and Maharashtra Navnirman Sena (MNS).

Executive summary

II. **Total income versus total expenditure of political parties:** The total income and expenditure of political parties is calculated from their IT returns filed with the Income Tax Department annually.




Chart: Comparison of total income received and expenditure incurred by political parties of Maharashtra during FY 2012-13





III. Total income of political parties of Maharashtra from all over India:

• The total income of National Parties for FY 2012-13 was Rs. 991.21 crores. INC declared the highest total income of Rs. 425.69 crores, followed by BJP with Rs. 324.16 crores and BSP with a declared total income of Rs. 87.63 crores. NCP a declared total income of Rs. 26.56 crores, CPI, Rs. 1.07 crores and CPM declared a total income of Rs. 126.09 crores for FY 2012-13.




Chart: Total income of national political parties [FY 2012-13]

• The total income for the regional parties of Maharashtra was Rs. 5.31 crores. MNS did not submit its IT Returns to the IT Department. While SHS declared an income of Rs 4.26 crores, RJD declared Rs 1.04 crores as its income.

IV. Number of donors contributing above Rs 20,000 to political parties from all over India [FY 2012-13]:

- The total amount of donations received above Rs. 20,000 by political parties of Maharashtra during FY 2012-13 is calculated from the donations report submitted to the Election Commission annually.
- The total donations received by National Parties above Rs 20,000 declared were **Rs. 99.14 crores**, from **3777** donors.
- BSP declared that the party received no donations above Rs 20,000 during FY 2012-13.








Chart: Total number of donors from all over India donating above Rs 20,000 to national political parties in FY 2012-13

- Political parties received a sum of Rs 21.37 crores from donors based in Maharashtra. While BJP received
 Rs 20.62 crores from 45 donors in Maharashtra, INC received Rs 0.1 crores from 11 donors based in
 Maharashtra.
- All of the donations received by SHS and MNS were from donors belonging to Maharashtra. SHS received Rs 0.36 crores from 28 donors, while MNS received Rs 0.23 crores from 8 donors.
- RJD has declared that it received no donations above Rs 20,000 in FY 2012-13.




Chart: Number of donors to the political parties which received donations from Maharashtra



• Corporate/ business sector tops the list of contributions with 88% or Rs 1 crore to the political parties followed by individual donations with 12% or Rs 0.13 crores.

VII. Donors who have not declared details of PAN:

- A total of 30 out of 95 donors (or 31.58%) contributing Rs 7.76 crores to the political parties have not declared their PAN details in the contribution form.
- BJP has 15 donors from Maharashtra, donating Rs 759.75 lakhs to the party without PAN details. INC has 11 donors from Maharashtra, donating a total of Rs 5.49 lakhs, who have not revealed their PAN details. SHS has 2 donors donating Rs 5.52 lakhs without PAN details. MNS also has 2 donors donating a total of Rs 5.25 lakhs without revealing PAN details.




Chart: Donors who have not revealed their PAN details [FY 2012-13]

Recommendations of ADR

- The Supreme Court gave a judgment on September 13, 2013 declaring that no part of a candidate's affidavit should be left blank. Similarly, no part of the Form 24A submitted by political parties providing details of donations above Rs 20,000 should be blank.
- Full details of all **donors should be made available for public scrutiny under the RTI**. Some countries where this is done include Bhutan, Nepal, Germany, France, Italy, Brazil, Bulgaria, the US and Japan. In none of these countries is it possible for 75% of the source of funds to be unknown, but at present it is so in India.
- Details of donors who make **donations to the Electoral Trusts should be available in the public domain** for increasing transparency in funding of political parties.
- Any party which does not submit its donation statement to the ECI on or before 31st Oct should be heavily
 penalized and its income should not be tax-exempted. Strict action must also be taken against parties which do
 not file their IT returns.
- Those parties not following the ICAI guidelines for auditing of reports should be scrutinized by the IT department.
- The National and regional political parties must provide all information on their finances under the Right to Information Act. This will only strengthen political parties, elections and democracy.





Detailed Report

Political parties represent citizens of the country at various levels of the government, voice people's demands and needs in the administrative and legislative sphere, and therefore serve as the link between citizens and the government.

Apart from collecting donations / voluntary contributions, it is seen from the IT Returns of political parties that there is a coupon system being adopted by a few parties for collecting funds by issuing of coupons in lieu of receipts to donors for cash contributions. Being cash donations, it becomes all the more difficult to establish the identity of the donor. This implies that a lot of cash donations received remain unaccounted for in the books of accounts as only those amounts would be recorded for which a receipt has been issued. Thus, it is imperative to have a strict regulatory mechanism wherein political parties have to report the correct quantum and the source of donations received.

Association for Democratic Reforms (ADR) had obtained copies of the IT Returns and Assessment Orders of the National Parties through the filing of RTI applications and has analyzed the income and expenditure incurred during the financial year 2012-13.

Total income of political parties during FY 2012-13

- The income of political parties during FY 2012-13 is calculated from their IT returns filed annually to the Income Tax Department.
- The total income of INC was Rs 425 crores while that of BJP was Rs 324 crores in FY 2012-13.
- The least annual income was declared by CPI (Rs 1 crore) followed by NCP (Rs 26 crores) and BSP (Rs 87 crores).
- The total income of regional political parties was Rs 5.31 crores. The declared income of SHS was Rs 4.26 crores, while RJD declared an income of Rs 1.04 crores during FY 2012-13.
- MNS has not submitted its IT return to the IT department for FY 2012-13.

Top sources of income of political parties between during FY 2012-13

- From the table below, it can be noted that there is neither standardization nor consistency in the parties' declaration of their sources of funds.
- Of the major sources of income, sale of coupons has been listed by most of the major political parties. Income for INC from the sale of coupons/publication amounted to Rs 312.24 crores (73.35% of total income) while NCP received Rs. 3.76 crores from the sale of coupons (14.16% of total income).
- Voluntary contributions and donations have been listed as the next major source of income by the National Parties. Bahujan Samaj Party declared that it did not receive any donations above Rs 20,000 during FY 2012-13, though the party's total income declared in its ITR was Rs 87.63 crores. 83.76% of BJP's income is declared to be from donations.
- Voluntary contributions also form the topmost source of income for Shiv Sena a total of Rs 2.02 crores (47.49% of its total income). Fee and subscription is the most major source of income for Rashtriya Janata Dal, which declared Rs 0.44 crores (or 42.54%) of its income from the same.




Chart: Top source of income for political parties of Maharashtra [FY 2012-13]





Top items of expenditure of Maharashtra Parties during FY 2012-13

- The maximum expenditure for INC has been towards administrative and general expenses (Rs 206.99 crores) followed by election expenditure (Rs 89.95 crores). The maximum expenditure of BJP has been towards advertisement & publicity (Rs 131.87 crores) followed by travelling (Rs 36.62 crores).
- Expense towards tours and travel (Rs 1.76 crores) is the top item of expenditure for BSP during FY 2012-13.
- While SHS has declared that it spent Rs 19.54 lakhs (11.27%) of its income on miscellaneous expenses, RJD declared that it spent the most major portion of its income on meetings and conferences a total of Rs 26.15 lakhs (or 24.91%) of its total income.

Analysis of Voluntary Contributions Received by Political Parties

Political parties rely heavily on donations for contesting elections and running their daily affairs. They receive huge sums of money in the form of donations and contributions from corporate, trusts and individuals. Section 29C of the Representation of People Act, 1951 dictates that political parties submit their contribution details received in excess of Rs 20,000 from any person or a company to the ECI annually.

Named contributions seem to be very small i.e. single contributions above Rs 20,000 seem to be very few in numbers for all the parties when compared with the total income of the party as declared in their IT Returns.

RJD has declared that it has not received any donations above 20,000 during FY 2012-13.

(If a donor has made multiple contributions during FY 2012-13, each contribution has been individually counted. Hence, if a donor has donated twice, the number of contributors would be counted as 2).

Top donors to political parties from Maharashtra during FY 2012-13

- Lodha Dwellers Pvt. Ltd. is the topmost donor to BJP from Maharashtra, donating a total of Rs 6.99 crores in FY 2012-13.
- Nirmal Lifestyle Ltd. is the topmost donor to the INC from Maharashtra, donating a total of Rs 5 lakhs to the party in FY 2012-13. NCP received Rs 4.51 lakhs from its top donor, Shri VS Gangadharan.
- SHS received Rs 11 lakhs from Shri Sai Corporation and MNS received Rs 10 lakhs from Lokhanowala Foundation.

Sector-wise donations to political parties from Maharashtra (FY 2012-13)

- INC received Rs 5 lakhs from corporate donations, and Rs 5.49 crores from individual donations.
- BJP received Rs 19.77 crores from the corporate and business sector, amounting to 95.85% of its total donations from donors based in Maharashtra.
- NCP and CPM received donations only from individual donors in Maharashtra.
- CPI did not receive any donations from Maharashtra.
- SHS and MNS received all their donations in FY 2012-13 from Maharashtra. While SHS received Rs 12.52 lakhs from the corporate sector (34.41%), MNS received Rs 18.86 lakhs from the same (81.79%).




Chart: Sector-wise donations received by parties from donors in Maharashtra [FY 2012-13]

SHS has 2 donors donating Rs 5.52 lakhs without PAN details, whereas MNS has 2 donors donating Rs 5.25 lakhs without PAN details.

These recommendations relate to a standardized and **comprehensive reporting framework of financial statements of political parties**. ADR feels that there is a dire need for these recommendations to be implemented at the earliest.
