

## Summary and Highlights

Jharkhand Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **199 candidates** who are contesting in the Jharkhand 2014 (Phase 1) elections.



### Criminal Background

- **Candidates with Criminal Cases:** Out of the **199** candidates, **55 (28%) candidates** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **37 (19%)** candidates have declared serious criminal cases including cases related to **murder, attempt to murder, communal disharmony, kidnapping, crimes against women** etc.
- **Candidates with cases related to murder:** 5 candidates have declared cases related to **murder**. **Tahir Ansari** of **BSP** from **Bhawanathpur** constituency, **Kushwaha Sashi Bhushan Mehta** an Independent candidate from **Panki** constituency, **Jalaluddin Rangsaj** an Independent candidate from **Garhwa** constituency, **Laxman Singh** an Independent candidate from **Bhawanathpur** constituency and **Vinod Sharma** an Independent candidate from **Daltonganj** constituency.
- **Candidates with cases related to Attempt to Murder:** **14** candidates have declared cases of attempt to murder. **2** candidates are fielded from **BSP**, **2** from **CPI(ML)(L)**, **1** from **JMM**, **1** from **JVM(P)**, **1** from **RJD**, **1** from **SP**, **1** from **AJSU**, **1** from **Navjawan Sangharsh Morcha** and **4** are **Independents**.
- **Candidates with cases related to Crimes against Women:** **2** candidates have declared cases related to crimes against women. **Tahir Ansari** of **BSP** from **Bhawanathpur** constituency has declared an offence of **Kidnapping**.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

abducting or inducing woman to compel her marriage, etc. (IPC Section-366) and Chamra Linda of JMM from Gumla constituency has declared an offence of **Word, gesture or act intended to insult the modesty of a woman** (IPC Section-509).

- **Candidates with cases related to causing Communal Disharmony:** Kushwaha Shivpujan Mehta of BSP from Hussainabad constituency has declared a case related to **Injuring or defiling place of worship with intent to insult the religion of any class** (IPC Section-295).
- **Candidates with cases related to Robbery and Dacoity:** 2 candidates have declared cases related to **robbery and dacoity**. Tahir Ansari of BSP from Bhawanathpur constituency has declared a charge related to **dacoity** (IPC Section-395) and Mithilesh Kumar Thakur of JMM from Garhwa constituency has declared a charge related to **Making preparation to commit dacoity** (IPC Section-399) and **Assembling for purpose of committing dacoity** (IPC Section - 402).
- **Candidates with cases related to Kidnapping:** 2 candidates have declared cases related to **Kidnapping**. Tahir Ansari of BSP from Bhawanathpur constituency has declared a case related to **kidnapping** (IPC Section-363), **Kidnapping or abducting in order to murder** (IPC Section-364) and **Kidnapping, abducting or inducing woman to compel her marriage, etc.** (IPC Section-366). Mohan Ganjhu of JMM from Latehar constituency has declared a case related to **Kidnapping or abducting with intent secretly and wrongfully to confine person** (IPC Section-365).
- **Party wise Candidates with Criminal Cases:** 6 (50%) out of 12 candidates from **BJP**, 4 (67%) out of 6 candidates from **RJD**, 6 (50%) out of 12 candidates from **JMM**, 6 (55%) out of 11 candidates fielded by **JVM (P)**, 3(43%) out of 7 candidates from **INC** and 14 (19%) out of 72 **Independent** candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** 3 (25%) out of 12 candidates from **BJP**, 2 (33%) out of 6 candidates from **RJD**, 4 (33%) out of 12 candidates from **JMM**, 5 (45%) out of 11 candidates fielded by **JVM (P)**, 3(43%) out of 7 candidates from **INC** and 9 (13%) out of 72 **Independent** candidates have declared serious criminal cases against themselves in their affidavits.
- **Red Alert Constituencies\*:** 10 constituencies have at least 3 candidates with declared criminal cases.

\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.

### Financial Background

- **Cronepati Candidates:** Out of the 199 candidates, 46 (23%) are cronepati.
- **Party-wise Cronepati Candidates:** 6 (55%) out of 11 candidates from **JVM (P)**, 5 (42%) out of 12 candidates from **BJP**, 4 (57%) out of 7 candidates from **INC**, 3 (25%) out of 12 candidates from **JMM**, 5(83%) out of 6 candidates of **RJD** and 14 (19%) out of 72 Independent candidates have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the first phase of Jharkhand elections is **Rs.1.02 crores**.

- **Party-wise Average Assets:** Among major parties, the average assets per candidate for **12 BJP** candidates is **Rs 1.97 crores**, **12 JMM** candidates have average assets of **Rs.99.33 lakhs**, **12 BSP** candidates have average assets worth of **Rs.72.14 lakhs**, **11 JVM (P)** candidates have average assets worth **Rs. 3.47 crores**, 7 INC candidates have average assets worth of Rs. 1.68 crores and **72 Independent** candidates have average assets of **Rs. 84.98 lakhs**.

### Other Background Details

- **Education Details of Candidates:** 122 (61%) candidates have declared that they have an education qualification of **12<sup>th</sup> pass or below** while **76 (38%)** candidates have declared having an educational qualification of **graduate or above**.
- **Age Details of Candidates:** 153 (77%) candidates have declared their age to be between **25 to 50 years** while **44 (22%)** candidates have declared their age to be between **51 to 80 years**. Two candidates have not given their age details.
- **Gender Details of Candidates:** 18 (9%) female candidates are contesting in the **Jharkhand 2014 Phase 1 elections**.
- **Profession Details of Candidates:** 88 candidates have declared **agriculture** as their main profession. 26 candidates have declared their main profession to be **business**. 32 candidates have declared their profession to be **Social Service**. 8 candidates have declared that they have **retired**. 12 candidates have declared their main occupation to be a **politics**.

## Analysis based on declared criminal cases

Out of the **199** candidates, **55 (28%) candidates** have declared criminal cases against themselves. **37 (19%)** candidates have declared serious criminal cases including cases related to **murder, attempt to murder, communal disharmony, kidnapping, crimes against women** etc.

### Party-wise break up of candidates with declared criminal cases

**6 (50%)** out of 12 candidates from **BJP**, **4 (67%)** out of 6 candidates from **BSP**, **6 (50%)** out of 12 candidates from **JMM**, **6 (55%)** out of **11** candidates fielded by **JVM (P)**, **3(43%)** out of 7 candidates from **INC** and **14 (19%)** out of 72 **Independent** candidates have declared criminal cases against themselves in their affidavits.




