Executive Summary


This report, prepared by Association for Democratic Reforms and National Election Watch, focuses on the income and expenditure of national and regional political parties belonging to Assam. The six national parties include Indian National Congress (INC), Bhartiya Janata Party (BJP), Bahujan Samaj Party (BSP), Nationalist Congress Party (NCP), Communist Party of India (CPI) and Communist Party of India (Marxist) (CPM).

The regional parties considered for this report include Asom Gana Parishad (AGP), All India United Democratic Front (AIUDF) and Bodoland People's Front (BPF).

The **executive summary** below lists the key observations that were drawn from the report:

I. Total income of political parties from all over India:

- The total income of political parties is calculated from their IT returns filed every year to the Income Tax Department.
- Among national parties, **INC** has the highest total income of Rs. 2365.02 crores between FY 2004-05 and 2011-12, followed by **BJP** with Rs. 1304.22 crores. **BSP** has a total income of Rs. 497.44 crores, **NCP** has a declared total income of Rs. 201.63 crores, **CPI** has Rs. 10.01 crores and **CPM** has a total income of Rs. 521.10 crores during FY 2004-05 and 2011-12.




Graph: Total income of national political parties [FY 2004-05 to 2011-12]

• Among regional parties, **AIUDF** has the highest total income of Rs. 329.91 lakhs, followed by BPF with Rs. 230.61 lakhs and AGP with 103.31 lakhs between FY 2004-05 and 2011-12.

II. Share of donations from total income of political parties (as per ITR):

Among the national parties, BJP received a total of Rs. 1095.98 crores as donations or voluntary contributions, which forms 84.03% of its income. INC declared Rs. 306.95 crores (12.98% of its income) as donations between FY 2004-05 and 2011-12.

III. Top three sources of income:


- There is no standard format in which political parties list their sources of income.
- **INC** which has the highest total income among all political parties (Rs. 2365.02 crores), lists 77.34% of its income (Rs. 1829.02 crores) from sale of coupons. **BJP** with a total income of Rs. 1304.22 crores, declares its topmost source of income to be voluntary contributions (Rs. 1095.98 crores, 84.03% of its total income).
- Most political parties list donations, voluntary contributions and members' contributions towards party fund as major sources of income.

IV. Top three items of expenditure:

- Political parties have varied expenses, including election expenses, publicity and advertisement.
- AGP spent Rs. 24.24 lakhs (23.72% of its income) on traveling expenses between FY 2004-05 and 2011-12.

V. Number of donors contributing above Rs. 20,000 to political parties from Assam (FY 2004-05 to FY 2011-12):

- Of the national parties, **INC** has the maximum number of donors from Assam contributing above Rs. 20,000. Between FY 2004-05 and 2011-12, **5 donors** belonging to Assam contributed **Rs. 15, 93,200** to the INC, while **4 donors** contributed **Rs. 96,000** to **BJP**.
- AIUDF received donations from 55 donors contributing a total of Rs. 12.57 lakhs, followed by BPF with 7 donors contributing a total of Rs. 30.50 lakhs and AGP with one donor contributing a total of Rs. 10 lakhs.





VI. Foreign funds to political parties:

- The **Foreign Contributions (Regulation) Act (FCRA), 1976**, prohibits political parties from accepting contributions from foreign companies or companies in India controlled by foreign companies.
- INC and BJP are the only two political parties which have received foreign funding, i.e. funding from foreign sources. INC received a total of Rs. 9.83 crores and BJP received a total of Rs. 19.42 crores between FY 2003-04 and 2011-12.
- Foreign donors include the Vedanta group (Sesa Goa, The Madras Aluminum Co. Ltd, Sterlite Industries), Public and Political Awareness Trust, Hyatt Regency (an Americal international company) and Dow Chemicals (headquartered in Michigan, USA). Vedanta group is the top donor to both the parties with its subsidiary, Sterlite Industries donating Rs 6 crores followed by Sesa Goa Ltd donating Rs 2.78 crores to INC, while the Public and Political Awareness Trust donated Rs 14.50 crores to BJP followed by Vedanta The Madras Aluminium Co. Ltd donating Rs 3.50 crores between FY 2003-04 and 2011-12.

Recommendations by ADR

- The Supreme Court gave a judgment on September 13, 2013 declaring that no part of a candidate's affidavit should be left blank. Similarly, no part of the Form 24A submitted by political parties providing details of donations above Rs 20,000 should be blank.
- Full details of all donors should be made available for public scrutiny under the RTI. Some countries where this is done include Bhutan, Nepal, Germany, France, Italy, Brazil, Bulgaria, the US and Japan. In none of these countries is it possible for 75% of the source of funds to be unknown, but at present it is so in India.
- Details of donors who make **donations to the Electoral Trusts should be available in the public domain** for increasing transparency in funding of political parties
- According to the Finance Bill introduced in 2009, 95% of the income of Electoral Trusts should be donated to political parties. Details of donations made by the electoral trusts to political parties has to be verified against the Income Tax Returns submitted by the electoral trusts so as to determine whether 95% of the Trusts' income has been donated
- Political parties are not permitted to accept contributions from foreign companies or companies controlled in India
 by foreign companies but a total of Rs 29.26 crores was accepted by INC and BJP together between FY 2003-04
 and 2011-12. ADR has filed a petition in the Delhi High Court to take action against the two largest national
 parties, INC and BJP.
- Any party which does not submit its donation statement to the ECI on or before 31st Oct should be heavily
 penalized and its income should not be tax-exempted. Strict action must also be taken against parties which do
 not file their IT returns.
- The National and other political parties must therefore provide all information under the Right to Information Act.

 This will only strengthen political parties, elections and democracy.





Major Political Parties of Assam: An All-India Report Income, Expenditure and Donations between FY 2004-05 and 2011-12

Political parties represent citizens of the country at various levels of the government, voice people's demands and needs in the administrative sphere, and therefore serve as the link between citizens and the government.

Political parties rely heavily on donations for fighting elections and running their daily affairs. They receive huge sums of money in the form of donations and contributions from corporate, trusts and individuals. Section 29C of the Representation of People Act, 1951 says that political parties are required to submit contribution details received in excess of Rs 20,000 from any person or a company. Named contributions seem to be very small i.e. single contributions above Rs 20,000 seem to be very few in numbers for all the parties.

In addition to this, the coupon system has been adopted by political parties for collecting funds by issuing of coupons in lieu of receipts to donors for cash contributions. Moreover, these are cash donations and it becomes all the more difficult to establish the identity of the donor. This implies that a lot of cash donations received remain unaccounted for in the books of accounts as only those amounts would be recorded for which a receipt has been issued.

Thus, it becomes all the more important to have a strict regulatory mechanism wherein political parties have to report the correct quantum and the source of donations received. Association for Democratic Reforms (ADR) had obtained copies of the IT Returns and Assessment Orders of various political parties through the filing of RTI applications.

Total income of major political parties of Assam [FY 2004-05 and 2011-12]

The parties analyzed include all of the six national political parties and the regional political parties of Assam. The following observations were made:

- Among national parties, INC has the highest total income of Rs. 2365.02 crores between FY 2004-05 and 2011-12, followed by BJP with Rs. 1304.22 crores. BSP has a total income of Rs. 497.44 crores, NCP has a declared total income of Rs. 201.63 crores, CPI has Rs. 10.01 crores and CPM has a total income of Rs. 521.10 crores during FY 2004-05 and 2011-12.
- Among regional parties, **AIUDF** has the highest total income of Rs. 329.91 lakhs, followed by BPF with Rs. 230.61 lakhs and AGP with 103.31 lakhs between FY 2004-05 and 2011-12.
- The income of national political parties shows an almost steady growth between FY 2004-05 and FY 2011-12. INC's income doubled from Rs. 220.82 crores to 496.87 crores, BJP's income went from Rs. 123.79 crores to Rs. 220.02 crores and BSP's income increased more than double from Rs. 70.92 crores to Rs. 182.02 crores between FY 2004-05 and FY 2011-12.
- Of the three political parties of Assam, Asom Gana Parishad (AGP) and Bodoland People's Front (BPF) have shown a **decrease in their income** between FY 2010-11 and FY 2011-12. AGP's income has decreased from Rs. 50.24 lakhs in FY 2010-11 to Rs. 20.54 lakhs in FY 2011-12, BDF's income has decreased from Rs. 117.5 lakhs to Rs. 28.59 lakhs between FY 2010-11 and 2011-12.
- RTIs have been filed by ADR to obtain the IT returns of some of the regional parties, responses for which are awaited, as have been mentioned in the table below.

Share of donations from total income of political parties between FY 2004-05 and 2011-12

Political parties declare their income from various sources such as sale of coupons, donations, voluntary contributions etc in their IT returns. Tabulated below is the share of donations from total income of political parties between FY 2004-05 and 2011-12. Some notable observations include:

- Among the national parties, BJP has the highest share of donations of its total income. Between 2004-05 and 2011-12, it received a total of Rs. 1095.98 crores as donations which forms 84.03% of its income, as declared in its IT returns.
- INC received only Rs. 306.95 crores as donations between FY 2004-05 and 2011-12, a mere 12.98% of its income. The party collected Rs. 1829.02 crores of its income by sale of coupons between FY 2004-05 and 2011-12, which forms 77.34% of its income.
- Income of **BSP** from voluntary contributions is Rs. 307.31 crores, which is 68.05% of its income. **BSP** is the only national party which claims that all the voluntary contributions it receives are below Rs. 20,000.
- BPF received 82.85% of its total income of Rs. 230.61 lakhs from voluntary donations (Rs 191.06 lakhs), while 76.80% of AGP's total income of Rs. 103.31 lakhs came from donations (Rs 79.34 lahs) between FY 2004-05 and FY 2011-12.

Top three sources of income of major political parties of Assam as per ITR [FY 2004-05 and 2011-12]

Political parties have a wide network of offices, and a diverse membership throughout the region that they operate in. All political parties cite various sources of income, of which the top three for every party have been tabulated below. Notable observations include:

• It is noticeable that there is **no standardization** for declaring sources of income by political parties, and thus no consistency in the method of declaration of funds received by political parties.

- Sale of coupons and voluntary contributions are two primary sources of income for political parties. The foremost source of income for AGP (Rs. 79.34 lakhs, 76.8% of their total income) is donation and subscription.
- **BPF** has declared 'donation received' as its primary source of income (Rs. 191.06 lakhs, 82.85% of its total income of Rs 230.61 lakhs), while 'Contribution towards Party Fund' is the top source of income for **AIUDF** (Rs. 252.33 lakhs, 76.48% of its total income of Rs 329.91 lakhs)

Top three items of expenditure of political parties of Assam as declared in their IT returns [FY 2004-05 and 2011-12]

Political parties have varied expenses, as declared in their IT returns. The most notable points from this analysis are as follows:

- INC, BJP, NCP, CPI and BPF spent the largest part of their income on election expenses, publicity and advertisement between FY 2004-05 and 2011-12. INC spent Rs. 1168.71 crores on election expenses, BJP spent Rs. 428.53 crores on advertising and publicity, and NCP spent a total of 139.77 crores on election expenses and publicity between FY 2004-05 and 2011-12.
- Among the regional parties, **AGP** spent Rs. 24.24 lakhs on Travelling Expenses and **BPF** spent Rs. 89 lakhs on election expenses between FY 2004-05 and 2011-12.
- AIDUF is the only political party which has spent about 25% of its income (Rs. 51.85 lakhs) on helicopter hiring charges.

Tabulated below are the annual donations above Rs. 20,000 received by national and regional parties from donors belonging to Assam, between FY 2004-05 and 2011-12.

- Among the national parties, **INC** received the highest amount of donations from donors of Assam. Between FY 2004-05 and 2011-12, INC received a total of Rs. 15,93,200 from 5 donors from Assam
- AGP received its maximum amount of contributions of Rs. 10 lakhs in FY 2010-11 from 1 donor
- AlUDF received Rs. 5.6 lakhs in FY 2011-12 from a total of 16 donors




