

Summary and Highlights

Jammu and Kashmir Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **175 candidates from 18 constituencies** who are contesting in the second phase of Jammu and Kashmir 2014 Elections.



Criminal Background

- Candidates with Criminal Cases:** Out of the 175 candidates, **9 (5%) candidates** have declared criminal cases against themselves.
- Candidates with Serious Criminal Cases:** **6 (3%)** candidates have declared serious criminal cases including cases related to **kidnapping, forgery** etc.
- Party wise Candidates with Criminal Cases:** **1** out of 18 candidates from **INC**, **1** out of 18 candidates from **JKNC**, **1** out of 17 candidates from **BJP**, **2** out of 16 candidates from **JKNPP** and **3** out of 52 **Independent** candidates have declared criminal cases against themselves in their affidavits.
- Party wise Candidates with Serious Criminal Cases:** **1** out of 18 candidates from **INC**, **1** out of 18 candidates from **JKNC**, **1** out of 17 candidates from **BJP**, **2** out of 16 candidates from **JKNPP** and **1** out of 52 **Independent** candidates have declared serious criminal cases against themselves in their affidavits.
- Candidate with cases related to Kidnapping:** **Balwant Singh Mankotia** of **JKNPP** from **Udhampur** constituency has declared a case related to **kidnapping (IPC Section-363)**.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Candidates:** Out of the **175** candidates, **55 (31%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **8 (44%)** out of 18 candidates in **JKNC**, **9 (56%)** out of 16 candidates in **JKPDP**, **7 (41%)** out of 17 candidates in **BJP**, **9 (50%)** out of 18 candidates in **INC** and **12 (23%)** out of 52 Independent candidates have declared assets worth more than Rs. 1 crore.

- **Average Assets:** The average assets per candidate contesting in the second phase of Jammu and Kashmir elections is **Rs.1.41 crores**.
- **Party-wise Average Assets:** Among major parties, the average assets per candidate for **18 INC** candidates is **Rs 1.78 crores**, **16 JKPDP** candidates have average assets of **Rs.2.01 crores**, **18 JKNC** candidates have average assets worth of **Rs.1.74 crores** and **17 BJP** candidates have average assets of **Rs. 1.54 crores**.

- **Candidates who have not declared Income Tax Details*:** 109 (62%) candidates out of 175 have not declared income tax details.* Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details*:** 20 candidates with assets worth more than Rs. 1 crore, have not declared Income Tax details. * Some candidates may be exempted from filing Income Tax Returns

Other Background Details

- **Education Details of Candidates:** 9 candidates have declared that they are illiterate. 88(50%) candidates have declared that have an education qualification of 12th pass or below while 71 (41%) candidates have declared having an educational qualification of graduate or above.
- **Age Details of Candidates:** 103 (59%) candidates have declared their age to be between 25 to 50 years while 68 (39%) candidates have declared their age to be between 51 to 80 years
- **Gender Details of Candidates:** Only 8 (5%) female candidates are contesting in the second phase of the Jammu and Kashmir Assembly elections.
- **Profession Details of Candidates:** 19 candidates have declared agriculture as their main profession. 52 candidates have declared their main profession to be business. 12 candidates have declared that they have retired. 35 candidates have declared their main occupation to be a politics and 19 candidates have declared that they are lawyers.


