संक्षेप आणि ठळक मुद्दे

असोसिएशन फॉर डेमॉक्रेटिक रिफॉर्म्स (एडीआर) आणि महाराष्ट्र इलेक्शन वॉच यांनी नाशिक, पुणे, सोलापूर, उल्हासनगर, अहमदनगर, जळगाव आणि बृहन्मुंबई येथे 6 एप्रिल 2018 रोजी महानगरपालिका पोट निवडणुकीत सहभाग घेणारे 33 उमेदवारांपैकी 31 उमेदवारांच्या शपथपत्रांचे विश्लेषण केले. गेही मायादेवी विजयकुमार या जळगाव महानगरपालिकेतील प्रभाग क्र. 26 आणि महेश दत्तात्रेय सोले हे अहमदनगर महानगरपालिकेतील प्रभाग क्र. 32 हे दोन्ही उमेदवार भारतीय जनता पक्षातील असून यांच्या शपथपत्राचे विश्लेषण करता आले नाही कारण हा अहवाल बनवेपर्यंत त्यांचे शपथपत्र संकेतस्थळावर टाकली गेली नव्हती.

गुन्हेगारी पार्श्वभूमी

- **गुन्हेगारी प्रकरणं घोषित करणारे उमेदवार:** विश्लेषित केलेल्या 31 पैकी 9 (29%) उमेदवारांनी त्यांच्या विरोधात गुन्हेगारी प्रकरण दाखल असल्याचे घोषित केले आहे.
- **गंभीर गुन्हेगारी प्रकरण घोषित करणारे उमेदवार:** विश्लेषित केलेल्या 31 पैकी 6 (19%) उमेदवारांनी त्यांच्या विरोधात खूनाचा प्रयत्न, खंडणी, धमकावणे, दरोडा आणि फसवणूक, इत्यादींसारखे गंभीर स्वरूपाचे गुन्हेगारी प्रकरण दाखल असल्याचे घोषित केले आहे.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

(33%) उमेदवारांनी त्यांच्या विरोधात गंभीर गुन्हेगारी प्रकरणं दाखल असल्याचे त्यांच्या शपथपत्रात घोषित केले आहे.

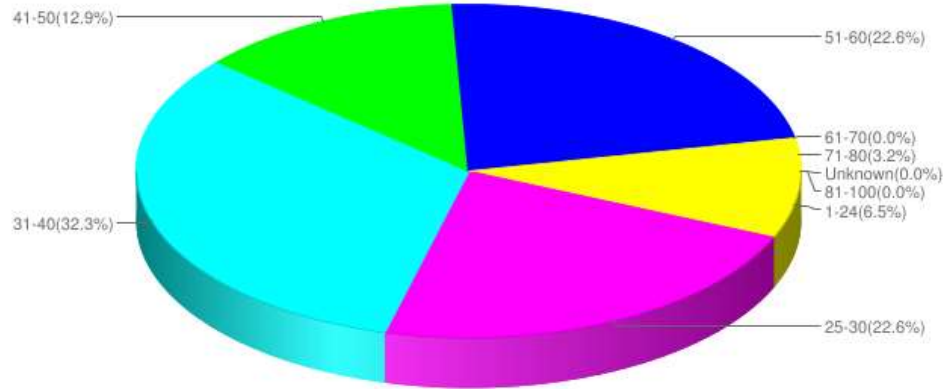

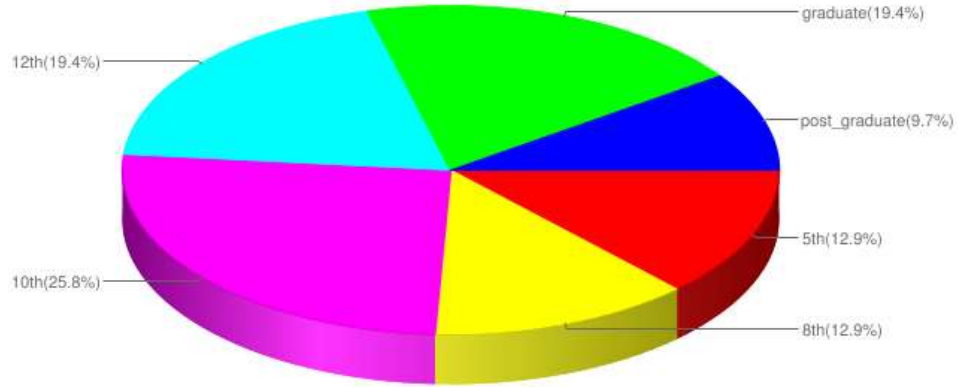

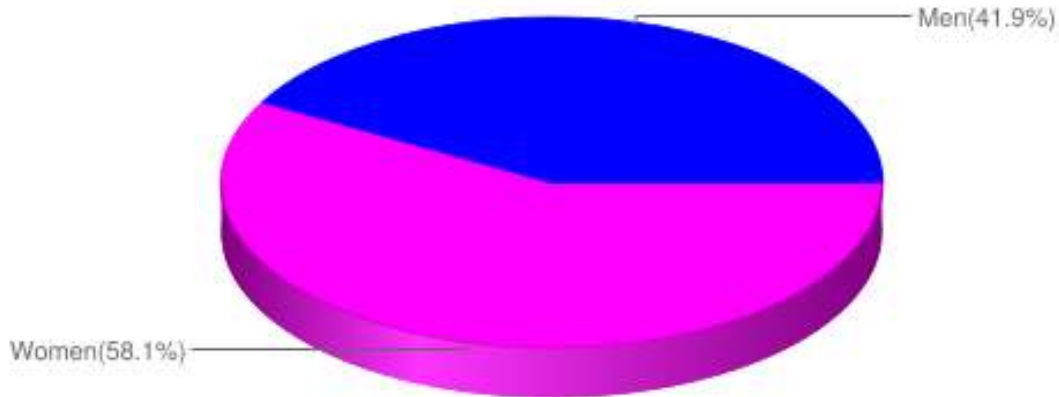
