

# **Background Details of Mizoram's Ministers, 2018**

#### **Criminal Background**

- *Ministers with Criminal Cases:* 2 (17%) ministers including the Chief Minister analysed have declared criminal cases against themselves.
- *Ministers with Serious Criminal Cases:* Only Zoramthanga (Chief Minister) has declared serious criminal case against himself.





### **Financial Background**

- *Crorepati Ministers:* Out of the **12** ministers analysed, **11 (92%)** are crorepatis.
- Average Assets: The average assets of 12 ministers analysed is Rs 6.93 crores.
- *Ministers with Highest Assets:* The minister with the highest declared total assets is **Robert Romawia Royte** from Aizawl East II constituency with assets worth **Rs.44.74 crores.** The top 3 ministers with highest declared assets are:

\* As per section 10 (26) of IT Act 1961, a memberof ST residing in specific area of in Arunachal Pradesh, Manipur, Mizoram, Nagaland, Tripura or Ladakh in Jammu and Kashmir is exempt from paying IT.

#### Other Background details (Education, Gender, Age)

- Ministers' Education: 3 (25%) ministers have declared their educational qualification to be between 10<sup>th</sup> pass and 12<sup>th</sup> pass while 9 (75%) ministers have declared having an educational qualification of graduate or above.
- <u>Ministers' Age:</u> 3 (25%) ministers have declared their age to be between 31 and 50 years while 7 (58%) ministers have declared their age to be between 51 and 70 years. There are 2(17%) ministers who have declared their age to be between 71 to 80 years.
- **Woman Minister:** Out of 12 ministers, there is not even a single woman minister in the Mizoram 2018 Assembly Elections.
