रिपोर्ट के मुख्य अंश

नेशनल इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने **4896** में से **4822** सांसदों और विधायकों के शपथपत्रों का विश्लेषण किया। जिसमें पिछले 5 वर्षों (2014–2019) में भारत के सभी राज्यों और केंद्र शासित प्रदेशों के **776** में से **759** सांसदों और **4120** में से **4063** विधायकों के शपथपत्र शामिल हैं। इस रिपोर्ट में 5 साल की अवधि के दौरान इस्तीफे के कारण, मृत्यु या किसी और कारण से हुए उप-चुनावों का विश्लेषण भी शामिल है।

इस रिपोर्ट में एडीआर ने महिलाओं के ऊपर अत्याचार से सम्बन्धित आईपीसी की निम्नलिखित धाराओं का वर्णन किया है—

- 2009 से 2019 तक, लोक सभा चुनाव में महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले उम्मीदवारों की संख्या में 231 प्रतिषत की वृद्धि हुई है।
- 2009 से 2019 तक, लोक सभा चुनाव में महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले सांसदों की संख्या में 850 प्रतिषत की वृद्धि हुई है।
- 756 सांसदों और 4063 विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं, 76 सांसदों और विधायकों ने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं।
- इन 76 सांसदों और विधायकों ने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं, जिसमें 58 विधायक और 18 सांसद हैं।
- पिछले 5 वर्षों में, महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले कुल 572 उम्मीदवारों ने लोकसभा/राज्यसभा और विधानसभा चुनाव लड़ा है। इनमें से किसी भी उम्मीदवार पर आरोप दोषसिद्ध नहीं हुआ है।
- मान्यता प्राप्त राजनीतिक दलों ने ऐसे 410 उम्मीदवारों को टिकट दिए जिन पर महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित थे। इन उम्मीदवारों में से 89 उम्मीदवारों को लोकसभा/राज्यसभा चुनाव के लिए और 321 उम्मीदवारों को राज्य विधानसभा चुनाव के लिए दलों द्वारा टिकट दिए गए।
- पिछले 5 वर्षों में महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले 162 निर्दलीय उम्मीदवारों ने लोकसभा/राज्यसभा और राज्य विधानसभा के लिए चुनाव लड़ा था।
- पिछले 5 वर्षों में महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले 35 निर्दलीय उम्मीदवारों ने लोकसभा/राज्यसभा चुनाव और 127 निर्दलीय उम्मीदवारों ने राज्य विधानसभा चुनाव लड़ा है।
- यह स्पष्ट रूप से दर्शाता है कि राजनीतिक दल महिलाओं के ऊपर अत्याचार के मुद्दे पर चिंतित नहीं हैं। जाहिर है, कि महिलाओं द्वारा नेतृत्व वाले राजनीतिक दल जैसे **INC**, **BSP**, और **AITC** भी महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले उम्मीदवारों को टिकट दे रहे हैं।
- राज्यों में पश्चिम बंगाल के सबसे अधिकतम 16 सांसद/विधायक, इस के बाद ओडिशा और महाराष्ट्र प्रत्येक से 12 ऐसे सांसद/विधायक हैं, जिन्होंने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं।

- पिछले 5 वर्षों में राज्यों में महाराष्ट्र से सबसे अधिकतम 84 उम्मीदवार, इस के बाद बिहार से 75 और पश्चिम बंगाल से 69 उम्मीदवारों (निर्दलीय उम्मीदवारों सहित) को राजनीतिक दलों द्वारा टिकट दिए गए, जबकि उन्होंने अपने षपथपत्रों में महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किए हैं।
- मान्यता प्राप्त दलों में **BJP** के सबसे अधिकतम 21 सांसदों/विधायकों, इसी के बाद **INC** के 16 और **YSRCP** के 7 सांसदों/विधायकों ने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामलों घोषित किए हैं।
- पिछले 5 वर्षों में मुख्य दलों में, महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले 66 उम्मीदवारों को **BJP** द्वारा, 46 उम्मीदवारों को **INC** द्वारा और 40 उम्मीदवारों को **BSP** द्वारा टिकट दिए गए जो पिछले 5 वर्षों से लोकसभा/राज्यसभा और राज्य विधानसभा चुनाव लड़ रहे थे।
- 9 सांसदों/विधायकों ने बलात्कार से सम्बन्धित मामले घोषित किए हैं, इन में से 3 सांसद और 6 विधायक हैं।
- पिछले 5 वर्षों में, मान्यता प्राप्त दलों ने बलात्कार से सम्बन्धित मामले घोषित करने वाले 41 उम्मीदवारों को टिकट दिए हैं।
- पिछले 5 वर्षों में, लोकसभा/राज्यसभा और राज्य विधानसभा के चुनाव लड़ने वाले 14 निर्दलीय उम्मीदवार ऐसे हैं, जिन्होंने अपने ऊपर बलात्कार से सम्बन्धित मामले घोषित किए हैं।

सिफारिशें


सभी प्रमुख राजनीतिक दल महिलाओं के खिलाफ अत्याचार विशेष रूप से बलात्कार सम्बन्धित मामलों वाले उम्मीदवारों को टिकट देते हैं, और इसलिए नागरिकों के रूप में महिलाओं की सुरक्षा और गरिमा में बाधा डालते हैं। ये गंभीर मामले हैं जिन पर अदालतों द्वारा या तो आरोप तय किये गए हैं या फिर संज्ञान लिया गया है। इन आंकड़ों से हमारी राजनीतिक प्रणाली में गंभीर खराबी और आघात का पता चलता है, जहां महिलाओं के ऊपर अत्याचार से सम्बन्धित मामलों वाले धनबली और बाहुबली सांसद/विधायक प्रणाली को वष में करने में सक्षम हैं, अपने प्रभाव का उपयोग करके पुलिस जांच में हस्तक्षेप करते हैं, अपने लाभ के लिए न्यायिक देरी का उपयोग करते हैं और कुछ मामलों में लगातार पीड़ितों और उनके परिवार वालों को परेशान करते हैं। एडीआर और नेशनल इलेक्शन वॉच इसकी दृढ़ता से अनुषंसा करता है।

- आपराधिक पृष्ठभूमि वाले उम्मीदवारों के चुनाव लड़ने पर रोक लगनी चाहिए।
- राजनीतिक दलों को उन मानदंडों का खुलासा करना चाहिए जिन पर उम्मीदवारों को टिकट दिए जाते हैं।

- सांसदों और विधायकों के खिलाफ मामलों को फास्ट ट्रैक किया जाना चाहिए और समयबद्ध तरीके से फैसला किया जाना चाहिए।
- मतदाताओं को महिलाओं के ऊपर अत्याचार और अन्य जघन्य अपराधों से सम्बन्धित मामले घोषित करने वाले उम्मीदवारों का चुनाव करने से बचना चाहिए।

लोक सभा चुनाव (2009–2019) और महिलाओं के ऊपर अत्याचार का विवरण

- 2009 से 2019 तक, लोक सभा चुनाव में महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले उम्मीदवारों की संख्या में 231 प्रतिषत की वृद्धि हुई है।
- 2009 से 2019 तक, लोक सभा चुनाव में महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले सांसदों की संख्या में 850 प्रतिषत की वृद्धि हुई है।



महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले सांसदों/विधायकों का विश्लेषण

- मान्यता प्राप्त राजनीतिक दलों ने ऐसे 410 उम्मीदवारों को टिकट दिए जिन पर महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित थे। इन उम्मीदवारों में से 89 उम्मीदवारों को लोकसभा/राज्यसभा चुनाव के लिए दलों द्वारा टिकट दिए गए थे। विभिन्न मान्यता प्राप्त राजनीतिक दलों ने राज्य विधानसभा चुनाव के लिए 321 उम्मीदवारों को टिकट दिए जिन पर महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित हैं।
- पिछले 5 वर्षों में महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले 162 निर्दलीय उम्मीदवारों ने लोकसभा/राज्यसभा और राज्य विधानसभा के लिए चुनाव लड़ा है।
- 76 सांसद/विधायक ऐसे हैं, जिन्होंने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं। जिसमें स्त्री की लज्जा भंग करने के आशय से उस पर हमला या आपराधिक बल का प्रयोग (आईपीसी-354), विवाह आदि के करने को विवश करने के लिए किसी स्त्री को व्यपहत करना, अपहृत करना या उत्प्रेरित करना (आईपीसी-366), बलात्कार (आईपीसी-376), किसी स्त्री के पति या पति के नातेदार द्वारा उसके प्रति क्रूरता करना (आईपीसी-498A), वेश्यावृत्ति के प्रयोजन के लिए अप्राप्तवय का खरीदना आदि (आईपीसी-373) और किसी स्त्री की लज्जा का अनादर करने से सम्बन्धित (आईपीसी-509)।
- इन 76 सांसदों/विधायकों में से 58 विधायक और 18 सांसद हैं।


MPs/MLAs with declared cases of Crimes against women

आलेख: महिलाओं के ऊपर अत्याचार से सम्बन्धित मामलों वाले सांसद/विधायक-दलवार






