- <u>Ministers with Serious Criminal Cases:</u> 3 (43%) ministers have declared serious criminal cases against themselves.



- Average Assets: The average assets of 7 ministers analysed is Rs 8.96 crores.
- <u>Minister with Highest Assets:</u> The minister with the highest declared total assets is Kailash Gahlot from Najafgarh constituency with assets worth Rs. 46.07 crores.
- <u>Minister with Lowest Assets:</u> The minister with the lowest declared total assets is Gopal Rai from Babarpur constituency with assets worth Rs. 90.01 lakhs.



Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- Offences that are assault, murder, kidnap, rape related
- Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.





• <u>Liabilities:</u> A total of four ministers have declared liabilities out of which the minister with the highest liabilities is Kailash Gahlot of Najafgarh constituency with Rs. 6.63 crores of liabilities.

Other Background details (Education, Gender, Age)

- <u>Ministers' Education:</u> 6 out of 7 ministers have education qualification of graduate or above and one minister, Manish Sisodia has declared that he has a diploma in Journalism.
- <u>Ministers' Age:</u> A total of **4(57%)** ministers have declared their age to be between **31-50 years** while **3(43%)** ministers have declared their age to be between **51-60** years.
- Women Ministers: There are no women among ministers in the Delhi Assembly, 2020.
