Analysis of Donations Received above Rs 20,000 by National Political Parties - FY 2018-19

This report, prepared by **Association for Democratic Reforms** (ADR), focuses on donations received by the National Political Parties, above Rs 20,000, during the Financial Year 2018-19, as submitted by the parties to the Election Commission of India (ECI). The National Parties include Bharatiya Janata Party (**BJP**), Indian National Congress (**INC**), Bahujan Samaj Party (**BSP**), Nationalist Congress Party (**NCP**), Communist Party of India (**CPI**), Communist Party of India (**Marxist**) (**CPM**) and All India Trinamool Congress (**AITC**).

Executive Summary

The **executive summary** below lists the key observations drawn from the report:


1. Status of Submission of Contributions reports by National Parties, FY 2018-19

- a) The due date for submission of Contributions reports for the parties was 30 September 2019.
- b) **BSP**, **INC**, **NCP** and **AITC** submitted their Contributions reports on time while **CPI** submitted after **3 days**, **CPM** submitted after **21 days** and **BJP** submitted after a delay of **31 days**.

2. Donations above Rs 20,000 to National Parties from all over India (FY 2018-19)

- a) The total donations (above Rs 20,000) declared by the National Parties was Rs. 951.66 cr, from 5520 donations.
- b) A total of Rs 742.15 cr was declared by BJP from 4483 donations while INC declared receiving Rs 148.58 cr from 605 donations. The donations declared by BJP is more than three times the aggregate declared by INC, NCP, CPI, CPM and AITC for the same period.
- c) **BSP** declared that the party **did not receive any donations** above Rs 20,000 during FY 2018-19, as it has been declaring for the past 13 years.






3. Comparison of donations received by National Parties during FY 2017-18 and FY 2018-19

- a) The total donations of the National Parties during FY 2018-19 increased by **Rs 481.77 cr**, an increase of almost **103%**, from the previous financial year 2017-18.
- b) Donations to **BJP** increased from **Rs 437.04** cr during FY 2017-18 to **Rs 742.15** cr during FY 2018-19 (70% increase). Party's donations decreased by 18% during FY 2017-18 in comparison to FY 2016-17.
- c) INC donations increased from Rs 26.658 cr during FY 2017-18 to Rs 148.58 cr during FY 2018-19 (457% increase). While INC's donations decreased by 36% between FY 2016-17 and FY 2017-18.



4. State-wise donations to National Parties

- a) **Segregation of donations according to State** was made by **ADR** based on the **address** provided by the parties in their donations report to the ECI.
- b) A total of **Rs 548.227 cr** was donated to the National Parties from **Maharashtra**, followed by **Rs 141.42 cr** from **Delhi** and **Rs 55.31 cr** from **Gujarat**.
- c) A total of **Rs 65.84 cr**, (6.92% of total donations received by the National parties, FY 2018-19), could not be attributed to any State/ Union Territory due to **incomplete information** provided by the parties.









5. <u>Donors from corporates/ business sectors Vs. individual donors</u>

- a) **1782 donations** to the National Parties were made by **corporate/business sectors** amounting to **Rs 881.26 cr** (92.60% of total donations) while **3501 individual** donors donated **Rs 66.246 cr** (6.96% of total donations) to the parties during FY 2018-19.
- b) **1578 donations from corporate/business sectors** were made to BJP (**Rs 698.14 cr**) while **2735 individual** donors donated **Rs 41.64 cr** to the party during FY 2018-19.
- c) INC received a total of Rs 127.602 cr via 124 donations from corporate/business sectors and Rs 20.288 cr via 480 individual donors during FY 2018-19.



6. Top donors to National Parties, FY 2018-19

- a) **Progressive Electoral Trust** donated a total of **Rs 455.15 cr** to BJP, INC and AITC together and is one of the top 2 donors to the three parties that received the maximum donations. The Trust donated **Rs 356.535 cr** to **BJP** (48.04% of total funds received by the party) and **Rs 55.629 cr** to **INC** (37.44% of total funds received by the party).
- b) BJP and INC received a total of Rs 67.25 cr (9.06%) and Rs 39 cr (26.25%), respectively from Prudent Electoral Trust.
- c) For top 10 donations to National Parties, refer Annexure 1.







Observations and Recommendations of ADR

Observations

- 1. Of the 7 National Parties, 4 parties, BJP, INC, CPI and CPM had **not declared PAN details** of **1300 donations** through which the parties collected a total of **Rs 29.44 cr (3.09%).** This is **five times** more than the amount of donations declared by these National Parties during FY 2017-18. **BJP** declared **Rs 27.24 cr** from **1170 donations** where it failed to provide PAN details of donors. **INC** collected **Rs 92.80 lakhs** from **28 donations** without PAN. **81** donations to **CPI** (**Rs 1.168 cr**) and 21 donations from **CPM** (Rs 10.70 lakhs) do not have PAN details.
- 2. **3 National Parties** (BJP, INC, and CPM) have declared **Rs 2.49 cr** from **46 donations** having **missing/incorrect PAN** details.
- 3. BJP declared 452 donations of Rs 514.48 cr, AITC collected 89 donations of Rs 44.26 cr and INC collected 51 donations of Rs 4.51 cr having incomplete cheque/DD details where cheque number, bank details on which it was drawn and the date on which the cheque was received/ encashed is not provided. Thus, without the complete cheque/DD details, it would be a time-consuming process to link the donors against their donations and hence trace the money trail.
- 4. **CPI** and **CPM** have also not declared the details of cheque and DD (cheque number, bank on which it was drawn and the date) for a total of 66 donations of **Rs 78 lakhs** and 31 donations of **Rs 35.63 lakhs**, respectively.
- 5. For the last **13 years** consecutively, **BSP** declared that the party **did not receive any donations** above Rs 20,000.
- 6. After the analysis by ADR, it is found that the **total sum of donations declared by INC** in its Contributions report is **incorrect**. It is found that the **total declared (Rs 146.78 cr) by the party is Rs 1.80 cr less than the actual amount (Rs 148.58 cr)**. This reinforces our demand for proper scrutiny of the parties' audited accounts by the IT department.
- 7. There are **167 donations of Rs 2.351 cr** declared by **BJP** in its Contributions Report for FY 2018-19 against which the **name of donor is not mentioned**. In case of **CPM**, the name of donor is not mentioned against **one contribution of Rs 30,000**.

Recommendations

- The Supreme Court gave a judgment on September 13, 2013 declaring that no part of a candidate's affidavit should be left blank. Similarly, no part of the Form 24A submitted by political parties providing details of donations above Rs 20,000 should be blank.
- 2. All donors who have donated a **minimum of Rs 20,000** as a single or multiple donations should **provide their PAN** details.
- 3. Full details of all donors should be made available for public scrutiny under the RTI. Some countries where this is done include Bhutan, Nepal, Germany, France, Italy, Brazil, Bulgaria, the US and Japan. In none of these countries is it possible for nearly 50% of the source of funds to be unknown, but at present it is so in India.
- 4. The National and Regional Parties should, ideally, lead by example by filing complete and correct statements of donations to the ECI well in time for public scrutiny so as to encourage financial transparency.
- 5. It is suggested that the ECI publicize on its website details of the action taken (if any) against political parties that fail to provide required details (such as name, address, PAN and mode of payment) of individuals, companies or entities making donations in cash.
- 6. **Incomplete contributions reports** having missing or incorrect PAN/mode of payment details must **be returned to the parties** by the ECI, to deter them from providing incomplete information.
- 7. The National and Regional political parties must provide all information on their finances under the Right to Information Act. This will go a long way in strengthening political parties, elections and democracy.





8. **Annual scrutiny** of donations reports of **National, Regional** and **unrecognized parties** should be initiated by a dedicated department of the **CBDT**, to **discourage donations** from **shell companies or illegal entities**.

Detailed Report

Political parties rely heavily on donations for contesting elections and running their daily affairs. They receive huge sums of money in the form of donations/ contributions from corporates or business houses, trusts and individuals. Section 29C of the Representation of People Act, 1951 mandates that political parties submit their contribution details in excess of Rs 20,000 received from any person or a company to the ECI annually, in order to enjoy 100% tax exemption.

This report, prepared by **Association for Democratic Reforms** (ADR), focuses on donations received by the National Political Parties, above Rs 20,000, during the Financial Year 2018-19, as submitted by the parties to the Election Commission of India (ECI). The National Parties include Bharatiya Janata Party (**BJP**), Indian National Congress (**INC**), Bahujan Samaj Party (**BSP**), Nationalist Congress Party (**NCP**), Communist Party of India (**CPI**), Communist Party of India (**Marxist**) (**CPM**) and All India Trinamool Congress (**AITC**)

1. Donations above Rs 20,000 to National Parties from all over India (FY 2018-19)

- a) The total amount of donations received above Rs 20,000 by National Political Parties during FY 2018-19 is calculated from the donations report submitted to the Election Commission annually.
- b) The total amount of donations above Rs 20,000 declared by the National Parties was Rs. 951.66 cr, from 5520 donations, which amounts to an average of Rs 17.24 lakhs per donor.
- c) With regard to the total number of donations, BJP leads with 4483 donations from individuals and corporates while INC declared a total 605 donations followed by CPM with 160 donations, CPI with 137 donations and AITC with 89 donations. The least number of donations was declared by NCP (46 donations).
- d) A total of **Rs 742.15 cr** was declared by **BJP** during FY 2018-19 while **INC** declared receiving **Rs 148.58 cr** during the same period.
- e) The donations declared by BJP is more than 3 times the aggregate declared by the INC, NCP, CPI, CPM and AITC for the same period (Rs 742.15 cr against Rs 209.51 cr declared by the remaining parties).
- f) BJP received an average of Rs 16.55 lakhs per donor; AITC Rs 49.73 lakhs per donor, NCP Rs 26.19 lakhs per donor, INC Rs 24.55 lakhs per donor, CPM Rs 1.89 lakhs per donor and CPI Rs 1.16 lakhs per donor.
- g) **BSP declared that the party did not receive any donations above Rs 20,000** during FY 2018-19, as it has been declaring for the past 13 years.



- II. Comparison of donations received by National Parties between FY 2017-18 and FY 2018-19
 - a) The total donations of the **National Parties** during FY 2018-19 **rose by Rs 481.77 cr, an increase of 103%,** from the previous financial year, 2017-18.
 - b) Donations to BJP increased from Rs 437.04 cr during FY 2017-18 to Rs 742.15 cr during FY 2017-18 (70% increase) while donations to INC increased from Rs 26.658 cr during FY 2017-18 to Rs 148.58 cr during FY 2018-19 (457% increase).
 - c) AITC declared the highest increase of 21757%, from Rs 20.25 lakhs in FY 2017-18 to Rs 44.26 cr in FY 2018-19 while NCP has declared increase of 477%, from Rs 2.087 cr in FY 2017-18 to Rs 12.05 cr in FY 2018-19.






III. Mode of contribution to National Parties

- a. National Parties declared receiving a total of **Rs 888.28** cr by cheque/DD from **5084 donations** and formed **93.34%** of the total donations received.
- b. It is to be noted that **689 donations** of a total of **Rs 564.39 cr** or **59.31%** of all donations contained incomplete cheque/DD details while **69 donations**, amounting to **Rs 86.9 lakhs** contained **undeclared** information of the mode of contribution and formed **0.09%** of the total donations declared by the parties.
- c. **Rs 61.796 cr** comprising of **313 donations** declared as received by the National Parties through **Bank Transfer** for FY 2018-19.
- d. Only 0.08% of the total donations received from 54 donations or Rs 71.44 lakhs was by cash.




IV. Donors from Corporates/ business sectors Vs. Individual donors

- a. Corporates/ business sectors have been segregated from individual donations by **ADR** as this segregation is not a part of the form submitted by the political parties to the ECI.
- b. **1782 donations from corporate/business sectors** amounting to **Rs 881.26 cr** were made to the National Parties while **3501 individual** donors donated **Rs 66.246 cr** to the parties during FY 2018-19.
- c. With the maximum number of donations during FY 2018-19, BJP has declared **1578 donations from corporate/business sectors** amounting to **Rs 698.14 cr** while **2735 individual donors** donated **Rs 41.64 cr** to the party.
- d. Donations from corporates formed 94.07% of total donations declared by BJP.
- e. 124 donations from corporate/business sectors amounting to Rs 127.602 cr were made to INC while 480 individual donors donated Rs 20.288 cr to the party.
- f. **Donations from corporates** formed **85.88%** of total donations declared by **INC**.





- c. A total of **Rs 548.227 cr** was donated to the National Parties from **Maharashtra**, followed by **Rs 141.42 cr** from **Delhi** and **Rs 55.31 cr** from **Gujarat**.
- d. A total of **Rs 65.84 cr**, (6.92% of total donations received by the National parties, FY 2018-19), could not be attributed to any State/ Union Territory due to **incomplete information** provided by the parties.
- e. Of the donations from **corporate** houses, **Rs 45.347 cr** could not be segregated into donations from various states.
- f. Corporate/ Business houses from Maharashtra donated Rs 539.506 cr while those from Delhi gave Rs 137.739


VI. Cash donations declared by National Parties - FY 2018-19

- a. **Maximum donations in cash** was declared by **INC** which collected a total of **Rs 60.54 lakhs** followed by **CPM** with **Rs 3.93 lakhs** and **CPI** with **Rs 2.25 lakhs** from **top 5 contributing states.**
- b. Among all the states, donors from **Mizoram** made the highest donations of **Rs 60 lakhs** in cash followed by donors from **Delhi** who donated a total of **Rs 3.22 lakhs in cash.**

VII. Incomplete disclosure of information in the donations report


- a) Of the 7 National Parties, 4 parties, BJP, INC, CPI and CPM had **not declared PAN details** of **1300 donations** through which the parties collected a total of **Rs 29.44 cr.**
- b) **BJP** collected **Rs 27.24 cr** from **1170 donations** but failed to provide PAN details of donors. **CPI** collected **Rs 1.168 cr** from **81 donations** without PAN. 28 donations to **INC** (Rs 92.80 lakhs) and 21 donations from **CPM** (Rs 10.70 lakhs) do not have PAN details.
- c) Three National Parties (BJP, INC and CPM) have declared **46 donations** of **Rs 2.49 cr** having **missing/incorrect PAN details** for FY 2018-19.
- d) BJP declared Rs 2.195 cr from 34 donations with missing/incorrect PAN details of donors. INC collected Rs 27.50 lakhs from 9 donations without complete PAN and 3 donations of CPM (Rs 1.90 lakh) do not have complete PAN details.
- e) None of the donations declared by AITC and NCP during FY 2018-19 have missing/incorrect or undeclared PAN details.




- a. Of the total donations of **Rs 951.66 cr**, the top **2 donors** of every National Party combined, donated a sum of **Rs 569.376 cr** which forms **59.83**% of the parties' overall donations above Rs 20,000 during FY 2018-19.
- b. Progressive Electoral Trust donated a total of Rs 455.15 cr to BJP, INC and AITC combined and is one of the top 2 donors to the three parties. The Trust donated Rs 356.535 cr to BJP (48.04% of total funds received by the party) and Rs 55.629 cr to INC (37.44% of total funds received by the party). AITC received Rs 42.986 cr or 97.12% of its total donations from Progressive Electoral Trust.
- c. **NCP** has received **Rs 5 cr** donations from **B.G. Shirke Construction Technology Pvt. Ltd.** and **Rs 2 cr** from New Democratic Electoral Trust, Mahindra & Mahindra Ltd.
