EC's directions (in its letters dated 6th Mar'20 & 10th Oct'18) in compliance with SC orders dated 25th September, 2018 and 13th February, 2020 on Publication of Criminal Cases by Candidates and Political Parties including recording of reasons for selection.

ECI's Letter dated 6th March, 2020 in compliance with Supreme Court directions dated 13th February, 2020:

- 1) It is mandatory for political parties at the Central and State election level to upload on their *website detailed information regarding candidates with pending criminal cases including the nature of the offences, relevant particulars like whether charges have been framed, the concerned Court, the case number etc.*
- 2) Political parties will also have to give *reasons for such selection* and *why other individuals without criminal antecedents could not be selected as candidates.*
- 3) The reasons as to selection shall be with reference to the *qualifications, achievements and merit of the candidate concerned*, and not mere "winnability" at the polls.
- 4) This information shall also be published in: (a)*One local vernacular newspaper and one national newspaper;* (b)On the *official social media platforms* of the political party, including **Facebook & Twitter**.
- 5) These details shall be published within *48 hours of the selection of the candidate or not less than two weeks before the first date for filing of nominations*, whichever is earlier.
- 6) The political party concerned shall then submit *a report of compliance with these directions with the Election Commission within 72 hours* of the selection of the said candidate.
- 7) If a political party *fails to submit such a compliance report* with the Election Commission, *the Election Commission shall bring such non-compliance by the political party concerned to the notice of the Supreme Court as being in contempt of this Court's orders/directions.*

For Candidates:

1. Each contesting candidate shall fill up the form as provided by the Election Commission and the form ***must contain all the particulars as required*** therein.
2. It shall state, ***in bold letters, with regard to the criminal cases pending against the candidate.***

3. If a candidate is contesting an election on the ticket of a particular party, ***he/she is required to inform the party about the criminal cases pending against him/her.***

For Political Parties:


1. The concerned political party shall be ***obligated to put up on its website the aforesaid information pertaining to candidates having criminal antecedents.***

Both Political Party and Candidates.

1. It is mandatory for **political parties** and **candidates** with criminal antecedents to publish the declaration ***atleast on three different dates from the date following the last date of withdrawal of candidatures and upto two days before the date of poll.*** The matter should be published in font size of at least 12 and should be placed suitably in newspapers. In case of ***declaration in TV Channels, the same should be completed before a period of 48 hours ending with hours fixed for conclusion of poll.*** There is a format provided by ECI for such a declaration by the candidates and political parties.
2. In case of non compliance of the direction by the ***candidate/political parties, the returning officers will give a written reminder*** to them and in the event of non compliance till the end of the elections, ***the returning officer will report to the state's Chief Electoral Officer who will intimate ECI. ECI will take a final decision in the matter.*** The standard format for such a reminder to the candidates and political parties is also annexed in the letter.
3. ***All political parties; recognized parties and registered unrecognized parties shall submit a report to the CEO of the concerned state stating that they have fulfilled the requirements of the directions and enclosing herewith the paper cuttings containing the directions.*** This shall be done within 30 days of the completion of elections. Thereafter, within the next 15 days, the CEO should submit a report to the ECI confirming compliance and pointing out cases of defaulters.

Summary and Highlights

The Assam Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **345** candidates, who are contesting in the **Assam Assembly Elections Phase II** in the following **39 constituencies**:

Criminal Background

- **Candidates with Criminal Cases:** Out of 345 candidates analyzed, 37 (11%) candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** 30(9%) have declared serious criminal cases against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.




Figure: Party Wise Candidates with Criminal Cases

- **Party wise Candidates with Criminal Cases:** Among the major parties, **11(32%)** out of 34 candidates analysed from **BJP**, **5(18%)** out of 28 candidates analysed from **INC**, **5 (71%)** out of 7 candidates analysed from **AIUDF**, **2 (33%)** out of 6 candidates analysed from **AGP**, **3 (16%)** out of 19 candidates analysed from **Assam Jatiya Parishad** and **One** candidate each from **AIFB, SUCI(C) and United Peoples Party Liberal** have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** Among the major parties, **10(29%)** out of 34 candidates analysed from **BJP**, **3(16%)** out of 19 candidates analysed from **Assam Jatiya Parishad**, **3 (43%)** out of 7 candidates analysed from **AIUDF**, **2 (33%)** out of 6 candidates analysed from **AGP**, **2 (7%)** out of 28 candidates analysed from **INC** and **One** candidate each from **AIFB, United Peoples Party Liberal and SUCI(C)** have declared serious criminal cases against themselves in their affidavits.
- **Candidates with declared cases related to crime against women:** **3** candidates have declared cases related to crime against women. Out of **3** candidates 1 candidate has declared cases related to rape (**IPC Section-376**).
- **Candidates with declared cases related to murder:** **3** candidates have declared cases related to **murder (IPC Section-302)** against themselves.
- **Candidates with declared cases related to attempt to murder:** **2** candidates have declared cases related to **Attempt to murder (IPC Section-307)** against themselves.
- **Red Alert Constituencies*:** **2(5%) out of 39** constituencies are Red alert constituencies. Red alert constituencies are those where 3 or more contesting candidates have declared criminal cases against themselves.
- The **directions of the Supreme Court** have had **no effect on the political parties in selection of candidates in Phase II** of the Assam Assembly Elections 2021 as they have again followed their old practice of **giving tickets to around 11% candidates with criminal cases**. All major parties contesting in Assam phase II elections have given tickets ranging from 16 % to 71% candidates who have declared criminal cases against themselves. The Supreme Court in its directions dated 13th February, 2020 had **specifically instructed political parties** to give **reasons for such selection** and **why other individuals without criminal antecedents could not be selected as candidates**. As per these mandatory guidelines, the reasons for such selection has to be with reference to **qualifications, achievements and merit of the candidate concerned**. During the recent Bihar Assembly elections held in October, 2020 it was observed that **political parties gave unfounded and baseless** reasons like popularity of the person, does good social work, cases are politically motivated etc. These are **not sound and cogent reasons** for fielding candidates with tainted backgrounds. This data clearly shows that **political parties have no interest in reforming the electoral system** and our democracy will continue to suffer at the hands of lawbreakers who become lawmakers.




Figure: Share of Wealth among the Contesting Candidates

- **Crorepatis Candidates:** Out of the 345 candidates, 73(21%) are crorepatis.
- **Party wise Crorepati Candidates:** Among the major parties 19(56%) out of 34 candidates analysed from **BJP**, 18(64%) out of 28 candidates analysed from **INC**, 6(32%) out of 19 candidates analysed from **Assam Jatiya Parishad**, 5(71%) out of 7 candidates analysed from **AIUDF**, 3(75%) out of 4 candidates analysed from **Bodoland Peoples Front** and 3(50%) out of 6 candidates analysed from **AGP** have declared assets valued more than **Rs 1 crore**.




Figure: Party Wise Percentage of Crorepati Candidates

- **Average assets:** The average of assets per candidate contesting in the Assam Assembly Elections 2021 Phase II is **Rs 2.19 Crores**.
- **Party wise average assets:** Among major parties, the average assets per candidate for **34 BJP** candidates analysed is **Rs. 2.74 Crores**, **28 INC** candidates analysed is **Rs 4.78 Crores**, **19 Assam Jatiya Parishad** candidates have average assets of **Rs 88.70 Lacs**, **7 AIUDF** candidates have average assets of **Rs 21.25 Crores**, **6 AGP** candidates have average assets of **Rs 1.13 Crore** and **13 SUCI(C)** candidates have average assets worth **Rs. 25.43 Lacs**.

Other Background Details

- **Education details of candidates:** 209(61%) candidates have declared their educational qualifications to be between 5th and 12th standard while 131 (38%) candidates have declared having an educational qualification of **graduate or above**. 2 candidates are **Diploma holders** and 3 candidates are just **literate**.
- **Age details of candidates:** 113(33%) candidates have declared their age to be between **25 to 40 years** while **182 (53%)** candidates have declared their age to be between **41 to 60 years**. There are **49(14%)** candidates who have declared their age to be between **61 to 80 years**. **1 candidate** has declared his age 82 years.
- **Gender details of candidates:** 26(8%) female candidates are contesting in **the Assam assembly election 2021 Phase II**.

Recommendations of ADR:

- To remedy the existing problem of criminalization is to immediately act upon the plausible solutions offered by various committees, civil society and citizens. Supreme Court of India being the ultimate custodian of “Justice and Rule of Law” should reprimand political parties and politicians for their complete lack of will, reprehensible predilection and absence of required laws.
- Permanent disqualification of candidates convicted for heinous crimes like murder, rape, smuggling, dacoity, kidnapping etc.
- Disqualification of persons from contesting elections to the public offices against whom charges have been framed for having committed serious criminal offences punishable by imprisonment of at least 5 years, and the case is filed at least 6 months prior to the election in question.
- Cancellation of tax exemptions given to the political parties who field such tainted candidates.
- Bringing political parties under the Right to Information Act.
- De-register and de-recognise any political party if it knowingly puts up a candidate with a tainted background.
- Political party should annually file the information on criminal antecedents of their Office Bearers and make such records available to the public, including NIL records.
- Disqualification of candidates furnishing false information in the election affidavit (Form 26).
- Ensure trial of cases in which the politicians are accused to be concluded in a time bound manner.

- Implementation of SC judgment dated 23rd September, 2013 (i.e provision of NOTA buttons on the EVMs) in its *letter and spirit* by ensuring a) if NOTA gets more votes than any of the candidates, none of the candidates should be declared elected, and a fresh election should be held; b) in the fresh election, none of the candidates in the earlier election, in which NOTA got the highest number of votes, should be allowed to contest.




