#### Introduction

- All recognised political parties are required to submit a statement of election expenditure to the Election
   Commission of India (ECI) within 90 days of completion of Lok Sabha Elections
- Similarly, all contesting candidates are required to submit their expenditure statement to the ECI within 30 days of completion of elections
- The expenditure statements of political parties contain details of 'lumpsum amount given to the candidates' and the abstract statements of candidates provide information on 'lumpsum amount received from the parties'
- This report analyses the difference in the declarations made by political parties and their MPs on the lumpsum amounts granted and received as part of election expenditure during the Lok Sabha elections in 2009
- Of a total of 543 MPs, complete information was available only for 388 MPs which ADR has analysed. Of the remaining 155 MPs, 59 submitted incomplete expenditure reports (without details of lumpsum amount received by candidates) and abstract statements of 96 MPs were not available
- The analysis is made based on the expenditure reports submitted by the parties and the MPs from the date of announcement of elections to the date of completion of elections
- The expenditure limit for candidates is revised from time to time. During Lok Sabha Elections in 2009, the limit of
  expenditure for a parliamentary constituency in bigger states like U. P, Bihar, Andhra Pradesh, Madhya Pradesh
  was Rs. 25 lakhs and the lowest limit for a parliamentary constituency was Rs. 10 lakhs for the constituency of
  Dadra and Nagar Haveli, Daman and Diu and Lakshadweep.

## Summary

- Total numbers of MPs whose expenditure statements were analysed: 388 MPs
- Out of 277 MPs from national parties, a total of Rs 7,46,58,901 (~ Rs 7.46 crores) was declared by 75 MPs as received from their parties but the national parties have declared that Rs 14,19,12,228 (~ Rs 14.19 crores) was given to 138 MPs

- Of the regional parties, a total of 15 MPs from 12 different parties and belonging to 9 different states have mentioned various amounts as received from their respective parties which do not match with the affidavits submitted by the parties.
- Party-wise breakup of difference in amounts declared by the MPs
  - Out of 123 MPs to whom INC has declared to have given lumpsum amounts for election expenditure, 81 MPs have declared NIL amount received. Shri Pranab Mukherjee who was given Rs. 15 lacs as declared by the party, has mentioned that no lump sum amount was received for his election expenses. Others include Subodh Kant Sahay, Jyotiraditya Scindia, Manish Tewari, Sachin Pilot, P. Chidambaram, Beni Prasad Verma, etc

- Only 25 MPs from INC have declared the same amount as declared by the party which include Rahul Gandhi,
   Shashi Tharoor, Meenakshi Natrajan, Salman Khurshid, among others
- BJP, on the other hand, reports that they did not financially support even one winning candidate but 25 MPs declared that they received a total of Rs 2,75,49,383 (~Rs2.75 crores) from their party

  - INC declared having given Rs 4.5 lakhs each to 2 MPs, Rs 5 lakhs each to 2 MPs, Rs 10 lakhs each to 116 MPs,
     Rs 15 lakhs each to 2 MPs and Rs 25 lakhs to 1 MP for their election expenditure
  - CPM declared having given a total of Rs 20.68 lakhs to 3 MPs, each receiving amounts below Rs 10 lakhs and Rs 144.60 lakhs to 10 MPs, each receiving more that Rs 10 lakhs

#### Ministers' declaration of election expenditure

- Of the 72 ministers of the Union Cabinet, **12 ministers are from the Rajya Sabha**, who do not contest in elections and hence do not file their expenditure statements.
- o 60 ministers in the Union Cabinet are from the Lok Sabha out of which the complete expenditure statements for analysis is available for 36 Ministers of which 12 are Cabinet Ministers, 17 Ministers of State and 7 are Ministers of State (Independent Charge).
- o A total of Rs 3,45,50,000 (~Rs 3.45 crores) was given by INC to its 33 Ministers. 22 Ministers have declared they received no amount while only 4 have declared the same amount as their party's declaration
- Sriprakash Jaiswal (Minister of Coal), Dinsha Patel (Minister of Mines), P.Chidambaram (Minister of Finance) among 23 others have declared that they received no lumpsum amount from their parties while INC declared they gave a total of Rs 2.35 crores or an average of Rs 10 lakhs to these 23 MPs

#### Recommendations of ADR

#### 1. Deadline for submission of Election Expenses by the party

As seen from the information available on the Election Commission's website for the General Elections to the Lok Sabha 2009, the election expenses of only 36 parties are available while there were 53 recognised parties which contested the General Elections to Lok Sabha, 2009. There needs to be a final date set for the election expenses to be submitted to the ECI failing which the parties be penalized. This would push the parties to maintain proper records which could be made available within the set date.

#### 2. Submission of Election Expenses by unrecognized parties

Currently, the election expenditure statements have to be submitted only by national and recognized regional parties within 90 days after the elections and **not by unrecognized parties**. It would only improve financial transparency if all contesting parties disclosed their election expenditure during Lok Sabha and Assembly Elections.

#### 3. Details of donors

Details of the donors such as their names, companies, address and the individual contribution is unavailable for public scrutiny. Hence, a format similar to the donations report, submitted to the ECI on an annual basis, has to be prescribed so as to bring in more transparency in the functioning of the political parties especially during elections. The format should include all modes of payments such as Cash, DD, Cheque and Electronic transfer along with donors' names.

#### 4. Data verification with the election expenses submitted by the candidates

It is seen from the analysis that the declaration of the winning candidates on lumpsum amount received, does not match with their parties' declarations regarding the amount allocated to the candidate for election expenditure. As there is discrepancy in the data provided by the candidate and his/ her political party, it should be made mandatory to cross check data provided by all the candidates and the political parties. If the Election Commission could scrutinize the expenditure statements within 6 months of declaration of election results, erring parties and candidates should be penalized as this amounts to wrong filing of affidavits.





# Lok Sabha 2009 Election Expenditure Analysis:

# A comparison of declaration of election expenses by political parties and their MPs

#### Lumpsum amount granted by parties to their MPs for election expenditure

- INC, being the party with the maximum number of MPs (206), has provided aid to 123 MPs while BJP has declared that the party did not provide any lumpsum amount to even one winning candidate.
- BSP and NCP have declared that the parties did not provide any lumpsum amount to their candidates for expenditure during Lok Sabha elections, 2009
- CPI and CPM have provided aid to 2 and 13 MPs respectively.
- Only INC and CPM provided more than Rs 10 lacs to their MPs. INC gave Rs 25 lacs to Shri Rahul Gandhi and Rs 15 lacs each to Shri Kamal Nath and Shri Paranab Mukerjee
- CPM gave more than Rs 10 lacs to 12 of its MPs
- There were a total of 171 MPs from 32 (31+ IND) regional parties of which the complete information is available for 111 MPs.

#### Lumpsum amount declared by MPs as received from their parties

- 81 MPs from INC have declared NIL lumpsum amount received from their party while INC has said that a total of Rs 8,09,00,000 (~Rs 8.09 crores) was provided to the 81 MPs
- 9 MPs from INC have declared amounts less than what the party had provided. Difference in amount equals Rs
   65,49,303 (~ Rs 65.49 lakhs)
- BJP declared that the party did fund any of its MPs, 27 MPs have declared in their affidavits that they received
  a total of Rs 2,75,49,782 (~Rs 2.75 crores)
- BSP and NCP declared that the parties provided no funds to any of their candidates, but Mr. Dhananjay Singh of BSP declared that he had received Rs. 2.5 lacs from his party while Mr. Sameer Magan Bhujbal of NCP declared that he has received Rs. 4 lacs from his party
- Mr Anirudhan Sampath of CPM declared he received Rs 19,02,458 from the party while the party declared otherwise.
- Similarly, Mr. P. Lingam of CPI declared he had received Rs. 18.57 lacs as a lump sum amount from the party while the party has not listed his name as one of the recipients
- Only INC and CPM provided more than Rs 10 lacs to their MPs. INC gave Rs 25 lacs to 1 MP and Rs 15 lacs to 2 MPs while CPM gave more than Rs 10 lacs to 12 of its MPs.

#### Submission of Election Expenses Statement by the Parties

It is to be noted that the election expenditure statements have to be submitted only by national and recognized regional parties within 90 days after the elections. Hence of the 11 parties listed below with at least 1 MP, only 2 parties are recognized regional parties and notices have been served to the two recognized parties by the Election Commission.

## Party-wise grant to MPs for Election Expenses

- A total of 120 MPs were given Rs. 10 lacs or less for their election expenses whereas 3 MPs were given more than Rs. 10 lacs for their election expenses.
- CPM is the only other party to have given more than Rs. 10 lacs to 10 of its MPs for their election expenses.
- CPI has declared to have given Rs. 10 lacs or less to 2 of its MPs.

## Party-wise break up of difference in amounts declared by MPs

The below table shows the discrepancies in the affidavits files by the MPs in relation to their election expenses:

- Of the 123 INC MPs to whom aid was given as declared by the party, only 25 MPs have declared the same amount as mentioned by the political party, whereas 81 MPs have said that they have not received any amount from the party though the party claims to have granted sums of money to the aforementioned MPs.
- Of all the 6 national parties, INC has the maximum number of MPs who have declared the same amount received
  as stated by the party, followed by CPM with one MP, Mr. Khagen Das of Tripura West constituency of Tripura
  State, declaring the same amount.
- Despite BJP declaring that it had incurred expenses on no winning candidate, 25 MPs have declared that they had received grants from their party.

## **Indian National Congress**

- The election expenditure incurred on candidates / MPs from Goa, Arunachal Pradesh, Haryana and Manipur were not available in the statement submitted by the party.
- The abstract statement, where the candidate specifies the lump sum amount received from the party, was not available in 59 affidavits hence the aid given as declared by the party could not be cross checked.
- Of the 206 INC MPs, the election expenses statement of 8 MPs did not have the page containing information on grant received from the party. It should be noted that the affidavit of Congress President, Ms Sonia Gandhi, did not contain the page with lump sum details while the party has claimed to have given Rs. 25 lacs to her for election expenses. We do not know whether it was not submitted or not uploaded by the Election Commission.

## List of MPs who have declared nil amount as received from the party

A total of 84 MPs have declared in their election expenses affidavit to the ECI that there was no lump sum amount received from their political party for election expenses while their political party (INC) has declared in its election expenses statement to the ECI that all the 81 MPs were given various amounts for their election to Lok Sabha in 2009.

It should be noted that 22 current members of the Union Council of Ministers too have listed that they had not received any grant from the party while the party says otherwise. Similarly, Mr. Pranab Mukherjee who was given Rs. 15 lacs as declared by the party, has mentioned that no lump sum amount was received for his election expenses.



# Election Expenses Comparison of Regional Parties and their MPs

- A total of 36 regional parties contested in the Lok Sabha 2009 elections. Only 19 regional parties submitted their election expenditure statements with the ECI.
- Of the 19 parties, 14 parties have mentioned that they had not provided any lumpsum amount to their candidates for contesting in Lok Sabha Elections, 2009
- Only Kerala Congress (Merger) and MDMK have declared that they had provided grant to their MPs.
- While KC(M) has declared to have given Rs 8,99,608 to its MP Mr. Jose K. Mani, the MP has declared that he was not granted any amount from his party
- Only MDMK MP, Mr. Ganeshamurthi has declared that Rs 24,00,000 was received by him from his party
- A total of 15 MPs from 12 different parties and belonging to 9 different States have mentioned various amounts as received from their respective parties which do not match with the affidavits submitted by the parties.

# Ministers' declaration of Election Expenses Aid from Party

- The aid provided by parties as mentioned in the affidavit of 72 ministers was analyzed.
- It should be noted that discrepancies were noted in their affidavits when compared with the statements submitted by the parties to the Election Commission.
- Of the 72 ministers of the Union Cabinet, 12 ministers are from the Rajya Sabha, who do not contest in elections and hence do not file their expenditure statements.
- 60 ministers in the Union Cabinet are from the Lok Sabha out of which the complete expenditure statements for analysis are available for 36 Ministers of which 12 are Cabinet Ministers, 17 Ministers of State and 7 are Ministers of State (Independent Charge).
- The analyzed list of Union Council of Ministers consists of 33 INC Ministers, 2 NCP Ministers and one Minister from J&KNC.
- RLD has not submitted its election expenses statement to the ECI therefore the figures submitted by its MP, Mr. Ajith Singh, could not be verified.
