Introduction :

Association for Democratic Reforms (ADR) is an organization established in 1999 with an aim to improve governance and strengthen democracy by continuous work in the area of Electoral and Political Reforms. Over past two decades ADR has been putting its effort in following areas

- Corruption and criminalization in the political process.
- Empowerment of the electorate through greater dissemination of information relating to the candidates and the parties, for a better and informed choice.
- Need for greater accountability of Political Parties.
- Need for inner-party democracy and transparency in party-functioning.

Mahiti Adhikar Gujarat Pahel (MAGP) is an initiative that promotes Right to Information Act as tool in the hands of the citizen to bring transparency in Governance and enhance accountability of the government towards people, as people hold supreme power in any democracy.

MAGP holds responsibility as Gujarat State Co-ordinator for ADR and conducts Gujarat Election Watch programme during General Assembly and state Legislative Assembly election.

Current Performance Report of MLAs of Gujarat is being released as part of Voter's Awareness Programme by Gujarat Election Watch. In coming days, we will be coming up with more reports regarding candidates of Gujarat Legislative Assembly Elections.

I. Questions Asked in the State Legislative Assembly during last 5 years.

Fourteenth Gujarat Vidhansabha all together held 9 sessions in last five years. Gujarat Vidhansabha has total of 182 constituencies. Currently we have 178 MLAs and 4 Assembly seats are Vacant (Bhiloda, Unjha, Dwarka & Khedbrahma¹)

We have made analysis of the Questions that were asked during these sessions both Starred and Un-Starred. The data has been taken from the *"Vidhan sabha Satrana Kamkaj no Aheval"* prepared by Vidhansabha and disclosed on the State Assembly website².

Gujarat state assembly in last five years had 10 sessions, 141 days of work. **Total of** <u>**38121 Starred and 10224 unstarred questions**</u> asked during 9 sessions. The data for questions during 10th session is not available.

We did not get detailed data on type of questions and responses given. We also did not get the separate compilation of questions-answers as earlier.


Out of 38,121 starred questions only 600 were answered in the house, that constitute 2% whereas 4800 (32%) unstarred questions were answered in the house.










- Out of 38121 starred questions,23.35 % (8905) were NOT Accepted, where as 0.42% (162) were withdrawn and 1.6% (623) were cancelled after accepting it.
- Out of **10224 unstarred questions**, **22% (2351)** got rejected, **and 0.04 % (5) were** withdrawn and 0.77 % (79) were cancelled after accepting it.
- Question is cancelled in three circumstances. Upon resignation of the MLA or demise of MLA or upon Minister's Request. However the reason for minister's request is unknown.




Starred total received V/s Rejected, Answered, Withdrawn and cancelled

II.USE OF LOCAL AREA DEVELOPMENT FUND

Under MLA Local Area Development Fund scheme (MLA LADS) every Member of Legislative Assembly can recommend/suggest developmental works worth Rs. 1.5 crore in her/his constituency. The District Planning Board keeps the accounts of the MLA LAD fund. In Gujarat this scheme has over 1365 crore rupees.





We had filed RTI with all district Planning Boards offices to get details of expenses done under MLALAD. Few districts gave information on CD while others simply transferred applications to all those authorities, to whom MLA LAD funds were given.

Complaint regarding non availability of information in user friendly manner has been filed with GIC and we are demanding for a separate website like <u>www.mplads.gov.in</u> giving MP wise expenses of the funds and details of kind of work executed using MPLAD funds in each year.

In Gujarat last give year works worth 1004.15 crore rupees were recommended by MLAs during 2017-2022 out of which 849.64 crores were released and 677.5 crores were spent till March 2022. This amounts to 67.47% of the total sanctioned amount.


Only 76 % of the works were completed out of total sanctioned 53,029 different works that were sanctioned out of which 40,428 works were completed till March 2022
















- Budget allocated for MLA LAD funds is for five years and all unspent amount is carried foreward to next year.
- Unspent amount of 300 crore will get expire once assembly term ends. This amount could have been effectively used.
- 6094 works could not be started at all despite sanctioning of works. Planning committee should look into the reason for this.








- Low expenditure also shows poor planning of works and poor execution.
- MLA needs to more pro-active in reaching to people to understand need at grass roots, kind of works those cannot be supported in regular planning for development and existing programme, and then pitch in with its support. Thus planning can be area specific and need based and innovative.




In above tribal district out of total 252 crore funds were available with MLAs. Works of Rs. 230.37 crores were sanctioned, and only 177.40 crores were spent. Thus 75 crore rupees remain unspent from the MLA LADs funds.

Total of -14689 works were planed out and sanctioned, only 11,445 works were completed (77%) which show several gaps in planning and execution state.

Transparency and Accountability issues with use of MLA LAD funds.

- There is no separate website for giving MLA LAD funds details as that of MPLAD fund webstie <u>www.mplads.gov.in</u>
- No sectoral data on expenses, or no year wise reports can be found.







- The IOJN website only gives total expenses.
- Very limited transparency in MLA LAD Scheme in planning, execution, monitoring, budget expenditure component.
- There is no reason given for large number of
- Out of 53029 works, No Photographs are uploaded for near to 40601 works.

III. MLAs participation in the discussion held in the assembly during last five years.

MLAs are expected to have discussion on the new policies that are being passed, abt the questions that are raised in the assembly floor, and also about larger issues concerning citizens like Status of poverty, unemployment, price rice, issues of labour, Food security, Malnourishment, law and order etc.

Given below is an analysis of their participation. As we do not have enough data on all questions raised and answers and minutes of discussion held thereafter. we restricted ourselves to frequency of participation and not "Quality of discussion".

95% (172) out of 182 MLAs participated for less than 50 times during last 5 years in any discussions, despite their attendance in the state assembly. Out of which 36% (66) participated less than 10 times..!!

This raises doubts on their interest, kind of discussions, (or discussion held or not ?) reason for their non-participation etc. Any vibrant Vibrant meeting is expected to have participation from participants.

Recommendations:--

- There should be separate web portal for disclosing MLALAD Scheme expenses where in sectoral as well as constituency wise data can be seen on dashboards. Today IOJN website only gives figures of expenses, but no comparative data. This is not user-friendly.
- There should be comprehensive guidelines for kind of work to be recommended under MLA LAD scheme, implementation mechanism, review for its progress, if work could not be started, then reason for same, reason for under-utilization etc.
- Gujarat Vidhasabha need to develop an application where in questions asked by the member of legislative assembly can be searched subject wise, session wise, name wise (as that of the parliament—DIGITAL SANSAD)
- The attendance of the member of legislative assembly should also be displayed in the form of dashboard, along with details of her/his participation in the discussion held. He/she represents people. People elect them to perform, to work for them, to discuss policy matter, to argue and to make good policies for sustainable development. Thus it is very much important that there should a user friendly portal as well as mobile based application which can give details of her/his performance to people.
- Such dashboard based presentation (interactive, user friendly) will bring transparency in MLAs work and thus will enhance their credibility.
