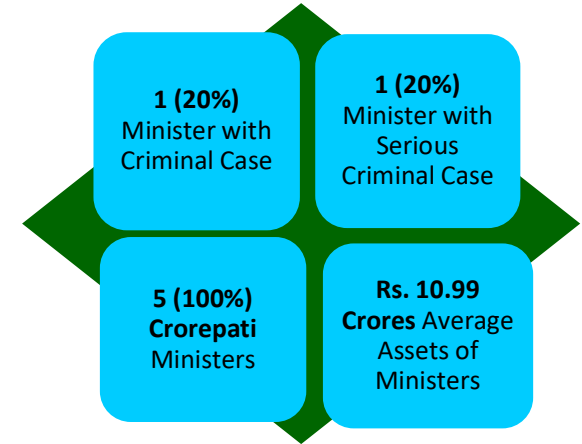

Association for Democratic Reforms (ADR) and Assam Election Watch have analysed the self-sworn affidavits of 5 Ministers including Chief Minister, sworn in on 12<sup>th</sup> May 2026 for the Assam State Assembly.

The information is based on the affidavits submitted by the ministers prior to 2026 Assam Assembly Elections.

## Financial Background

- **Crorepati Ministers:** Out of the **5** ministers analysed, **all 5 (100%)** are crorepatis.
- **Average Assets:** The average assets of **5** ministers analysed is **Rs 10.99 crores**.
- **Minister with Highest Assets:** The minister with the highest declared total assets is **Himanta Biswa Sarma** from **Jalukbari** constituency with assets worth **Rs. 35.16 crores**.
- **Minister with Lowest Assets:** The minister with the lowest declared total assets is **Rameswar Teli** from **Duliajan** constituency with assets worth **Rs. 3.17 crores**.
- **Liabilities:** A total of **3 (60%)** ministers have declared liabilities out of which the minister with the highest liabilities is **Himanta Biswa Sarma** of **Jalukbari** constituency with **Rs. 16.86 crores** of liabilities.

## Other Background details (Education, Gender, Age)

- **Ministers' Education:** **1 (20%)** minister has declared their educational qualification as **10th** standard, while **4 (80%)** ministers have declared educational qualifications of **graduate or above**.
- **Ministers' Age:** **1 (20%)** minister has declared his age as **46 years**, while **4 (80%)** ministers have declared their ages to be between **51** and **70 years**.
- **Women Ministers:** Out of **5** ministers, **1** is a woman.
