Summary and Highlights

Uttar Pradesh Election Watch and Association for Democratic Reforms have analysed the self-sworn affidavits of all **44 out of 47 Ministers including Chief Minister** from Uttar Pradesh State Assembly 2017. Three ministers namely Dr. Dinesh Sharma, Dr. Swatantra Dev Singh and Mohsin Raza have not been analysed due to the unavailability of data. Dr. Dinesh Sharma is a mayor whereas the other two are not currently members of either any house, state assembly or legislative council.

Criminal Background

- **Minister with Criminal Cases:** **20 (45%)** ministers have declared criminal cases against themselves.

Financial Background

- **Crorepati Ministers:** Out of the **44** ministers, **35 (80%)** are crorepatis.
- **Average Assets:** The average assets of **44** ministers is **Rs 5.34 crores**.
- **Ministers with Highest Assets:** The minister with the highest declared total assets is **Nand Gopal Gupta Nandi** from Allahabad South constituency with assets worth **Rs.57.11 crores**. The top three ministers with highest declared assets are:

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
