## Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **102 out of 115 winners** who have contested the Vasai Virar City Municipal Corporation Elections of 2015. Remaining 13 affidavits were not analysed due to incomplete or unclear affidavits uploaded at the time of making this report.

## Criminal Background

- **Winners with Criminal Cases:** Out of the 102 winners analysed, **17 (17%)** have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** Out of 102 winners analyzed, **12 (12%)** have declared serious criminal cases.
- **Party wise Winners with Criminal Cases:** **14 (15%)** out of 93 winners analysed from **Bahujan Vikas Aghadi** and **1 (20%)** out of 5 winners analysed from **Shiv Sena** have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with Serious Criminal Cases:** **10 (11%)** out of 93 winners analysed from **Bahujan Vikas Agadhi** and **1 (20%)** out of 5 winners analysed from **Shiv Sena** have declared serious criminal cases against themselves in their affidavits.

### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

## Financial Background

- **CrorepatiWinners**: Out of the 102 winners analysed, **56 (55%)** are crorepatis.
- **High Asset Winners**: Out of 102 winners analysed, **6 winners** declared assets worth more than Rs. 10 crores. The details of the top five winners with high assets is :

- **Average Assets**: The average assets per winner analysed for the Vasai Virar City Municipal Corporation 2015 elections is **Rs. 5 crore +**.
- **Party-wise Average Assets**: Among major parties, the average asset per winner for 93 analysed **BahujanVikasAgadhi** winners is approximate 5 crore +, 5 analysed **Shiv Sena** winners have average assets of Rs.5 crore + and 1 analysed **BJP** winner has average assets worth Rs. 1 crore +.

- **PAN Details of Winners:** 17(17%) winners out of 102 analysed have not declared their PAN details. Out of these, 4 winners have total assets worth more than Rs. 1 crore (including 2 winners having assets worth more than Rs. 5 crores).

## Other Background Details

**Education Details of Winners:** 2 (2%) winners have declared that they are **illiterate**. 4 (4%) winners have declared that they are **literate**. **64 (63%)** winners (including winners who are literate) have declared that have an education qualification of **12<sup>th</sup> pass or below** while **31 (30%)** winners have declared having an educational qualification of **graduate or above**.

**Age Details of Winners:** Out of total **102** analysed winners, **1** winner has declared his age to be between **21 to 24 years** of age while **83** winners declared their ages to be between **25 to 50 years**. **15** winners declared their ages to be between **51 to 60 years** whereas only **3** winners declared their ages to be between **61 to 70 years**. The youngest winner is **22 years old** and the oldest winner is **70 years**.
