Analysis of Donations Received above Rs 20,000 by National Political Parties, FY 2020-21

This report, prepared by **Association for Democratic Reforms (ADR)**, focuses on donations received by the National political parties, above Rs 20,000, during the financial year 2020-21, as submitted by the parties to the Election Commission of India (ECI). The National parties include Bharatiya Janata Party (**BJP**), Indian National Congress (**INC**), Bahujan Samaj Party (**BSP**), Nationalist Congress Party (**NCP**), Communist Party of India (**CPI**), Communist Party of India (Marxist) (**CPM**), All India Trinamool Congress (**AITC**) and National People's Party (**NPEP**).

Executive Summary

The **executive summary** below lists the key observations drawn from the report:

1. Status of Submission of Contribution reports of National Parties, FY 2020-21


- a) The **due date** for submission of contribution reports for the parties was **30 September 2021**.
- b) **Only BSP** submitted its contribution report on time while **NCP, AITC, CPM, NPEP, INC, BJP** and **CPI** submitted after a delay of 10 days, 117 days, 136 days, 137 days, 161 days, 164 days and 178 days, respectively.

2. Donations above Rs 20,000 to National Parties from all over India, FY 2020-21

- a) The **total donations** (above Rs 20, 000) declared by the National parties for FY 2020-21 was **Rs 593.748 cr** from **3753 donations**.
- b) A total of **Rs 477.545 cr** from 2206 donations was declared by **BJP** followed by **Rs 74.524 cr** from 1077 donations declared by **INC**. The **donations declared by BJP** are **more than four times the aggregate declared by INC, NCP, CPI, CPM, NPEP and AITC** for the same period.
- c) **BSP** declared that the party **did not receive any donations above Rs 20,000** during FY 2020-21, as it has been **declaring for the past 15 years**.


No. and Amount of contributions (above Rs 20,000) declared by National Parties, FY 2020-21 (in Rs Cr)



3. Comparison of donations received by National parties during FY 2019-20 and FY 2020-21

- For this comparison, we are not taking **National People's Party's** income amount as the party's donation statement is **not available on ECI website** for FY 2019-20.
- The **total donations** of the National parties during FY 2020-21 **decreased by Rs 420.652 cr, a decrease of 41.49%** from the previous financial year 2019-20.
- Donations to BJP decreased** from Rs 785.77 cr during FY 2019-20 to Rs 477.545 cr during FY 2020-21 (**39.23% decrease**). While the party's donations **increased by 5.88% during FY 2019-20 in comparison to FY 2018-19**.
- INC's donations** decreased from Rs 139.016 cr during FY 2019-20 to Rs 74.524 cr during FY 2020-21 (**46.39% decrease**). While **INC's donations decreased by 6.44%** between FY 2018-19 and FY 2019-20.

Comparison of contributions (above Rs 20,000) to National Parties for FY 2019-20 and FY 2020-21 (in Rs Cr)




- e) In a comparison of the previous FY decrease in donations declared by **AITC** was 94.74% (Rs 7.6585 cr), **NCP** - 56.19% (Rs 33.685 cr) and **CPM**- 34.49% (Rs 6.7925 cr).

4. State-wise donations to National Parties: FY 2020-21


- Segregation of donations according to state** was made by **ADR** based on the **addresses** provided by the parties in their donations report to the ECI.
- A total of **Rs 246.502 cr** was donated to the National Parties from **Delhi**, followed by **Rs 71.681 cr** from **Maharashtra** and **Rs 47.071 cr** from **Gujarat**.
- A total of **Rs 37.912 cr**, (6.39% of total donations received by the National parties, FY 2020-21), could not be attributed to any State/ Union Territory due to **Incomplete/Undeclared information** provided by the parties.

Top 5 states which contributed to National parties, FY 2020-21 (in Rs Cr)




5. Donors from corporates/business sectors Vs. individual donors

- 1398 donations** to the National parties were made by **corporate/business sectors** amounting to **Rs 480.655 cr (80.953%** of total donations) while **2258 individual** donors donated **Rs 111.65 cr (18.804%** of total donations) to the parties during FY 2020-21.
- 1111 donations from corporate/business sectors** were made to **BJP (Rs 416.794 cr)** while **1071 individual** donors donated **Rs 60.37 cr** to the party during FY 2020-21.
- INC** received a total of **Rs 35.89 cr** via **146** donations from **corporate/business sectors** and **Rs 38.634 cr** via **931 individual donors** during FY 2020-21.
- BJP (Rs 416.794 cr)** received **more than six times** the total amount (Rs 63.931 cr) of **corporate donations** declared by all other National parties for the FY 2020-21.



6. Top donors to National Parties, FY 2020-21

- Prudent Electoral Trust** donated a total of **Rs 216.00 cr** to **BJP, NCP** and **INC** together and is the top donor to parties that received the maximum donations. The Trust donated **Rs 209.00 cr to BJP** (43.766% of total funds received by the party), **Rs 5.00 cr to NCP** (19.04% of total funds received by the party). and **Rs 2 cr to INC** (2.68% of total funds received by the party).
- IRB Infrastructure Developers Ltd** (Rs 20.00 cr, 1 donation), **Modern Road Makers Pvt Ltd. Ltd.** (Rs 20.00 cr, 1 donation) and **Saranjay Brahma** (Rs 14.46 cr, 4 donations) are some of other top donors of **BJP** in the FY 2020-21.
- BJP and INC received a total of Rs 10.00 cr (2.09%) and Rs 60 lakhs (0.81%), respectively from **Nirma Ltd.**

Observations and Recommendations of ADR

Observations

1. **NCP, AITC, CPM, NPEP, INC, BJP and CPI** submitted contribution reports after a delay of 10 days, 117 days, 136 days, 137 days, 161 days, 164 days and 178 days, respectively.
2. It is to be noticed that **INC** declared **Rs 74.504 cr** but the actual calculated amount is **Rs 74.524 cr** and **CPM** had declared **Rs 12.854 cr** but the actual calculated amount is **Rs 12.901 cr** in their donation statements for FY 2020-21.
3. 5 National parties, **BJP, INC, CPM, CPI and NPEP** had not declared **PAN details of 171 donations** through which the parties collected a total of **Rs 2.746 cr (0.46%** of the total donations declared by National parties).
4. 4 National Parties (INC- Rs 5.43 cr, BJP-Rs 63.50 lakhs, CPM- Rs 2 lakhs and NCP- Rs 1 lakh) have declared **Rs 6.095 cr from 43 donations having missing/incorrect PAN details.**
5. **BJP** declared 252 donations of Rs 81.383 cr, **INC** collected 90 donations worth Rs 12.21 cr, **AITC** collected 26 donations of Rs 42.50 lakhs, **CPM** collected 26 donations of Rs 17.35 lakhs, **NPEP** collected 3 donations of Rs **8.35 lakhs** and **CPI** collected 1 donation of Rs 50,000 having **incomplete cheque/DD details** where cheque number, bank details on which it was drawn and the date on which the cheque was received/ encashed is not provided. Thus, without the complete cheque/DD details, it would be a time-consuming process to link the donors against their donations and hence trace the money trail.
6. As done for the **last 15 years, BSP has remarkably declared again that the party did not receive any donations above Rs 20,000.**

Recommendations

1. The Supreme Court gave a judgment on September 13, 2013 declaring that no part of a candidate's affidavit should be left blank. Similarly, **no part of the Form 24A submitted by political parties providing details of donations above Rs 20,000 should be blank.**
2. All donors who have donated a **minimum of Rs 20,000** as a single or multiple donations should **provide their PAN details.**
3. Full details of all **donors should be made available for public scrutiny under the RTI.** Some countries where this is done include Bhutan, Nepal, Germany, France, Italy, Brazil, Bulgaria, the US and Japan. In none of these countries is it possible for nearly 50% of the source of funds to be unknown, but at present it is so in India.
4. The National parties should, ideally, lead by example by filing complete and correct statements of donations to the ECI well in time for public scrutiny so as to encourage financial transparency.
5. It is suggested that the **ECI publicize on its website details of the action taken (if any) against political parties that fail to provide required details** (such as name, address, PAN and mode of payment) of individuals, companies or entities making donations in cash.
6. **Incomplete contributions reports** having missing or incorrect PAN/mode of payment details must **be returned to the parties** by the ECI, to deter them from providing incomplete information.
7. **The National and Regional political parties must provide all information of their finances under the Right to Information Act.** This will go a long way in strengthening political parties, elections and democracy.

8. **Annual scrutiny** of donations reports of **National, Regional** and **unrecognized parties** should be initiated by a dedicated department of the **CBDT**, to **discourage donations from shell companies or illegal entities**.

Detailed Report


Political parties rely heavily on donations for contesting elections and running their daily affairs. They receive huge sums of money in the form of donations/ contributions from corporates or business houses, trusts and individuals. Section 29C of the Representation of People Act, 1951 mandates that political parties submit their contribution details in excess of Rs 20,000 received from any person or a company to the ECI annually, in order to enjoy 100% tax exemption.

This report, prepared by Association for Democratic Reforms (ADR), focuses on donations received by the National Political Parties, above Rs 20,000, during the FY 2020-21, as submitted by the parties to the Election Commission of India (ECI). The National parties include Bharatiya Janata Party (**BJP**), Indian National Congress (**INC**), Bahujan Samaj Party (**BSP**), Nationalist Congress Party (**NCP**), Communist Party of India (**CPI**), Communist Party of India (Marxist) (**CPM**), All India Trinamool Congress (**AITC**) and National People's Party (**NPEP**).

- I. **Donations above Rs 20,000 to National Parties from all over India (FY 2020-21)**
- The total amount of donations received above Rs 20,000 by National political parties during FY 2020-21 is calculated from the donations report submitted to the Election Commission annually.
 - The total amount of donations above Rs 20,000 declared by the National Parties was **Rs.593.748 cr**, from **3753 donations**, which amounts to an average of **Rs 15.82 lakhs per donation**.
 - With regard to the total number of donations, **BJP leads with 2206 donations** from individuals and corporates while **INC** declared a total of **1077 donations** followed by **CPM** with **226 donations**, **CPI** with **124** donations, **NCP** with **79** donations and **AITC** with **26** donations. The least number of donations was declared by **NPEP (15 donations)**.
 - A total of **Rs 477.545 cr** was declared by **BJP** during FY 2020-21 while **INC** declared receiving **Rs 74.524 cr** during the same period.
 - The **donations** declared by **BJP** are **more than 4 times the aggregate** declared by the INC, NCP, CPI, CPM, NPEP and AITC for the same period (Rs 477.545 cr against Rs 116.203 cr declared by the **remaining parties**).
 - NCP** received an average of **Rs 33.24 lakhs** per donation; **BJP**– **Rs 21.64 lakhs** per donation, **INC** – **Rs 6.91 lakhs** per donation, **CPM** – **Rs 5.70 lakhs** per donation, **NPEP** – **Rs 3.96 lakhs** per donation, **AITC** – **Rs 1.63 lakhs** per donation and **CPI** – **Rs 1.20 lakhs** per donation.
 - BSP** declared that the party **did not receive any donations above Rs 20,000** during FY 2020-21, as it has been declaring for the past 15 years.

No. and Amount of contributions (above Rs 20,000) declared by National Parties, FY 2020-21 (in Rs Cr)




II. Comparison of donations received by National Parties between FY 2019-20 and FY 2020-21

- The **total donations** of the **National Parties** during FY 2020-21 decreased by **Rs 420.652 cr**, a **decrease of 41.49%**, from the previous financial year, 2019-20.
- Donations to **BJP** decreased from Rs 785.77 cr during FY 2019-20 to Rs 477.545 cr during FY 2020-21 (**39.23% decrease**) while donations to **INC** decreased from Rs 139.016 cr during FY 2019-20 to Rs 74.524 cr during FY 2020-21 (**46.39% decrease**).
- AITC** declared the **highest decrease of 94.74%**, from Rs 8.0835 cr in FY 2019-20 to **Rs 42.50 lakhs** in FY 2020-21 while **NCP** has declared **decrease of 56.19%**, from Rs 59.946 cr in FY 2019-20 to Rs 26.261 cr in FY 2020-21.


Comparison of contributions (above Rs 20,000) to National Parties for FY 2019-20 and FY 2020-21 (in Rs Cr)



III. Mode of Contribution to National Parties, FY 2020-21

- National Parties declared receiving a total of **Rs 479.141 cr** by cheque/DD from **2689 donations** and formed **80.698 %** of the total donations received.
- It is to be noted that **398 donations** of a total of **Rs 94.28 cr** or **15.879%** of all donations contained incomplete cheque/DD details while **27 donations**, amounting to **Rs 1.0405 cr** contained **undeclared** information of the **mode of contribution** and formed **0.175 %** of the total donations declared by the parties.
- Rs 113.565 cr** comprising of **1035 donations** declared as received by the National Parties through **Bank Transfer** for FY 2020-21.
- Only **0.0002%** of the total donations received from **2 donations** or **Rs 15,000** was by cash.




IV. Donors from Corporates/business sectors Vs. Individual donors

- Corporates/business sectors have been segregated from individual donations by ADR as this segregation is not a part of the form submitted by the political parties to the ECI.
- 1398 donations from corporate/business sectors amounting to Rs 480.655 cr were made to the National parties while 2258 individual donors donated Rs 111.65 cr to the parties during FY 2020-21.
- With the maximum number of donations during FY 2020-21, BJP has declared 1111 donations from corporate/business sectors amounting to Rs 416.794 cr while 1071 individual donors donated Rs 60.37 cr to the party.
- Donations from corporates formed 87.28% of total donations declared by BJP.
- 146 donations from corporate/business sectors amounting to Rs 35.89 cr were made to INC while 931 individual donors donated Rs 38.634 cr to the party.
- Donations from corporates formed 48.16% of total donations declared by INC.




V. State-wise donations to National Parties, FY 2020-21

- Segregation of donations according to State** was made by ADR based on the address provided by the parties in their donations report to the ECI.
- Donations declared by the National parties contained details of **donations received from 28 States/Union Territories/ common capitals**. Please refer to **Annexure – 2** for more details.
- A total of **Rs 246.502 cr** was donated to the National parties from **Delhi**, followed by **Rs 71.681 cr** from **Maharashtra** and **Rs 47.071 cr** from **Gujarat**.
- A total of **Rs 37.912 cr**, (6.39% of total donations received by the National parties, FY 2020-21), could not be attributed to any State/ Union Territory due to **Incomplete/Undeclared address** provided by the parties.
- Of the donations from **corporate houses**, **Rs 30.237 cr** could **not be segregated** into donations from various states.

- f) **Corporate/ Business houses** from **Delhi** donated **Rs 228.354 cr** while those from **Maharashtra** gave **Rs 61.79 cr**.




VI. Incomplete disclosure of information in the donations report

- a) Of the 8 National parties, 5 parties namely BJP, INC, CPM, CPI and NPEP had **not declared PAN details of 171 donations** through which the parties collected a total of **Rs 2.746 cr**.
- b) **BJP** collected **Rs 1.2846 cr** from **96 donations** but failed to provide PAN details of donors. **NPEP** collected **Rs 55.15 lakhs** from **13 donations** and **CPI** collected **Rs 44.00 lakhs** from **42 donations** without PAN. **3 donations** to **CPM** (**Rs 27.50 lakhs**) and **17 donations** from **INC** (**Rs 19.50 lakhs**) do **not have PAN details**.
- c) Four National parties (BJP, INC, NCP and CPM) have declared **43 donations** of **Rs 6.095 cr** having **missing/incorrect PAN** details for FY 2020-21.

- d) **INC** declared **Rs 5.43 cr** from **25** donations with missing/incorrect PAN details of donors. **BJP** collected **Rs 63.50 lakhs** from **14** donations without complete PAN, **3 donations** of **CPM (Rs 2 lakhs)** and **1 donation** of **NCP (Rs 1 lakh)** do not have complete PAN details.

VII. Top donors to National Parties

- Of the total donations of **Rs 593.748 cr**, the **top 2 donors of every National party** combined, donated a sum of **Rs 265.904 cr** which forms **44.78%** of the parties' overall donations above Rs 20,000 during FY 2020-21.
- Prudent Electoral Trust** donated a total of **Rs 216.00 cr** to **BJP, NCP and INC** combined and it is top two donors of BJP and NCP. The Trust donated **Rs 209 cr** to BJP (43.766% of total funds received by the party), **Rs 5 cr** to NCP (19.04% of total funds received by the party) and **Rs 2 cr** to INC (2.68% of total funds received by the party).
- BJP has received **Rs 20 cr** each donation from **IRB Infrastructure Developers Ltd and Modern Road Makers Pvt Ltd**.
