## Analysis of Election Expenditure Statements of MLAs

### Haryana Assembly Elections, 2014

**According to Section 78 of the Representation of the People Act, 1951, every contesting Winner has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories.** Haryana Election Watch and Association for Democratic Reforms (ADR) have analyzed election expenditure statements of 85 out of 90 sitting MLAs.

#### **List of MLAs whose expenditure statements were not analysed**

These expenditure statements were not analysed due to the non-availability of the statements on the CEO Websites at the time of the making of the report.

This analysis is based on the election expenditure statement submitted by the MLAs after the 2014 Assembly elections and bye elections conducted thereafter.

The expenditure limit for the MLAs during the Haryana Assembly elections was Rs.28 lakhs. These election expense documents include *details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.*

#### Recommendations:

1. **It is recommended that the Abstract Expenditure Statement (Annexure 15) of the MLAs is uploaded on the website of the CEO within 72 hours of the receipt of the statement.**
2. The deadline for filing an election petition against any Winner is 45 days after the declaration of the results. Generally, MLAs submit their election expenditure statements towards the end of the 30 days given for submission of the statements. This leaves 15 days for any common citizen to file an election petition against any Winner. The deadline for filing an election petition should be increased in order to give the citizens time to scrutinize the election expenditure statements of the MLAs and gather the relevant documents/proof etc. for the election petition.
3. As has been instated in the filing of affidavits during the elections, the MLAs should not be allowed to keep any field blank on the Abstract Election Expenditure statement (Annexure 15) and Schedule 1 to 9. The statements must be filled in a legible format and overwriting of amounts in the statement should be discouraged.

### Summary and Highlights of Election Expenses of MLAs from the Haryana Assembly 2014 Elections

1. **Less than 50% of the Limit:** Out of 85 MLAs analysed, 55 (65%) MLAs had declared election expenses of less than 50% of the expense limit in their constituency.
2. **Average Election Expenses:** Based on the election expense declarations of 85 MLAs from Haryana Assembly 2014, the average amount of money spent by them in the elections is **Rs12.06 lakhs, which is 43% of the expense limit.**
3. **Party-wise Average Election Expenses:** The party wise average election expenses shows that the average spending for **46 MLAs from BJP** is **Rs. 12.91 lakhs** (46.1% of the expense limit). For **16 MLAs from INLD**, the average election expenditure is **Rs. 10.31 lakhs** (36.8% of the

expense limit), the average election expenditure for **14 MLAs** from **INC** is **Rs.11.79 lakhs** (42.1% of the expense limit) and **5 Independent MLAs** have spent **Rs12.84 lakhs** (45.9% of the expense limit).




Figure 1: Party-wise Average Election Expenses (Rs.in lakhs)




Figure 2: Break Down of Elections Expenses Incurred by MLAs

**3. Expense on Public Meeting, Rally, and Processions with Star Campaigners:** Out of the 85 MLAs analyzed, **31(36%)** MLAs have declared that **they have not spent any amount on** public meetings, processions etc. with star campaigners.

4. **Expense on Public Meeting, Rally, and Processions without Star Campaigners:** Out of the 85 MLAs analyzed, **15 (18%)** MLAs have declared that **they have not spent any amount on** public meetings, processions etc. without star campaigners.
5. **Expense on Campaigning through electronic/print media:** **11 (13%)** MLAs have declared that they have **not spent any amount on** campaigning through electronic/print media.
6. **Expense on Campaign Workers:** **41 (48%)** MLAs have declared that they **have not spent any amount on campaign workers.**
7. **Expense on Campaign Materials.: 8 (9%)** MLAs have declared that they **have not spent any amount on campaign materials.**




Figure 3: Party-wise Average Expenses on Public Meetings, Processions etc. with Star Campaigners (Rs. in lakhs)




Figure 4: Party-wise Average Expenses on Public Meetings, Processions etc. without Star Campaigners (Rs.in lakhs)




Figure 5: Party-wise Average Expenses on Campaign Materials (Rs. in lakhs)




Figure 6: Party-wise Average Expenses on Electronic Media (Rs. in lakhss)




Figure 7: Party-wise Average Expenses on Campaign Vehicles (Rs. in lakhs)




Figure 8: Party-wise Average Expenses on Campaign Workers (Rs. in lakhs)
