Analysis of Election Expenditure Statements of MLAs Tripura Assembly Elections, 2018

According to Section 78 of the Representation of the People Act, 1951, every contesting Winner has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories. Tripura Election Watch and Association for Democratic Reforms (ADR) have analyzed all 60 election expenditure statements submitted after the Tripura 2018 Assembly for newly elected MLAs. The expenditure limit for the Winners during the Tripura Assembly elections was Rs. 20 lakhs. These election expenses documents include details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.

Recommendations:

- 1. Each Winner is required to file his election expenditure statement within 30 days of the results of the elections, the deadline in case of the Tripura Assembly Elections being the 3rd April, 2018. It is recommended that the Abstract Expenditure Statement (Annexure 15) of the Winners is uploaded on the website of the CEO within 72 hours of the receipt of the statement.
- 2. The deadline for filing an election petition against any Winner is 45 days after the declaration of the results. Generally, Winners submit their election expenditure statements towards the end of the 30 days given for submission of the statements. This leaves 15 days for any common citizen to file an election petition against any Winner. The deadline for filing an election petition should be increased in order to give the citizens time to scrutinize the election expenditure statements of the Winners and gather the relevant documents/proof etc. for the election petition.
- 3. As has been instated in the filing of affidavits during the elections, the Winners should not be allowed to keep any field blank on the Abstract Election Expenditure statement (Annexure 15) and Schedule 1 to 9. The statements must be filled in a legible format and overwriting of amounts in the statement should be discouraged.

Summary and Highlights of Election Expenses of MLAs from the Tripura Assembly 2018 Elections

- 1. Less than 50% of the Limit: Out of 60 MLAs analyzed, 25(42%) MLAs have declared election expenses of less than 50% of the expense limit in their constituency.
- 2. <u>Average Election Expenses</u>: Based on the election expense declarations of 60 MLAs from Tripura Assembly, the average amount of money spent by them in the elections is **Rs 11.25 lakhs, which is 56% of the expense limit**.
- Party-wise Average Election Expenses: The party wise average election expenses shows that the average spending for 36 MLAs from BJP is Rs 12.96 lakhs (64.8% of the expense limit). For 16 MLAs from CPI(M), the average election expenditure is Rs 7.68 lakhs (38.4% of the expense limit) and for 8 IPFT MLAs, the average election expenditure is Rs 10.69 Lakhs (53.5% of the expense limit).




Figure 1: Party-wise Average Election Expenses (Rs. in lakhs)








Figure 2: Break Down of Elections Expenses Incurred by MLAs

- 3. <u>Expense on Public Meeting, Rally, and Processions with Star Campaigners</u>: Out of the 60 MLAs analyzed, **10 (17%) MLAs** have declared that **they have not spent any amount on** public meetings, processions etc. with star campaigners.
- 4. <u>Expense on Public Meeting, Rally, and Processions without Star Campaigners:</u> Out of the 60 MLAs analyzed, none of the MLAs have declared that they have not spent any amount on public meetings, processions etc. without star campaigners.
- 5. <u>Expense on Campaigning through electronic/print media</u>: 53(88%) MLAs have declared that they have not spent any amount on campaigning through electronic/print media.
- 6. *Expense on Campaign Workers:* 30 (50%) MLAs have declared that they have not spent any amount on campaign workers.
- 7. *Expense on Campaign Materials.*: 35 (58%) MLAs have declared that they have not spent any amount on campaign materials.
- 8. *Expense on Campaign Vehicles.:* 7 (12%) MLAs have declared that they have not spent any amount on campaign vehicles.




Figure 4: Party-wise Average Expenses on Public Meetings, Processions etc. without Star Campaigners (Rs. in lakhs)




Figure 5: Party-wise Average Expenses on Campaign Materials (Rs. in lakhs)




Figure 6: Party-wise Average Expenses on Electronic Media (Rs. in Thousands)





Figure 7: Party-wise Average Expenses on Campaign Vehicles (Rs. in lakhs)

- 1. <u>Percentage break-down of funds received by MLAs:</u> Out of the total funds received by MLAs, 94% funds were raised from political parties, 4% were raised by MLAs themselves and 2% funds were raised from other sources.
- 2. <u>MLAs Who Raised Funds from Political Parties</u>: Out of the 60 MLAs analyzed, none of the MLAs have declared that they have not received any funds from political parties.
- 3. <u>MLAs Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:</u> Out of the 60 MLAs analyzed, **50(83%) MLAs** have declared that **they have not received any funds from** *any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.*
- 4. <u>Self-funds used for election campaign</u>: Out of the 60 MLAs analyzed, 27 (45%) MLAs have declared that they have not used any of their own funds for their election campaign.





- <u>Average funds raised from Political Parties (Party-wise)</u>: On an average a MLA from BJP raised 94%, a MLA from CPI(M) raised 99.83% and on an average a MLA from IPFT raised 81% of his/her election expense funds from the political party.
- 6. <u>Average funds raised through any person/company/firm/associations/body of persons etc as loan, gift or donation etc</u> (<u>Party-wise</u>): On an average a MLA from **BJP** raised **2%** of his/her election expense funds from any person/company/firm/associations/body of persons etc. as loan, gift or donation and **8 IPFT** MLAs raised on an average **7%** of their expense funds from any person/ company/ firm/ associations/ body of persons etc. as loan, gift or donation.




Figure 10: Break-down of Election Expenses Incurred by Ministers





- 1. <u>Less than 50% of the Limit</u>: Based on the election expense declarations of all 9 Ministers analysed from Tripura Assembly 2018, 3(33%) have declared election expenses of less than 50% of the expense limit in their constituency.
- 2. <u>Average Election Expenditure</u>: Based on the election expense declarations of all 9 Ministers from Tripura Assembly 2018, the average amount of money spent by them in the elections is about Rs 12.13 lakhs, which is 61% of the expense limit.
- 3. <u>Top 3 Ministers with highest Election Expenditure:</u> The details of top 3 ministers with highest election expenditure are given below:




Figure 11: Percentage Break-down of Funds Raised by Ministers

- 1. <u>Percentage break-down of funds received by Ministers:</u> Out of the total funds received by Ministers, 82% funds were raised from political parties, 15% were raised by Ministers themselves and 3% funds were raised from other sources.
- 2. <u>Ministers Who Raised Funds from Political Party</u>: Out of the 9 Ministers analyzed, none of the Ministers have declared that they have not received any funds from political parties.
- 3. <u>Ministers Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation</u> <u>etc:</u> Out of the 9 Ministers analyzed, 5 Ministers have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.
