असम इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने असम विधानसभा उपचुनाव में चुनाव लड़ने वाले सभी **31** उम्मीदवारों के शपथपत्रों का विश्लेषण किया। 5 निर्वाचन क्षेत्रों भवानीपुर, तमुलपुर, गोसाईगांव, थौरा और मरिआनी में उपचुनाव की मतदान तिथि 30 अक्टूबर 2021 है।

- ☞ 5 (16 प्रतिशत) उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। इनमें से 4 (13 प्रतिशत) उम्मीदवार ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।
- ☞ 9 (29 प्रतिशत) करोड़पति उम्मीदवार हैं।
- ☞ असम विधानसभा उपचुनाव में चुनाव लड़ने वाले उम्मीदवारों की औसतन संपत्ति ₹ 1.35 करोड़ है।
- ☞ 8 उम्मीदवारों ने अपनी देनदारी घोषित की है।
- ☞ असम विधानसभा उपचुनाव में सभी 31 पुरुष उम्मीदवार हैं, कोई भी महिला उम्मीदवार नहीं है।
