Assam 2011 Assembly Elections

Assam Assembly Elections, 2011 was held on April, 2011. This report includes the analysis of criminal, financial, education, PAN availability, IT, age, gender and other background information of contested candidates and MLAs. Information provided by the Election Commission of India and details from the affidavits filed by the candidates have been used for the analysis.

Representation of political parties

In Assam 2006 Assembly Elections, 31 political parties (including independent) contested which decreased to 27 in Assam 2011 Assembly Elections. This reflects a decline of 13% in the number of political parties contesting election from Assam 2006 Assembly Elections to Assam 2011 Assembly Elections.

Growth in number of candidates

Out of 981 candidates contesting in 2011 Assembly Elections, there were 896 (91%) men and 85 (9%) women candidates. In 2006, out of 997 candidates contested, 927 were men (93%) while 70 (7%) were women. Hence, the percentage of men has decreased by 2% while the percentage of women candidates has increased from 2006 Assembly Elections to 2011 Assembly Elections.

Executive summary of candidates and MLAs

Summary of candidates

- Assam Election Watch (AEW) has analyzed affidavits of 962 candidates out of 981 candidates who contested 2011 Assembly elections.
- Out of these 962 candidates analyzed, 98 candidates or 10% declared pending criminal cases against them. AIUDF had 18 out of 78 (23%) candidates with pending criminal cases, AGP had 14 out of 104 (14%), AITC had 11 out of 95 (12%), BJP had 9 out of 120 (8%) and INC had 9 out of 126 (7%) candidates with pending criminal cases.
- Out of these 98 candidates with pending criminal cases, 37 (4%) had pending serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc. against them.
- All major parties have given tickets to candidates with pending criminal cases, AIUDF – 23%, AGP – 14%, AITC – 12%, BJP – 8% and INC – 7%.
- There were a total of 5 red alert constituencies (i.e. where 3 or more contesting candidates had pending criminal cases). Karimganj South had 6 candidates with pending criminal cases followed by Sonai which had 5 candidates with pending criminal cases.
- A total of 115 candidates out of 962 analyzed i.e. 12% were crorepatis.
- A total of 2 candidates out of 962 analyzed declared zero assets.
- A total of 196 candidates out of 962 analyzed declared liabilities above 5 lakhs.

- Among major parties, the average asset per candidate for INC was 1.24 crores, for AIUDF was 1.08 crores, for AGP was 89.75 lakhs, for BPF was 75.22 lakhs and for AITC was 40.46 lakhs.
- 27% of candidates (262 of 962 analyzed) had not furnished their PAN card details.
- A total of 442 candidates (46%) out of 962 candidates analyzed have declared that they have never filed Income Tax returns (ITR).
- Out of the above 442 candidates who have never filed ITR, 259 have not even given their PAN details.
- More than 49% candidates (475 of 962 analyzed) were graduates & above.
- 49 candidates out of the 962 analyzed have declared their age to be less than 30 years while 19 candidates have declared age more than 71 years.
- Number of women candidates was just 85 (9%) as compared to 896 (91%) of men.

Summary of MLAs

- Affidavits of all 126 MLAs were analyzed by Assam Election Watch (AEW).
- Out of 126 MLAs analyzed, 13 (10%) have pending criminal cases against them. Comparing this to Assam 2006 Assembly Elections, out of 126 MLAs analyzed, 7 (6%) had pending criminal cases against them.
- Out of these 13 (10%) MLAs with pending criminal cases, there are pending serious criminal cases against 8 MLAs (6%). Contrasting this with Assam 2006 Assembly, there were 7 MLAs with pending criminal cases, out of which 5 MLAs (4 %) had serious pending criminal cases against them.
- Out of 13 MLAs with pending criminal cases in Assam 2011 Assembly, 6 MLAs are from AIUDF, 4 from INC and 1 each from AGP, BJP and AITC.
- MLAs with pending criminal cases have increased from 7 in Assam Assembly 2006 to 13 in Assam Assembly, 2011.
- There are a total of 15 IPC charges of heinous nature on the MLAs. These included kidnapping, extortion, etc.
- The number of crorepati MLAs has increased from 16 (12%) in Assam 2006 Assembly Elections to 47 (37%) in Assam Assembly, 2011.
- Out of 47 crorepati MLAs in Assam 2011 Assembly, 31 from INC, 6 from AGP, 4 from BPF, 3 from AIUDF and 1 each from BJP and AITC.
- Among major parties, the average asset per MLA for AIUDF is Rs. 3 crores, for AGP is Rs 2.22 crores, and for INC is Rs. 1 crores.
- Average asset for a MLA from Assam is Rs 1.65 crores.
- Out of 126 MLAs analyzed, 9 had not declared their PAN details.
- A total of 20 MLAs (16%) out of 126 MLAs have declared that they have never filed Income Tax returns.
- Out of the above 20 MLAs who have never filed ITR, 9 have not even given their PAN details.
- Out of 85 women candidates contested, only 14 won. Hence only 11% of MLAs in current Assam Assembly are women.
- A total of 90 (71%) MLAs (out of 126 analyzed) in Assam 2011 Assembly Election are graduates/graduate professionals.
- 2 MLAs out of the 126 analyzed have declared their age to be less than 30 years while 13 MLAs have declared age more than 71 years.

Analysis based on pending criminal cases

Analysis based on pending criminal cases- candidates

A total of 962 affidavits were analyzed by Assam Election Watch (AEW) for 2011 Assembly Elections. Out of these 962 candidates, 98 or 10% declared pending criminal cases against them. Out of these 98 candidates with pending criminal cases, 37 had pending serious criminal cases like kidnapping, robbery, extortion etc. pending against them.

Party-wise break up of candidates with pending criminal cases

A total of 98 candidates contesting elections from Assam had pending criminal cases against them. 18(23%) out of 78 candidates analyzed of AIUDF, 14 (14%) out of 104 from AGP, 11 (12%) out of 95 of AITC, 9 (7%) candidates out of 126 of INC and 9 (8%) out of 120 candidates of BJP had pending criminal cases against them. The party wise break up is given below:

Party-wise comparison of pending criminal cases on candidates in Assam Assembly Elections 2006 vs 2011

A comparison between candidates with pending criminal cases in Assam 2006 and 2011 Assembly Elections held in 2006 and 2011 respectively shows that for major parties like INC, AGP, AIUDF and NCP the number of candidates with pending criminal cases has increased in 2011 elections as compared to the 2006 Assembly Elections.

Top 20 candidates with serious pending criminal cases

The table below lists top 20 candidates with most serious pending criminal cases. Almost all of them had pending criminal cases of murder, attempt to murder, kidnapping, theft, dacoity etc against them. Kushal Dowari an IND candidate from Thowra constituency in Assam had 7 serious IPC counts including

murder, attempt to murder etc. pending against him. Out of these 20 candidates with most serious pending criminal cases, only 6 won while the rest 14 lost. Detailed list is given below.

Tainted constituency analysis

There are 66 constituencies where in at least one tainted candidate (i.e candidate having pending criminal cases) contested. As the following analysis shows, **if voters have a choice, they prefer a clean and capable candidate**. In the constituencies where there was only one candidate with pending criminal cases, voters choose 89% of the clean candidates and rejected most of the candidates with pending criminal cases. In the constituencies where there were two candidates with pending criminal cases, voters choose 63% of the clean candidates.

Difference in asset between the highest asset candidate and the final winner

As can be seen from the table below, there are some constituencies where the assets of candidates did not seem to matter. The criterion for choosing a candidate by voters was something other than money. In about 59 (47%) constituencies out of 126 in Assam 2011 Elections, the winner did not have highest assets candidate. Hence in these constituencies, money does not play a significant role in winnability factor of the candidate. The table below provides the increase in assets of re-elected MLAs who contested and won both 2006 and 2011 elections. In Rupees, the maximum growth in assets has been for Sri Padma Hazarika of AGP. His assets have grown by over 4.16 Crore. He is followed by Sri Tarun Gogoi of INC (asset growth of over 4.03 Crore) and Pradyut Bordoloi of INC (asset growth of over 2.41 Crore).

In percentage terms, the maximum percentage increase is in the total assets of Dr. Rumi Nath of INC from Barkhola constituency. His assets have grown by 2239%. He is followed by Maneswar Brahma of BPF from Barama constituency with a growth of 2118% in his assets and Bibekananda Dalai INC from Jagiroad with a growth of 1861% in his assets.

Background on Association for Democratic Reforms (ADR) and National Election Watch (NEW)

About ADR & NEW

Association for Democratic Reforms (ADR) was established in 1999 by group of professors from Indian Institute of Management (IIM) Ahmedabad. In 1999, a Public Interest Litigation (PIL) was filed by them with Delhi High Court asking the disclosure of criminal, financial and educational background of the candidates contesting elections. Based on this, the Supreme Court in 2002 and subsequently in 2003, made it mandatory for all candidates contesting elections to disclose Criminal, Financial and educational background prior to the polls by filing an affidavit with Election Commission.

The first election watch was conducted by ADR in 2002 for Gujarat Assembly Elections whereby detailed analysis of the backgrounds of candidates contesting elections was provided to the electorate in order to help the electorate make an informed choice during polls. Since then ADR has conducted Election Watches for almost all state and parliament elections in collaboration with the National Election Watch. It conducts multiple projects aimed at increasing transparency and accountability in the political and electoral system of the country.

Our Achievements

- ADR won the NASSCOM award for ICT led Innovation by Multi-stakeholder Partnerships. This award was for the Election Watch software of ADR and Webrosoft.
- ADR won two milestone judgments on disclosure of candidate's criminal and financial records from the Supreme Court in May 2002 and March 2003 respectively. Since then, 1200 NGOs from all over the country are supporting ADR and ADR in partnership with its partners has organized Citizen Election Watch for all major elections and disclosed candidate's background information to the media and the public.
- The Election Commission has completed a massive exercise based on the Gujarat Election Watch report to verify information filed by candidates in the nomination papers and affidavits, and has started proceedings against candidates with false declarations.
- A Bill on Electoral Expenses was passed in September 2003. The EC has asked candidates to file a statement of expenses in every three days during the campaign. This information is made available to citizens on request to Returning Officers, District Election Officers and the CEOs.
- Civil Society non-partisan Election Watches are springing up in different states. In the Lok Sabha 2004 Elections, 19 States and 5 Union Territories carried out Election Watches. In the Lok Sabha 2009 elections, Election Watches were held in all states and union territories in the country.
- Bihar Election Watch in October-November 2005 resulted in intense pressure on the Chief Minister designate due to the extensive media coverage of candidate's background. As a result, for the first time, Bihar has a Council of Ministers without any known criminal record.

- The Election Commission inaugurated Civil Society led National Conferences on Electoral Reforms in Ahmedabad, Bangalore, Patna, Lucknow, Mumbai, Bhopal and Chennai. These Conferences were action oriented and resulted in successful Election Watch campaigns.
- The EC issued several very significant orders in the last two years relating to candidate disclosure, ensuring those affidavits are complete, taking action against false affidavits based on complaints, and disclosing electoral expenses.
- In April 2008, ADR obtained a landmark ruling from the Central Information Commission (CIC) saying that Income Tax Returns of Political Parties would now be available in the public domain along with the assessment orders.
- In the Karnataka Assembly Elections, 2008, there was a reduction in the number of candidates with serious offenses put up by parties. There were 93 such cases against candidates in the 2008 elections, down from 217 in the 2004 assembly elections.
- Overall, the percentage of candidates with pending criminal cases came down from 20% to 14% in the assembly elections held in the country in 2008 for the states of Rajasthan, Chhattisgarh, Madhya Pradesh, NCT of Delhi and Mizoram.
- A large number of candidates with serious pending cases that contested Lok Sabha 2009 elections like Pappu Yadav, Atiq Ahmed, Mukhtar Ansari, Akhilesh Singh, etc. lost.
- The number of total serious IPC sections against MPs decrease from 296 in Lok Sabha 2004 to 274 in Lok Sabha 2009.
- On Jan 25, 2010 both the Congress Chief Ms Sonia Gandhi and leader of opposition in Lok Sabha Ms Sushma Swaraj of BJP made public statements calling for a consensus on barring candidates with criminal backgrounds from contesting elections.
- On Feb 3, 2010 Prime Minister Manmohan Singh asked his Cabinet colleagues to disclose details of their assets and liabilities and refrain from dealing with the government on immovable property.
- Because of an RTI application that ADR has been following up with the CIC for nearly the past 2 years, the contribution reports of major political parties have been made public. Added to this is the fact that the Election Commission has taken proactive steps towards bringing in some level of accountability in the functioning of the political parties by getting the ICAI to develop reporting formats for political parties
- In May, 2010, the Chief Minister of Uttar Pradesh, Ms. Mayawati had announced the expulsion of about 500 party leaders with criminal past.
- In January 2011, the Election Commission of India entrusted the Institute of Chartered Accountants of India (ICAI) with the task of developing accounting format for political parties.
- Details of the movable and immovable assets of 30 Bihar ministers, including that of CM Nitish Kumar, were uploaded on the government website in January, 2011. It is seen as a step aimed at ending corruption promised by the Chief Minister himself.
