Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of all **88** winners out of **90** who had contested in the **23** multi member **wards** of the **Bhiwandi-Nizampur Municipal Corporation** Elections, held on **24th May, 2017**. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

Criminal Background

- **Winners with Criminal Cases:** **27 (31%)** out of **88** analyzed winners have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** **21 (24%)** out of **88** analyzed winners have declared serious criminal cases against themselves like **murder, attempt to murder, kidnapping, criminal intimidation, assault or criminal force to woman with intent to outrage her modesty, theft, cheating, forgery, etc.**
- **Party wise Winners with declared Criminal Cases:** **16 (34%)** out of 47 winners from **Indian National Congress (INC)**, **5 (26%)** out of 19 winners from **Bhartiya Janta Party (BJP)** and **4 (33%)** out of 12 winners from **Shivsena** have declared criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. *Offence for which maximum punishment is of 5 years or more.*
2. *If an offence is non-bailable*
3. *If it is an electoral offence (for eg. IPC 171E or bribery)*
4. *Offence related to loss to exchequer*
5. *Offences that are assault, murder, kidnap, rape related*
6. *Offences that are mentioned in Representation of the People Act (Section 8)*
7. *Offences under Prevention of Corruption Act*
8. *Crimes against women.*

- Party wise Winners with declared Serious Criminal Cases:** 10 (21%) out of 47 winners from Indian National Congress (INC), 5 (26%) out of 19 winners from Bhartiya Janta Party (BJP) and 4 (33%) out of 12 winners from Shivsena have declared serious criminal cases against themselves in their affidavits.

- Party wise Crorepati Winners:** 14 (30%) out of 47 winners analysed from Indian National Congress (INC), 12 (63%) out of 19 winners analysed from Bhartiya Janata Party (BJP), 11 (92%) out of 12 winners analysed from Shivsena, 3 (100%) out of 3 winners analysed from Konark Vikas Agadhi and 2 (100%) out of 2 winners analysed from Samajwadi Party, are Crorepati.






