रिपोर्ट के मुख्य अंश

मंत्रिमंडल के विस्तार के फलस्वरूप, बिहार इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने बिहार राज्य विधानसभा 2020 से मुख्यमंत्री सहित 31 में से 28 मंत्रियों के शपथपत्रों का विश्लेषण किया। **BJP** के एक मंत्री **राम सूरत कुमार** का शपथपत्र स्पष्ट ना होने के कारण उनका विश्लेषण नहीं किया गया है। अशोक चौधरी और जनक राम के विवरण का विश्लेषण नहीं किया गया था क्योंकि वे वर्तमान में दोनों सदन राज्य विधानसभा या विधान परिषद के सदस्य नहीं हैं।

यह जानकारी 2020 बिहार विधानसभा चुनाव और बिहार विधान परिषद चुनाव से पहले उम्मीदवारों द्वारा प्रस्तुत शपथपत्रों पर आधारित हैं।

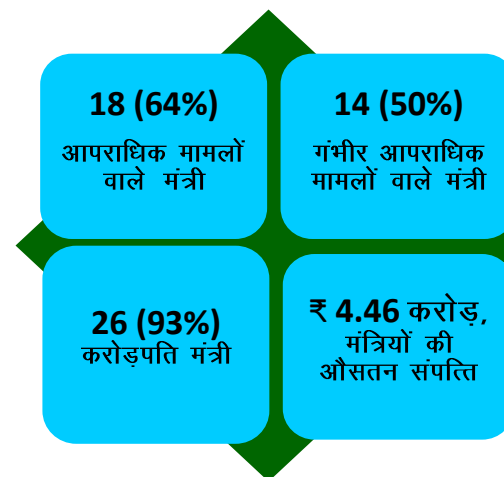

☞ **सबसे कम संपत्ति वाले मंत्री:** सबसे कम संपत्ति घोषित करने वाले मंत्रियों में निर्वाचन क्षेत्र चैनपुर से मोहम्मद जमा खान ने सबसे कम संपत्ति ₹ 30.04 लाख घोषित की हैं।

☞ **देनदारी घोषित करने वाले मंत्री:** कुल 20 मंत्रियों ने अपनी देनदारी घोषित की है, जिसमें मुकेश सहनी बिहार विधानसभा चुनाव से निर्वाचित हुए हैं, जिन्होंने ₹ 1.54 करोड़ के साथ सबसे ज्यादा देनदारी घोषित हैं।

- ☞ **शैक्षिक योग्यता:** 11 (39 प्रतिशत) मंत्रियों ने अपनी शैक्षिक योग्यता 8वीं और 12वीं के बीच घोषित की है, जबकि 16 (57 प्रतिशत) मंत्रियों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज्यादा घोषित की हैं और एक मंत्री सैयद शाहनवाज हुसैन ने अपनी शैक्षिक योग्यता इलेक्ट्रॉनिक्स में राष्ट्रीय व्यापार प्रमाण पत्र में डिप्लोमा घोषित की हैं।
- ☞ **मंत्रियों की आयु:** 11 (39 प्रतिशत) मंत्रियों ने अपनी आयु 35 से 50 वर्ष के बीच घोषित की है, जबकि 17 (61 प्रतिशत) मंत्रियों ने अपनी आयु 51 से 75 वर्ष के बीच घोषित की हैं।
