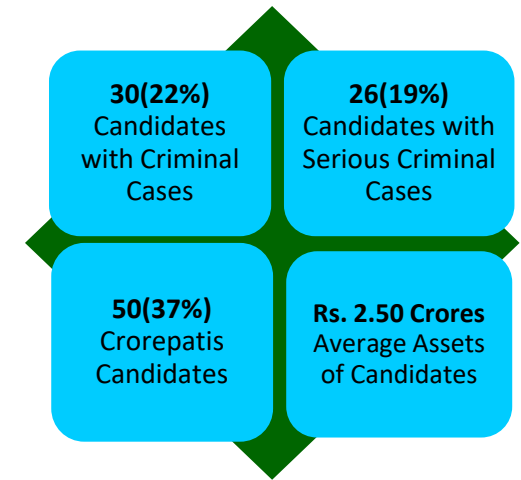

## Summary and Highlights

**Bihar Election Watch and Association for Democratic Reforms (ADR)** have analysed the self-sworn affidavits of all **134** candidates, who are contesting in the **8 constituencies in Bihar Phase-VII Lok Sabha elections 2024**.

### Criminal Background

- **Candidates with Criminal Cases:** Out of 134 candidates analyzed, 30 (22%) candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** 26(19%) candidates have declared serious criminal cases against themselves.
- **Candidates with cases related to Attempt to Murder:** 10 candidates have declared cases related to attempt to murder (IPC Section 307) against themselves.
- **Candidates with cases related to Crime Against Women:** 4 candidates have declared cases related to crime against women. Out of 4 candidates 1 candidate has declared charge related to **Whoever commits rape repeatedly on the same woman, shall be punished with rigorous imprisonment for a term which shall not be less than ten years, but may extend to imprisonment (IPC Section-376(2)(n)).**

#### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
