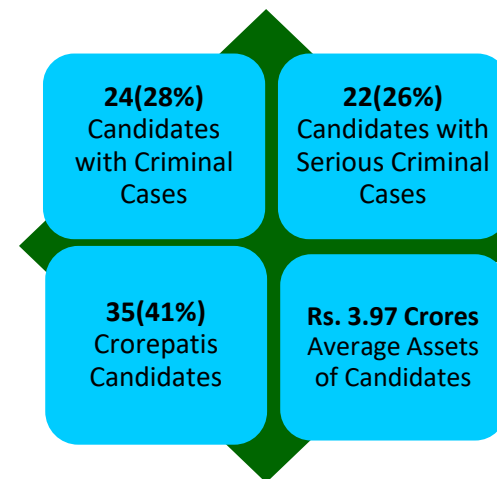

## Summary and Highlights

**Bihar Election Watch** and **Association for Democratic Reforms (ADR)** have analysed the self-sworn affidavits of **85** out of **86** candidates, who are contesting in the **8 constituencies in Bihar Phase-VI Lok Sabha elections 2024**. One **Independent** candidate namely **Shambhu Prasad** contesting from **Valmiki Nagar** Constituency has not been analysed due to the unavailability of his clear and complete affidavit on the ECI website at the time of making this report.

## Criminal Background

- **Candidates with Criminal Cases:** Out of 85 candidates analyzed, **24 (28%)** candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **22(26%)** candidates have declared serious criminal cases against themselves.
- **Candidates with cases related to Murder:** **4** candidates have declared cases related to **murder (IPC Section - 302)** against themselves.
- **Candidates with cases related to Attempt to Murder:** **3** candidates have declared cases related to **attempt to murder (IPC Section 307)** against themselves.

### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
