DETAILED ANALYSIS – BIHAR LOK SABHA PHASE 7

Summary and Highlights

The **Bihar Election Watch** and **Association for Democratic Reforms (ADR)** have analysed the self-sworn affidavits of **153** out of **157** candidates, who are contesting in the following constituencies in the **Bihar Phase VII Lok Sabha Elections 2019**.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
