Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of 358 out of 374 candidates who are contesting for 84 seats in the 21 multiple member wards for the Malegaon Municipal Corporation Elections, being held on 24th May, 2017 in Maharashtra. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

Criminal Background

- **Candidates with declared criminal cases:** 54 (15%) out of 358 candidates analyzed have declared criminal cases against themselves.
- **Candidates with declared serious criminal cases:** 37 (10%) out of 358 candidates analyzed have declared serious criminal cases against themselves.
- **Party wise candidates with declared criminal cases:** 15 (24%) out of 62 candidates from Indian National Congress (INC), 8(14%) out of 56 candidates from Bhartiya Janta Party (BJP), 8 (16%) out of 51 candidates from Nationalist Congress Party (NCP), 7 (21%) out of 34 candidates from All India Majlis –e- Ittehadul Muslimeen (AIMIM), 2 (8%) out of 26 candidates from Shivsena, 2 (20%) out of 10 candidates from Janta Dal Secular and 12(12%) out of 99 Independent candidates have declared criminal cases against themselves.
- **Party wise candidates with declared serious criminal cases:** 12(19%) out of 62 candidates from Indian National Congress (INC), 6(12%) out of 51 candidates from Nationalist Congress Party (NCP), 4(7%) out of 56 candidates from Bhartiya Janta Party (BJP), 6(18%) out of 34 candidates from All India Majlis –e- Ittehadul Muslimeen (AIMIM), 2(20%) out of 10 candidates from Janta Dal Secular, 1(4%) out of 26 candidates from Shivsena and 6(6%) out of 99 Independent candidates have declared serious criminal cases against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
