## Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of 476 candidates out of 579 who are contesting for the Akola Municipal Corporation Elections, scheduled to be held on 21<sup>st</sup> February, 2017. There are total 80 seats spread across 20 wards, each ward will elect 4 members. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

### Criminal Background

- **Candidates with Criminal Cases:** 59 (12%) out of 476 analyzed candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** 51 (11%) out of 476 analyzed candidates have declared serious criminal cases against themselves like murder, attempt to murder, criminal intimidation, robbery and dacoity, etc.
- **Party wise Candidates with declared Criminal Cases:** 11 (19%) out of 58 candidates analysed from NCP, 7 (15%) out of 47 candidate analysed from BJP, 6 (12%) out of 50 candidate analysed from SHS, 2 (13%) out of 15 candidate analysed from MNS and 7 (12%) out of 60 candidates analysed from INC have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with declared Serious Criminal Cases:** 10 (17%) out of 58 candidates analysed from NCP, 6 (13%) out of 47 candidate analysed from BJP, 7 (12%) out of 60 candidate analysed from INC, 4 (8%) out of 50 candidate analysed from SHS and 1 (7%) out of 15 candidates analysed from MNS have declared serious criminal cases against themselves in their affidavits.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
