Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of 5 candidates who are contesting for the **Palghar (ST)** seat in the **Maharashtra Legislative Assembly Bye- Election of 2016**.

Criminal Background

- **Candidates with Criminal Cases:** Out of the 5 candidates analysed, **1 (20%)** candidate has declared criminal cases against her.

- **Candidates with Serious Criminal Cases:** Out of the 5 candidates, **1 (20%)** candidate has declared serious criminal cases.

- **Party wise Candidates with declared Criminal Cases:**

1 (100%) out of 1 candidate analysed from **Bahujan Vikas Aagadhi** has declared **criminal cases** against herself in her affidavit.

- **Party wise Candidates with declared Serious Criminal Cases:** **1 (100%)** out of 1 candidate analysed from **Bahujan Vikas Aagadhi** has declared **serious criminal cases** against herself in her affidavit.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Crorepati Candidates:** Out of the 5 candidates analysed, 2 (40%) are crorepatis.
- **Party-wise Crorepati Candidates:** 1 (100%) out of 1 candidate analysed from Bahujan Vikas Aaghadi and 1 (100%) out of 1 candidate analysed from INC are crorepatis.

- **Average Assets:** The average assets per candidate analysed for the Palghar (ST) Legislative Assembly Bye–Election 2016 is **Rs. 3.27 crores**.
- **Party-wise Average Assets:** Among major parties, the average assets per candidate for 1 analysed Bahujan Vikas Aaghadi candidate is **Rs 8.30 crores**, 1 analysed INC candidate has average assets of **Rs.7.45 crores**, 1 analysed Shiv Sena candidate has average assets of **Rs. 39 lacs**, 1 analysed Bahujan Mukti Party candidate has average assets of **Rs. 23 lacs** and 1 CPI (M) candidate has average assets of **Rs. 55 thousands** only.


