## Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **446** candidates out of **460** who are contesting for **66** seats in the **Municipal Corporation Elections of Chandrapur** being held on **19<sup>th</sup> April, 2017** in Maharashtra. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

### Criminal Background

- **Candidates with Criminal Cases:** **35 (8%)** out of **446** analyzed candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **18 (4%)** out of **446** analyzed candidates have declared serious criminal cases against themselves like **attempt to murder, kidnapping, criminal intimidation, assault or criminal force to woman with intent to outrage her modesty, dacoity, robbery, forgery, cheating, etc.**
- **Candidates with cases related to attempt to murder:** Only **1** candidate, viz., **Nitin Devidas Udar**, contesting from **ward 1D** as **Independent** candidate, has declared case related to **attempt to murder** against him, in his affidavit.

#### *Criteria for serious criminal cases*

1. *Offence for which maximum punishment is of 5 years or more.*
2. *If an offence is non-bailable*
3. *If it is an electoral offence (for eg. IPC 171E or bribery)*
4. *Offence related to loss to exchequer*
5. *Offences that are assault, murder, kidnap, rape related*
6. *Offences that are mentioned in Representation of the People Act (Section 8)*
7. *Offences under Prevention of Corruption Act*
8. *Crimes against women.*

- **Candidates with cases related to assault or criminal force to woman with intent to outrage her modesty-** **2** candidates, namely, **Anil Vinod Surpam** contesting from **ward 3B** & **Anil Ramchandra Musale** contesting from **ward 8A**, both belonging to **Indian National Congress (INC)**, have declared cases related to *assault or criminal force to woman with intent to outrage her modesty*.
- **Party wise Candidates with declared Criminal Cases:** **3 (5%)** out of 65 candidates from **Bhartiya Janata Party (BJP)**, **6 (10%)** out of 62 candidates from **Indian National Congress (INC)**, **6 (11%)** out of 54 candidates from **Shiv Sena** and **1 (3%)** out of 39 candidates from **Nationalist Congress Party (NCP)**, have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with declared Serious Criminal Cases:** **1 (2%)** out of 65 candidates from **Bhartiya Janata Party (BJP)**, **5 (8%)** out of 62 candidates from **Indian National Congress (INC)** and **3 (6%)** out of 54 candidates from **Shiv Sena**, have declared **serious** criminal cases against themselves in their affidavits.

- **Party wise Crorepati Candidates**: **13 (20%)** out of 65 candidates analysed from **Bhartiya Janata Party (BJP)**, **7 (13%)** out of 54 candidates analysed from **Shiv Sena**, **6 (10%)** out of 62 candidates analysed from **Indian National Congress (INC)** and **5 (13%)** out of 39 candidates analysed from **Nationalist Congress Party (NCP)**, are crorepatis.

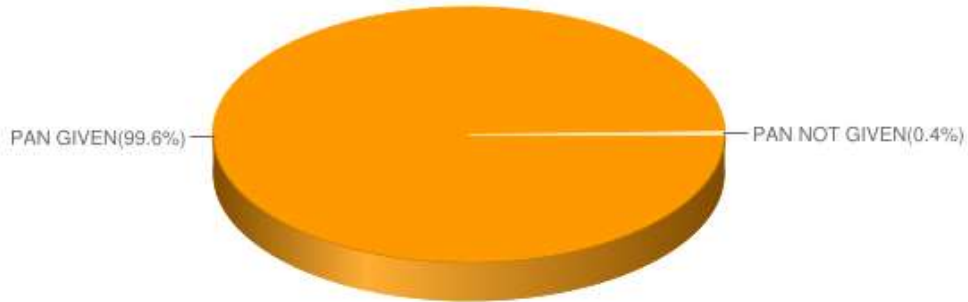
- **Low Assets:** There are **83 (19%)** out of 446 candidates who have declared assets below Rs. **3 lakhs**, in this election.
- **Candidates with high Liabilities:** The candidate with highest declared total liabilities is **Amal Satish Poddar of Bhartiya Janata Party (BJP)**, who is contesting from ward no **4D**, having liabilities of **Rs. 13 Crores+**. However, it is interesting to note that he declared only **Rs. 3.53 Crores** as his total assets. A total of **5 (1%)** out of 446 analysed candidates have declared liabilities of **Rs.50 lakhs and above**. The **top ten** candidates with highest declared liabilities are given below:-

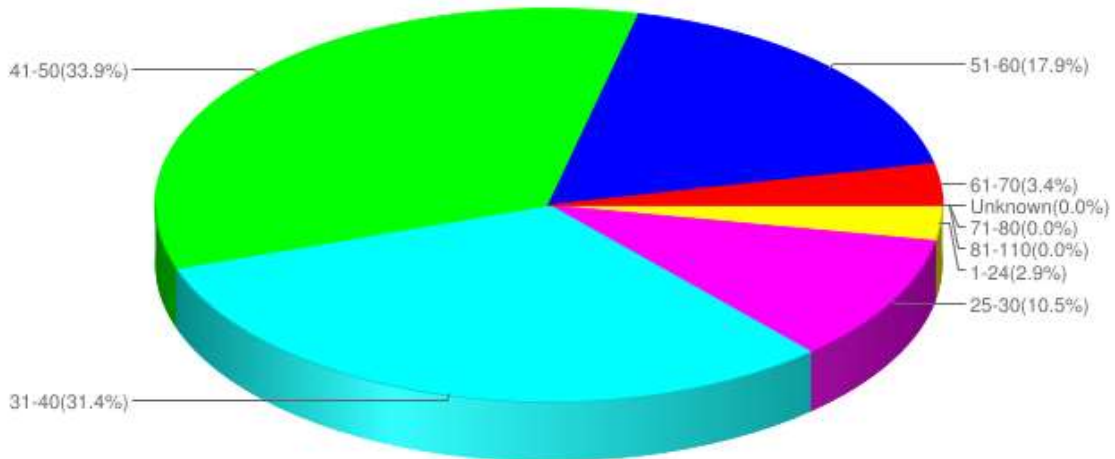

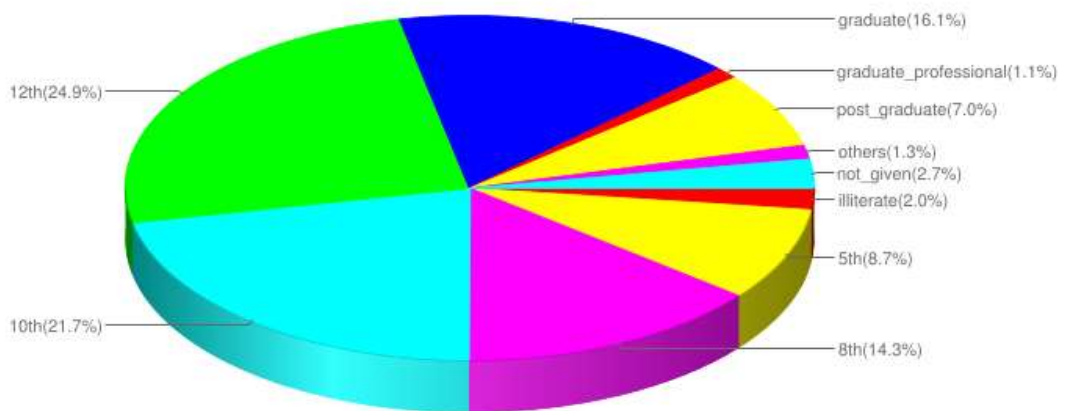

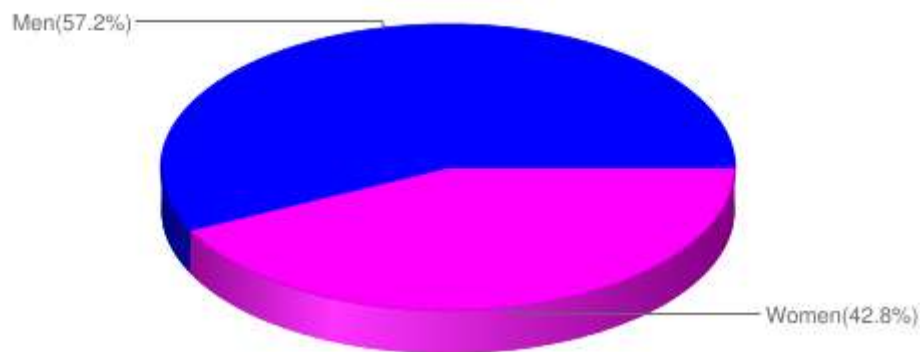
