

Summary and Highlights

The National Election Watch and Association of Democratic Reforms (ADR) have analysed the self-sworn affidavits of **808 out of 822** Winning Candidates in the Union territory of Puducherry and 4 states of Assam, Kerala, Tamil Nadu and West Bengal. **14 Winning Candidates were not analysed due to unclear affidavit available on the ECI website at the time of making this report.**



Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Winning Candidates with Criminal cases: Out of 808 Winning Candidates analysed, **419 (52%)** have declared criminal cases against themselves in their affidavits.

Winning Candidates with serious criminal cases: **241 (30 %)** Winning Candidates have declared serious criminal cases against themselves.

State wise Winning Candidates with self-declared criminal cases




Figure: State wise Percentage of Winning Candidates with criminal cases




Figure: Party wise Percentage of Winning Candidates with criminal cases

Crorepati Winning Candidates: Out of 808 Winning Candidates analysed, 535(66%) are crorepati.




Figure: State Wise Percentage of Crorepati Winning Candidates




Figure: Party Wise Percentage of Crorepati Winning Candidates




Figure: State Wise Average Assets of Winning Candidates




Figure: Analysis of Winning Candidates on the basis of eduational qualification





Figure: Analysis of Winning Candidates on the basis of age groups
