## Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of 245 winners out of 252 who had contested in the 64 multi member wards of the Panvel, Bhiwandi-Nizampur and Malegaon Municipal Corporation Elections, held on 24<sup>th</sup> May, 2017. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

## Criminal Background

- Winners with Criminal Cases:** 62 (25%) out of 245 analyzed winners have declared criminal cases against themselves.
- Winners with Serious Criminal Cases:** 45 (18%) out of 245 analyzed winners have declared serious criminal cases against themselves like **murder, attempt to murder, kidnapping, criminal intimidation, rape, assault or criminal force to woman with intent to outrage her modesty, theft, cheating and forgery, etc.**
- Party wise Winners with declared Criminal Cases:** 24 (30%) out of 79 winners from **Bhartiya Janta Party (BJP)**, 21 (29%) out of 72 winners from **Indian National Congress (INC)**,

### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

**4 (16%)** out of 25 winners from **Shiv Sena**, **2 (9%)** out of 23 winners from **Bhartiya Shetkari Kamgar Paksh** and **3 (14%)** out of 22 winners from **Nationalist Congress Party (NCP)** have declared criminal cases against themselves in their affidavits.

- **Party wise Winners with declared Serious Criminal Cases:** **18 (23%)** out of 79 winners from **Bhartiya Janta Party (BJP)**, **14 (19%)** out of 72 winners from **Indian National Congress (INC)**, **4 (16%)** out of 25 winners from **Shiv Sena**, **1 (4%)** out of 23 winners from **Bhartiya Shetkari Kamgar Paksh** and **1 (5%)** out of 22 winners from **Nationalist Congress Party (NCP)** have declared serious criminal cases against themselves in their affidavits.

- **Municipal Corporation wise Winners with declared Criminal Cases:** **27 (31%)** out of 88 winners from **Bhiwandi-Nizampur Municipal Corporation**, **18 (23%)** out of 79 winners from **Malegaon Municipal Corporation** and **17 (22%)** out of 78 winners from **Panvel Municipal Corporation** have declared criminal cases against themselves in their affidavits.
- **Municipal Corporation wise Winners with declared Serious Criminal Cases:** **21 (24%)** out of 88 winners from **Bhiwandi-Nizampur Municipal Corporation**, **12 (15%)** out of 79 winners from **Malegaon Municipal Corporation** and **12 (15%)** out of 78 winners from **Panvel Municipal Corporation** have declared serious criminal cases against themselves in their affidavits

- **Crorepatis**: Out of the 245 analyzed winners, **119 (49%)** are crorepatis.
- **Party wise Crorepati Winners**: **52 (66%)** out of **79** winners analysed from **BJP**, **18 (25%)** out of **72** winners analysed from **INC**, **17 (74%)** out of **23** winners analysed from **Bhartiya Shetkari Kamgar Paksh**, **17 (68%)** out of **25** winners analysed from **Shivsena** and **5 (23%)** out of **22** winners analysed from **NCP**, are Crorepatis.


## Other Background Details




