Summary and Highlights

Delhi Election Watch and Association for Democratic Reforms have analysed the self-sworn affidavits of all **7 Ministers including Chief Minister** from Delhi State Assembly 2013.

Criminal Background

- **Ministers with Serious Criminal Cases:** 2 out of the 7 Ministers have declared serious criminal cases against themselves

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
