Analysis of Election Expenses of MLAs from the Delhi 2013 Assembly Elections

According to Section 78 of the Representation of the People Act, 1951, every contesting candidate has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories. Election Expense limit for the Delhi 2013 Assembly Elections by the Election Commission of India is 14 Lakh Rupees, which is revised from time to time.

Delhi Election Watch (DEW) and Association for Democratic Reforms (ADR) have analyzed the election expenditure affidavits of 64 out of the 70 newly elected MLAs in the Delhi 2013 Assembly Elections. These election expense documents include *details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.*

Summary and Highlights of Election Expenses of MLAs from the Delhi 2013 Assembly Elections

- 1. Less than 50% of the Limit:** Candidates have constantly claimed that the election expenditure limit set by the ECI is very low. However, based on the election expense declarations of 67 out of 70 newly elected MLAs of Delhi to the ECI, **34 MLAs (51%) have declared election expenses of less than 50% of the expense limit** i.e. Rs 14 Lakhs.
- 2. Average Election Expenses:** Based on the election expense declarations of 67 out of the 70 newly elected MLAs of Delhi to the ECI, the **average amount of money spent** by them in the elections is only about **Rs 7.16 Lakhs, which is 51% of the expense limit** (14 Lakhs).
- 3. Party wise Average Election Expenses:** The Party wise average election expenses shows that the average spending for **30 MLAs of BJP is Rs 7.08 lakhs** (51% of the expense limit), for **AAP's 26 MLAs is Rs 7.26 lakhs** (52% of the expense limit), for **8 INC MLAs is Rs 7.51 lakhs** (54% of the expense limit), for **1 MLA of SAD is Rs 11.42 lakhs** (82% of the expense limit) for **1 MLA of JD(U) is Rs. 3.22 lakhs** (23% of the expense limit) and for **1 Independent MLA is Rs 3.97 Lakhs** (28% of the expense limit).
- 4. Election expense of Ministers:** The average election expense declared by 6 Ministers is **Rs 8.07 Lakhs**. **Girish Soni** has declared highest election expense of **Rs 12.53 Lakhs** (90% of expense limit) among ministers while **Arvind Kejriwal** declared lowest election expense of **Rs 3.99 Lakhs** (29% of expense limit).
- 5. Lowest Election Expenses:** **2 (3%) MLAs** have declared election expenses **less than Rs 3.5 lakhs** (that is about 25% of Expense Limit set by ECI).
- 6. Top 3 MLAs with highest Election Expenses:** The maximum expense of about **Rs 12.53 Lakhs** (90% of the expense limit) has been declared by **Girish Soni** of **AAP** from Madipur constituency followed by **Rakhi Birla** of **AAP** from Mangolpuri constituency with an

expense of **Rs 11.65 lakhs** (or 83% of the expense limit) and **Jarnail Singh** of **AAP** from Tilaknagar constituency with an expense of **Rs 11.64 Lakhs** (or 83% of the expense limit)

7. **MLAs with lowest Election Expenses:** The minimum expense of about **Rs 2.93 Lakhs** (or 21% of the expense limit) has been declared by **Jagdish Mukhi** of **BJP** from Janakpuri constituency. He is followed by **Shoaib Iqbal** of **JD(U)** from Matia Mahal constituency with election expenses of about **Rs. 3.22 lakhs** (or 23% of the expense limit) and **Ashok Kumar** of **AAP** from Ambedkar Nagar constituency with expenses of **Rs. 3.78 lakhs** (or 27% of the expense limit).
8. **Expense on Public Meetings and Processions:** **Neel Daman Khatri** of **BJP** from Nerela constituency has declared that he has **not spent ANY amount** on public meetings, processions etc. 3 other MLAs have declared less than Rs 20,000 expenses on public meetings and processions.
9. **Expense on Campaigning through electronic/print media:** **24(36%) MLAs** have declared that they have **not spent ANY amount** on campaigning through electronic/print media.
10. **Expense on Campaign Workers:** **20 (31%) MLAs** have declared that they **have not spent ANY amount** on campaign workers.
11. **Expense on Vehicles Used:** **Shoaib Iqbal** of **JD(U)** from Matia Mahal constituency has declared **Zero expense on use of vehicles**. **4 other MLAs** have declared less than **Rs 20,000** expenses on vehicle use.
12. **Expense on Campaign Materials and Erection of gates, arches, banners etc.:** **Vinod Kumar Binny** of **AAP** from Laxminagar constituency and **Arvind Kejriwal** from New Delhi constituency have declared **Zero expense** on campaign materials.

Analysis of the Election Expenses – MLAs

Election expenses declared by Ministers

The average election expense declared by 6 Ministers is **Rs 8.07 Lakhs**. **Girish Soni** has declared highest election expense of **Rs 12.53 Lakhs** (90% of expense limit) among ministers while **Arvind Kejriwal** declared lowest election expense of **Rs 3.99 Lakhs** (29% of expense limit).

He is followed by **Shoaib Iqbal of JD(U)** from Matia Mahal constituency with election expenses of about **Rs. 3.22 lakhs** (or 23% of the expense limit) and **Ashok Kumar of AAP** from Ambedkar Nagar constituency with expenses of **Rs. 3.78 lakhs** (or 27% of the expense limit).

MLAs who declared NO expenses on Public Meetings, Processions etc.

According to the ECI's document of Election Expenditure Monitoring 2011, (5.5.1) *Any candidate or his representative, who applies for permission for a public meeting or a rally shall also submit an expenditure plan in a prescribed format along with the application for permission.* (5.6.2) *In the event of public rally or meeting by the star campaigner, if the candidate or his election agent shares the dias with the star campaigner/another dignitary or banners and posters with his name or photograph are displayed at the site of the rally or his name is mentioned by the Star Campaigner, then the entire expenditure on that rally other than the travel expenses on that star campaigner should be added to the candidate's expenses.*

Neel Daman Khatri of BJP from Nerela constituency has declared that he has **not spent ANY amount** on public meetings, processions etc. 3 other MLAs have declared less than Rs 20,000 expenses on public meetings and processions. The names of these MLAs are listed below:

MLAs who declared NO expense on campaigning through electronic/print media

This category for monitoring election expenses is mainly to combat instances of "paid news" and surrogate advertising that many candidates resort to. According to 4.10.4 of ECI's document of Election Expenditure Monitoring 2011, *"The candidate will have to submit the details of expenditure on the telecast/ broadcast in electronic media and advertisement/ paid news in print media. If the Media monitoring cell finds that any advertisement has been published in favour of any candidate without*

proper permission, they shall inform the RO immediately, and the RO will issue a notice to the candidate u/s 127 of the R.P.Act, 1951”.

24(36%) MLAs have declared that they have **not spent ANY amount on** campaigning through electronic/print media. The table below provides a list of the names of these MLAs.

According to 5.9.1 of ECI's document of Election Expenditure Monitoring 2011, "Each candidate shall submit before the R.O., details of all vehicles proposed to be used by him for his election campaign. The R.O. will issue permits for use on the same day. The vehicle permit obtained from the concerned RO is to be displayed on the front screen of the vehicle..."

Shoaib Iqbal of JD(U) from Matia Mahal constituency has declared **Zero expense on use of vehicles. 4 other MLAs** have declared less than **Rs 20,000** expenses on vehicle use. The table below provides the list of five MLAs who have declared least expense on use of vehicles:
