रिपोर्ट के मुख्य अंश

एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और दिल्ली इलेक्शन वॉच ने दिल्ली विधानसभा के 70 में से 65 वर्तमान विधायकों के वित्तीय, आपराधिक एंव अन्य विवरणों का विश्लेषण किया। वर्तमान विधानसभा में 5 सीटें रिक्त हैं।

यह विश्लेषण 2020 के विधानसभा चुनावों और उसके बाद हुए उपचुनावों में उम्मीदवारों द्वारा प्रस्तुत शपथपत्रों पर आधारित है।

वर्तमान विधानसभा में निम्नलिखित निर्वाचन क्षेत्रों में 5 सीटें रिक्त है।



आपराधिक पृष्टभूमि

- **विधायकों द्वारा घोषित आपराधिक मामले**:— **65** में से **43 (66 प्रतिशत)** वर्तमान विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये है।
- विधायकों द्वारा घोषित गंभीर आपराधिक मामले:— 36 (55 प्रतिशत) वर्तमान विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये है।
- **हत्या का प्रयास से सम्बन्धित मामले घोषित करने वाले विधायक**ः **1** वर्तमान विधायक ने अपने ऊपर हत्या का प्रयास (आईपीसी—307) से सम्बन्धित मामला घोषित किया है।
- महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले विधायकः 13 वर्तमान विधायकों ने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं। इन 13 में से 1 वर्तमान विधायक ने अपने ऊपर बलात्कार (आईपीसी-376) से सम्बन्धित मामला घोषित किया हैं।
- क वर्तमान विधायकों द्वारा घोषित आपराधिक मामले—दलवारः AAP के 58 में से 38 (66 प्रतिशत) और 7 में से 5 (71 प्रतिशत) BJP के विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये है।
- जित्मान विधायकों द्वारा घोषित गंभीर आपराधिक मामले—दलवारः AAP के 58 में से 32 (55 प्रतिशत) और 7 में से 4 (57 प्रतिशत) BJP के विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये है।



- 6. लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)
- 7. भ्रष्टाचार निरोधक अधिनियम कानून के तहत अपराध
- 8. महिलाओं और बच्चों के ऊपर अत्याचार से सम्बन्धित अपराध









- ङ <u>शैक्षिक योग्यताः</u> 23 (35 प्रतिशत) विधायकों ने अपनी शैक्षिक योग्यता 8वीं और 12वीं के बीच घोषित की हैं, जबकि 38 (58 प्रतिशत) विधायकों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज़्यादा घोषित की हैं। 4 विधायकों ने अपनी शैक्षिक योग्यता डिप्लोमा धारक घोषित की हैं।
- क विधायकों की आयुः 38 (58 प्रतिशत) विधायकों ने अपनी आयु 25 से 50 वर्ष के बीच घोषित की हैं, जबकि 27 (42 प्रतिशत) विधायकों ने अपनी आयु 51 से 80 वर्ष के बीच घोषित की हैं।






