Lok Sabha 2019 Phase II - Puducherry

The Puducherry Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of 17 out of 18 candidates.

One candidate has not been analysed due to the unavailability of his complete affidavit on the ECI website. The details of candidate are given below:

<u>Criminal Background, Financial, Education, Gender and other details of Candidates</u>

- > There are 3 (18%) candidates who have declared criminal cases against themselves. Out of these, 2 have declared serious criminal cases against themselves.
- > 4(24%) candidates are crorepati.
- > The average asset per candidate contesting in the Lok Sabha 2019 from Puducherry is Rs. 3.66 crores.
- There are candidates 9 candidates who have declared liabilities.
- There is only 1 woman candidate contesting in Lok Sabha phase II from Puducherry.
