Asset Comparison of Re-contesting Candidates and MLAs Contesting in Phase 1 and Phase 2 of the Gujarat Assembly Elections 2012

Summary of asset comparison of re-contesting candidates

- 171 re-contesting (candidates who fought elections in 2007 and now in 2012 are again in the fray) candidates have been analyzed for the Gujarat Assembly Elections 2012
- The average assets of candidates fielded by various parties in 2007 was Rs 1,85,04,727 (1.85 crore)
- The average assets of the re-contesting candidates now in 2012 is Rs 7,10,14,468 (7.10 crore)
- The average asset growth for these re-contesting candidates is Rs 5,25,09,741 (5.25crore)
- Average percentage growth in assets for these re-contesting candidates is 284%
- Balvantsinh Chandansinh Rajput of INC from Sidhpur constituency has declared maximum increase in assets with an increase of Rs 233.73 crore i.e from Rs. 34.66 crores in 2007 to Rs. 268.40 crores in 2012. Assets of Chavada jawaharbhai Pethaljibhai (of INC from Manavadar) have increased by Rs 64.57 crore, from Rs 18.32 crore in 2007 to Rs 82.90 crore in 2012. Assets of Patel Dineshbhai Balubhai (of BJP from Padra) have risen by Rs 34.89 crore, from Rs 4.51 crore in 2007 to Rs 39.41 crore in 2012.
- The highest percentage increase (5525%) in assets has been declared by Kavadiya Jayantbhai Ramjibhai of BJP from Dhrangadhara constituency. Kavadiya Jayantbhai Ramjibhai's assets increased from Rs. 10.50 lakhs in 2007 to Rs 5.91 crore in 2012. Panada Vajesinghbhai Parsingbhai of INC from Dahod (ST) constituency has declared an increase in assets of 4281%, his assets have risen from Rs. 4.40 lakhs in 2007 to Rs 1.92 crore in 2012. Shailesh Manharbhai Parmar of INC from Danilimda (SC) constituency falls at third position with 2944% increase in assets; his assets have grown from Rs 96.15 Lakhs in 2007 to Rs 29.26 Crore in 2012.
- 6 candidates have reported decrease in assets in 2012 as compared to value of assets in 2007. They are Pravinsinh Prabhatsinh Chauhan (13% reduction in assets, from Rs 83.54 lakhs in 2007 election to Rs 72.79 Lakhs in 2012) of BJP from Godhra, Dalal Patel Saurabh Yashyantbhai (13% decline in assets, Rs 65.29 crore in 2007 to Rs 56.60 crore in 2012) of BJP from Akota, Govindbhai Ukabhai Patel (22% decline in assets, Rs. 1.48 crore in 2007 to Rs 1.16 crore in 2012) of BJP from Rajkot

South, Jaswantbhai Amarsinh Solanki(a decline by 43% in his assets, Rs 1.64 Crore in 2007 to 94.81 Lakhs in 2012) of BJP from Anklav constituency, Makwana Kirankumar Laxmanbhai (45% decline in assets, Rs 21.54 Lakhs in 2007 to Rs 11.93 Lakhs in 2012) of INC from Jambusar and Mohanbhai Dahyabhai Patel (60% decline in assets, Rs 2 Lakhs in 2007 to Rs 80 thousand in 2012) of JD(U) from Mahuva(ST) constituency .

Summary of asset comparison of re-contesting MLAs

- 121 sitting MLAs who are again contesting elections (whom we call re-contesting MLAs) have been analyzed for the Gujarat Assembly Elections 2012.
- The average assets of these re-contesting MLAs in 2007 was Rs 1,86,11,795 (1.86 crore)
- The average assets of these MLAs who are contesting elections again now in 2012 is Rs 6,20,99,047 (6.20 crore)
- The average growth in assets for these re-contesting MLAs is Rs 4,34,87,252 (Rs 4.34 crore)
- Average percentage growth in assets for these re-contesting MLAs is 234%
- Chavada jawaharbhai Pethalagbhai (of INC from Manavadar) have increased by Rs 64.57 crore, from Rs 18.32 crore in 2007 to Rs 82.90 crore in 2012. Patel Dineshbhai Balubhai (of BJP from Padra) have risen by Rs 34.89 crore, from Rs 4.51 crore in 2007 to Rs 39.41 crore in 2012. Assets of Aacharya Dr.Nimaben Bhavesbhai (a BJP MLA from Bhuj) have increased by Rs 32.30 crore, from Rs 2.34 crore in 2007 to Rs 34.64 crore in 2012.
- Panada Vajesingbhai Parsingbhai an INC MLA from Dahod(ST) has declared the highest percentage increase in assets of 4281%, from Rs 4.40 lakh in 2007 to Rs 1.92 crore in 2012. Parmar Shailesh Manharbhai an INC MLA from Danilimda has shown a percentage increase in assets of 2944%, from Rs 96.15 lakh in 2007 to Rs 29.26 crore in 2012. Vasava Chhotubhai Amarsinh a JD(U) MLA from Jaghadia (ST) has shown his assets go up by 2860%, from Rs 9.15 lakhs in 2007 to Rs 2.70 crores in 2012. From BJP Makwana Bhavnaben Raghavbhai from Mahuva(ST) constituency has declared maximum asset increase of 2275%, from Rs 3.67 Lakhs in 2007 to Rs 87.35 Lakhs in 2012.
- 3 MLAs has reported a decrease in assets in 2012 as compared to their correponding value of assets in 2007. He is Dalal Patel Saurabh Yashyantbhai(13% reduction in assets, from Rs 65.29 crores in 2007 elections to Rs 56.60 crores in 2012) of BJP from Akota constituency, Govindbhai Ukabhai Patel (22% decline in assets, Rs. 1.48 crore in 2007 to Rs 1.16 crore in 2012) of BJP from Rajkot South, Makwana Kirankumar Laxmanbhai (45% decline in assets, Rs 21.54 Lakhs in 2007 to Rs 11.93 Lakhs in 2012) of INC from Jambusar constituency .

Asset Comparison of Re-contesting Candidates

Average asset increase of re-contesting Candidates: Party-Wise

The table below provides the party-wise categorization of average asset increase of re-contesting candidates. Financial details of 97 candidates fielded by BJP have been taken from the recently filed affidavits by these candidates and the values of these financial assets have been compared to the corresponding values of the assets that the candidates showed in their affidavits in 2007. The same procedure has been followed for other parties as well and it has been found that average increase in the assets of 97 candidates who have again been given tickets by BJP is Rs 4.21 crore. INC with 66 re-contesting candidates has shown Rs 7.32 crore as the average increase in the assets of these candidates between 2007 and 2012. Assets of re-contesting Candidates in Gujarat 2012 Assembly Elections

Top 5 candidates with highest asset increase in Rupees

The table below provides the increase in assets of re-contesting candidates. In Rupees, the maximum growth in assets has been for Balvantsinh Chandansinh Rajput of INC from Sidhpur constituency with increase of Rs 233.73 crore i.e from Rs. 34.66 crores in 2007 to Rs. 268.40 crores in 2012, followed by Jawaharbhai Pethalajibhai Chavada of INC from Manavadar constituency with an increase of Rs 64.57 crore i.e from 18.32 crore in 2007 to 82.90 crore in 2012. Assets of Patel Dineshbhai Balubhai (of BJP from Padra) have increased by Rs 34.89 crore, from Rs 4.51 crore in 2007 to Rs 39.41 crore in 2012 and assets of Acharya Dr.Nimaben Bhavesbhai(of BJP from Bhuj) have risen by Rs 32.30 crore, from Rs 2.34 crore in 2007 to Rs 34.64 crore in 2012. Shailesh Parmar of INC from Danilimda(SC) constituency has declared an increase of 28.30 crore in his assets, i.e from 96.15 Lacs in 2007 to 29.26 crore in 2012.

Top 5 candidates with highest asset increase in Percentage

The table below provides the top 5 re-contesting candidates with highest % increase in assets. The highest percentage increase (5525%) in assets has been declared by Jayantibhai Ramjibhai Kavadiya of BJP whose assets increased from 10.5 Lacs in 2007 to 5.91 crore in 2012. He is followed by Panada Vajesinghbhai Parsingbhai (4281%) an INC candidate from Dahod(ST) constituency. Panada Vajesinghbhai Parsingbhai's assets increased from Rs. 4.40 lakhs in 2007 to Rs 1.92 crore in 2012. Parmar Shailesh Manharbhai of INC from Danilimda (ST) constituency has declared an increase in assets of 2944%; his assets have risen from Rs. 96.15 lakh in 2007 to Rs 29.26 crore in 2012. Chhotubhai Amarsinh Vasava of JD(U) from Jhagadia(ST) constituency has declared an increase of 2860% increase in assets; his assets have grown from Rs 9.15 Lacs in 2007 to Rs 2.7 crore in 2012. Baldevji C.Thakore of INC from Kalol constituency has declared an increase of 2579% in his assets; his assets have grown from 63.91 Lacs to 17.12 crore in 2012.

The table below provides the party-wise categorization of average asset increase of re-contesting MLAs. Financial details of 81 candidates fielded by BJP have been taken from the recently filed affidavits by these MLAs and the values of these financial assets have been compared to the corresponding values of the assets that the MLAs showed in their affidavits in 2007. The same procedure has been followed for other parties as well and it has been found that average increase in the assets of 81 BJP MLAs who have again been given tickets by BJP is Rs 4.58 crore. INC with 37 re-contesting MLAs has shown Rs 4.06 crore as the average increase in the assets of these MLAs between 2007 and 2012. Patel Dineshbhai Balubhai a BJP MLA from Padra constituency has declared an increase of Rs 34.89 crore in his assets, his assets have grown from Rs. 4.51 crore in 2007 to Rs 39.41 crore in 2012. Assets of Aacharya Dr.Nimaben Bhavesbhai (a BJP MLA from Bhuj) have increased by Rs 32.30 crore, from Rs 2.34 crore in 2007 to Rs 34.64 crore in 2012. Assets of Parmar Shailesh Manharbhai (of INC from Danilimda) have risen by Rs 28.30 crore, from Rs 96.15 lakhs in 2007 to Rs 29.26 crore in 2012.
