Analysis of Income Tax Return details from affidavits of Candidates Contesting in Phase 1 and Phase 2 of the Gujarat Assembly Elections 2012

1. Solanki Hirabhai Odhavjibhai of BJP from Rajular constituency for the Financial Year 2011-12 and Italiya Ghanshyambhai Kanjibhai (GPP) from Katargam constituency for the Financial Year 2012-13 have declared the highest income of Rs. 3.41 Crores in their last Income Tax return. They are followed by Pabubha Virambha Manek of BJP from Dwarka constituency who has declared income of Rs. 3.25 Crores for the Financial Year 2011-12 in his last ITR, and Radadiya Jayeshbhai Vithalbhai, of INC from Jetpur constituency who has declared income of Rs. 2.53 crore for the Financial Year 2010-11 as per his last filed Income Tax Returns.

2. A total of 470 candidates (49%) out of the 952 candidates analyzed by the Gujarat Election Watch have declared that they have never filed income tax returns.

3. Of the 470 candidates analyzed who have declared that they have never filed income tax returns BJP has 30 (17%) out of 180 candidates, INC has 35 (20%) out of 171 candidates, GPP has 68 (43%) out of 157 candidates, BSP has 122 (81%) out of 150 candidates, and JD(U) has 44(73%) out of 60 candidates who have declared that they have not filed IT Returns.

4. **High Assets but no IT Return:** Top 3 candidates with maximum assets but who have declared that they have never filed IT returns are Parmar Rajabhai Parbathbhai of BSP contesting from Somnath constituency with total assets of Rs. 40.75 crores. He is followed by Jadeja Kandhalbhai Sarmanbhai of NCP from Kutiyana with assets of Rs. 28.29 crores and Mukeshbhai Damajibhai Satasiya(IND) from Jetpur constituency with assets worth Rs 5.95 crores. Vithalbhai Hanshrajibhai Radadia from Dhoraji with assets worth Rs. 5.62 crores is an INC candidate who has not filed ITR and Dilipkumar Virajibhai Thakor, contesting from Chanasama constituency with total assets of Rs. 4.73 crores is a BJP candidate who has declared that he has never filed Income Tax Return.

5. Gujarat Election Watch and ADR appeal to the voters of Gujarat to know what their candidates write in their affidavits so that they can make an informed choice on 13th and 17th December 2012
