In this regard, it is noted that the territorial jurisdiction over the area "Rajakori, New Delhi-110038" lies with Range-24 under CIT-VIII, New Delhi charge. Moreover, the PAN of the assessee does not lie with the undersigned as pointed out by your office because as per the online query on ITD, the jurisdiction if reflecting as "DEL-WS-66-3 for ITO WARD" whereas online jurisdiction of this office is identifiable only as "DEL-W-66-3 for ITO, WARD 36(3)". Therefore, neither the PAN lies with this office nor the jurisdiction of the said assessee lies with this office.

In the wake of foregoing facts, you may direct the respective AO of Range-24 to initiate the proceedings for inward-migration of PAN and supply the requisite information to the concerned applicant, if allowable as per Law.


