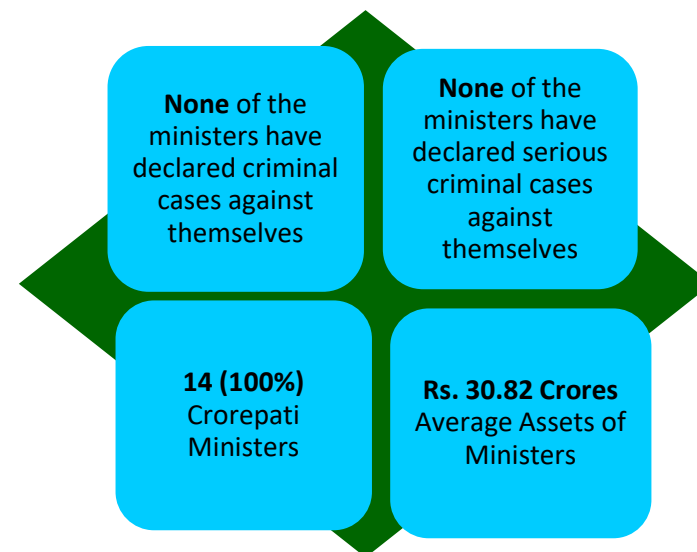

Association for Democratic Reforms (ADR) and Haryana Election Watch have analysed the self-sworn affidavits of all **14** Ministers including Chief Minister from **Haryana State Assembly Elections 2024**.

The information is based on the affidavits submitted by the ministers prior to 2024 Haryana Assembly Elections.

Criminal Background

- **Ministers with Criminal Cases:** None of the ministers have declared criminal cases against themselves.

Financial Background

- **Crorepati Ministers:** Out of the **14** ministers analysed, **all 14 (100%)** are crorepatis.
- **Average Assets:** The average assets of **14** ministers analysed is **Rs 30.82 crores**.
- **Minister with Highest Assets:** The minister with the highest declared total assets is **Shruti Choudhry** from **Tosham** constituency with assets worth **Rs. 134.56 crores**.
- **Minister with Lowest Assets:** The minister with the lowest declared total assets is **Shyam Singh Rana** from **Radaur** constituency with assets worth **Rs. 1.16 crores**.
- **Liabilities:** **10** ministers have declared liabilities out of which the minister with the highest liabilities is **Shruti Choudhry** of **Tosham** constituency with **Rs. 13.37 crores** of liabilities.

Other Background details (Education, Gender, Age)

- **Ministers' Education:** **3 (21%)** Ministers have declared their educational qualification **12th** standard while **11 (79%)** Ministers have declared having an educational qualification of **graduate and above**.
- **Ministers' Age:** **4 (29%)** ministers have declared their age to be between **31** and **50 years** while **10 (71%)** ministers have declared their age to be between **51** and **80 years**.
- **Women Ministers:** Out of **14** ministers analysed, **2(14%)** ministers are women.

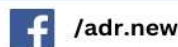
