The Jammu & Kashmir Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **all 24** candidates, who are contesting in the **Udhampur and Srinagar constituency in the Jammu & Kashmir Phase II Elections**.

6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
