# Jammu & Kashmir Election Watch\* Lok Sabha elections 2009

Lok Sabha 2009 elections were held in five phases in Jammu & Kashmir from April 16, 2009 to May 13, 2009. This chapter includes the analysis of voting trend, criminalization, money power, gender etc in these elections. Information provided by ECI and details from the affidavits filed by contesting candidates have been used for above analysis.

#### Growth of political parties

In Lok Sabha 2004, 19 parties contested elections which rose to 23 in 2009 Lok Sabha elections. This reflects a rise of 21% in the number of parties from 2004 Lok Sabha elections to 2009 Lok Sabha elections.

#### Growth in number of candidates

A total of 83 candidates contested in Lok Sabha 2004 from Jammu & Kashmir. This number decreased to 81 candidates in Lok Sabha 2009 elections. This shows a decline of 2.46% in the number of contesting candidates from Lok Sabha 2004 to Lok Sabha 2009.

# **Executive summary for <u>candidates</u> and <u>MPs</u>**

## Summary for candidates

- Affidavits of all 81 candidates contesting Lok Sabha 2009 elections were analyzed by Jammu & Kashmir Election Watch (J&KEW).
- Out of these 81 candidates, 4 candidates declared pending criminal cases against them. JKNPP, JKPDP & INC had 1 candidate each with pending criminal cases according to their self sworn affidavits.
- Out of these 4 candidates with pending criminal cases, 2 had pending serious criminal cases like waging, or attempting to wage war against the Government of India, Collecting arms with intention of waging war against the Government of India, cheating etc. JKNPP & JKPDP has 1 candidate each with pending serious criminal cases.
- There were 81 candidates contesting in 2009 and out of these 4 candidates had pending criminal cases against them. Comparing this to 2004 Lok Sabha elections, there were 83 candidates contesting in 2004. Out of these 1 candidate had pending criminal cases against him.
- There were 5 IPC charges of heinous nature on the candidates which included waging, or attempting to wage war against the Government of India, Collecting arms with intention of waging war against the Government of India, cheating etc.

This volume is dedicated to all who were part of the Election Watch.

- A total of 14 candidates out of 81 i.e. 17.28% were crorepatis.
- A total of 4 candidates declared zero assets.
- A total of 9 candidates declared liabilities above 5 lakhs.
- Among major parties, the average asset per candidate for JKPDP was Rs. 4.05 crores, for BJP was Rs 1.02 crores, for INC was Rs. 1.20 crore.
- 71.6% of candidates (58 of 81) had not furnished PAN card details.
- Number of women candidates was just 6 (7.4%) as compared to 75 of men (92.6%).
- More than 38% candidates (31 of 81) were graduates & above.
- None of the parties managed to get votes anywhere near 50%. The highest votes polled were approx 25% by INC and about 10% of the total registered voters. JKNC managed 19% of the votes and JKPDP 20%.

# Summary for MPs

- Of the 4 candidates with pending criminal cases against them, only 1 won and the remaining 3 were rejected by the voters.
- Out of 6 MPs, 1 (17%) has pending criminal cases against him. Comparing this to Lok Sabha 2004, affidavits were available for 6 MPs out of which no MP had pending criminal case against him/her.
- In Lok Sabha 2004, none of the MP has pending criminal case against them while in Lok Sabha 2009 1 MP has pending criminal case against him.
- The number of crorepati MPs has increased from 2 in Lok Sabha 2004 to 3 in Lok Sabha 2009.
- Among major parties, the average asset per MP for JKNC was Rs. 3.82 crores, INC Rs 68.22 Lakh
- Average asset for a MP from Jammu & Kashmir was Rs 2.23 crore.
- Out of 6 MPs, 3 had not declared their PAN details.

# Voting and winning trend

## The % of votes polled by major parties


The % of votes cast by the four major parties clearly shows that none of them got anywhere close to the 50% mark. Total voting in the state was only 40%. INC managed approx 24.67% of the votes cast and only 9.78% of the registered voters. JKNC managed just 19.11% votes cast and 7.58% registered voters. The total electorate in J&K was 65, 73,118 and the total votes cast were 26, 07,335.



# Analysis based on pending criminal cases

### Pending criminal cases- analysis for candidates

A total of 81 affidavits were analyzed by J&KEW for Lok Sabha 2009 elections. Out of these 81 candidates, 4 candidates declared pending criminal cases against them. Out of these 4 candidates with pending criminal cases, 2 had pending serious criminal cases like waging or attempting to wage war, or abetting waging of war, against the Government of India, Collecting arms, with intention of waging war against the Government of India, Cheating and dishonestly inducing delivery of property etc.

### Party wise break up for candidates with pending criminal cases

Total 4 candidates contesting elections from J & K had pending criminal cases against them. Out of 3 candidates of INC, 1 had pending criminal cases. JKPDP had 1 candidate with pending criminal cases out of 6.


# Analysis based on assets – <u>for candidates</u>




# Analysis based on assets- for MPs

Out of 6 MPs in Lok Sabha 2009, 3 MPs are crorepatis as compared to 2 crorepati MPs from Lok Sabha 2004 i.e. an increase of 50%. The average asset of a MP in 2004 Lok Sabha was Rs 91.79 lakhs which rose to Rs 2.23 cr in 2009. Between 2004 & 2009 there has been an average asset increase of 144% for MPs.

### Chances of winning based on assets

As can be seen from the table, the higher the assets the more are the chances of winning of a candidate. 50% of the candidates who declared assets more than 5 crores and above won. On the other hand not a single candidate with assets less than 10 lakhs won. The election results seemed to be highly influenced by the money power of the candidates


