

Association for Democratic Reforms (ADR) and Jammu and Kashmir Election Watch have analysed the self-sworn affidavits of all 6 Ministers including Chief Minister from **Jammu and Kashmir State Assembly Elections 2024**.

The information is based on the affidavits submitted by the ministers prior to 2024 Jammu and Kashmir Assembly Elections.

Criminal Background

- **Ministers with Criminal Cases:** None of the ministers have declared criminal cases against themselves.

Financial Background

- **Crorepati Ministers:** Out of the 6 ministers analysed, 5 (83%) are crorepatis.
- **Average Assets:** The average assets of 6 ministers analysed is Rs 4.12 crores.
- **Minister with Highest Assets:** The minister with the highest declared total assets is **Javed Ahmed Rana** from **Mendhar (ST)** constituency with assets worth Rs. 7.99 crores.
- **Minister with Lowest Assets:** The minister with the lowest declared total assets is **Omar Abdullah** from **Ganderbal** constituency with assets worth Rs. 55.24 lakhs.
- **Liabilities:** 4 ministers have declared liabilities out of which the minister with the highest liabilities is **Javed Ahmed Rana** of **Mendhar (ST)** constituency with Rs. 68.12 lakhs of liabilities.

Other Background details (Education, Gender, Age)

- **Ministers' Education:** 2 (33%) Ministers have declared their educational qualification 12th standard while 4 (67%) Ministers have declared having an educational qualification of **graduate and above**.
- **Ministers' Age:** 2 (33%) ministers have declared their age to be between 41 and 50 years while 4 (67%) ministers have declared their age to be between 51 and 70 years.
- **Women Ministers:** Out of 6 ministers, 1 is a woman.


