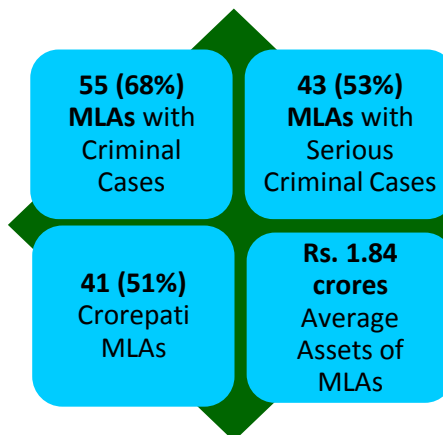

Jharkhand Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of 81 newly elected MLAs in the Jharkhand 2014 Assembly Elections.

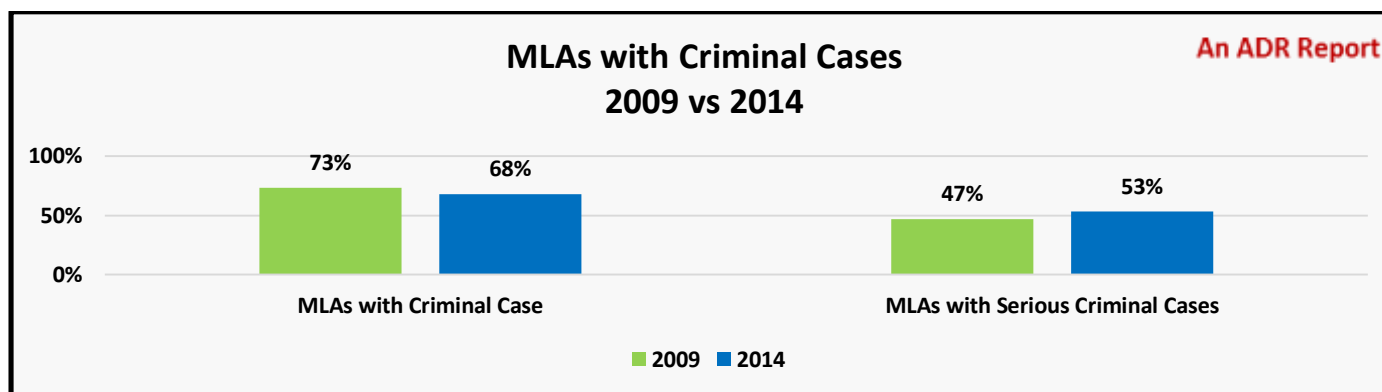

Criminal Background

- **MLAs with Criminal Cases:** Out of the **81** MLAs analysed, **55 (68%)** MLAs have declared criminal cases against themselves. Out of 75 MLAs analysed during **Jharkhand Assembly elections in 2009**, **55 (73%)** MLAs had **declared criminal cases** against themselves.
- **MLAs with Serious Criminal Cases:** **43 (53%)** MLAs have declared serious criminal cases including cases related to **murder, attempt to murder, communal disharmony, kidnapping, crimes against women** etc. Out of **75** MLAs analysed during **Jharkhand Assembly elections in 2009**, **35 (47%)** MLAs had **declared serious criminal cases** against themselves.
- **MLAs with Criminal Cases where Charges have been framed:** Out of the 55 MLAs who have declared pending criminal cases against themselves, **35 (64%)** have declared that the **charges for these cases have already been framed by the court of law.**

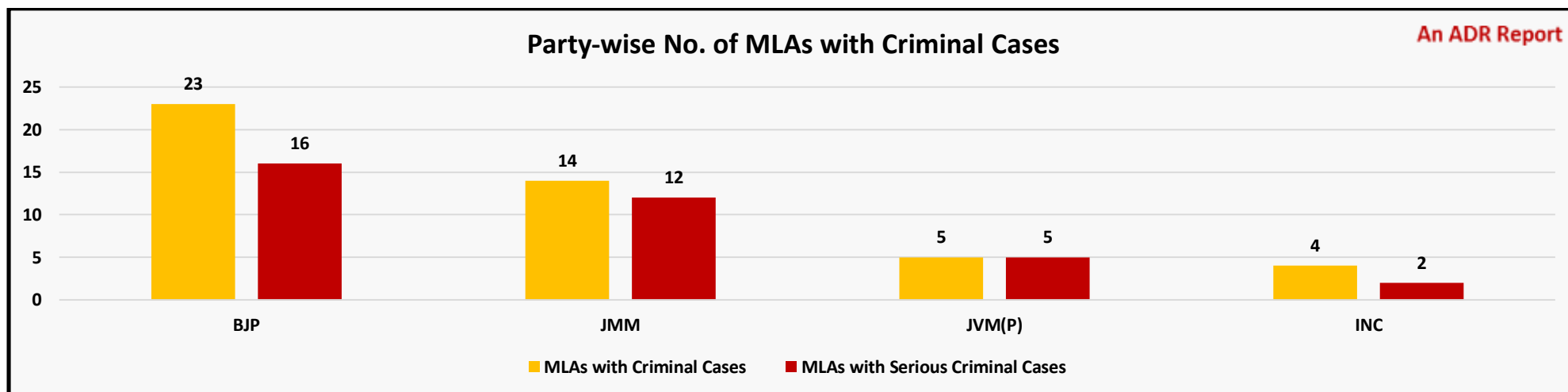
Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.



- **MLAs with cases related to murder and attempt to murder:** **3** MLAs have declared cases related to **murder**, one each from BJP, JMM and JVM(P). **13** MLAs have declared cases of attempt to murder out of which **3** MLAs are from BJP, **5** are from JMM and one each from AJSU Party, BSP, CPI(ML)(L), JVM(P) and Navjawan Sangharsh Morcha.
- **MLAs with cases related to Crimes against Women:** **3** MLAs have declared cases related to crimes against women with cases related to **assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)** and **1** charge related to **word, gesture or act intended to insult the modesty of a woman (IPC Section-509).**

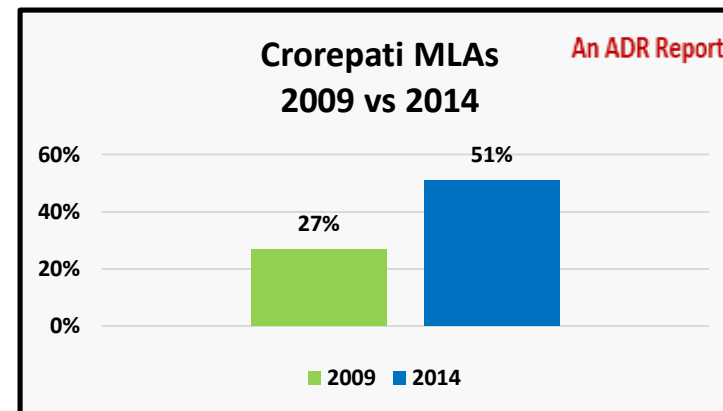
- **MLA with case related to causing Communal Disharmony:** 1 MLA has declared a case related to Injuring or defiling place of worship with intent to insult the religion of any class (IPC Section-295).
- **MLAs with cases related to Kidnapping:** 1 MLA has declared a case related to Kidnapping or abducting in order to murder (IPC Section-364).
- **Party wise MLAs with Criminal Cases:** 23 (62%) out of 37 MLAs from BJP, 14 (74%) out of 19 MLAs from JMM, 5 (63%) out of 8 MLAs from JVM(P), 3 (60%) out of 5 MLAs from AJSU and 4 (67%) out of 6 INC MLAs have declared criminal cases against themselves in their affidavits.
- **Party wise MLAs with Serious Criminal Cases:** 16 (43%) out of 37 MLAs from BJP, 12 (63%) out of 19 MLAs from JMM, 5 (63%) out of 8 MLAs from JVM(P) and 2 (33%) out of 6 INC MLAs have declared serious criminal cases against themselves in their affidavits.



Financial Background

- **Crorepati MLAs:** Out of the **81** newly elected MLAs, **41 (51%)** are crorepatis. Out of **75** MLAs analysed during **Jharkhand 2009 assembly elections**, **20 (27%)** MLAs were crorepatis.
- **High Asset MLAs:** Out of the 81 newly elected MLAs, 2 MLAs have total assets worth more than Rs. 15 crores. The top 3 MLAs with highest assets are as follows:

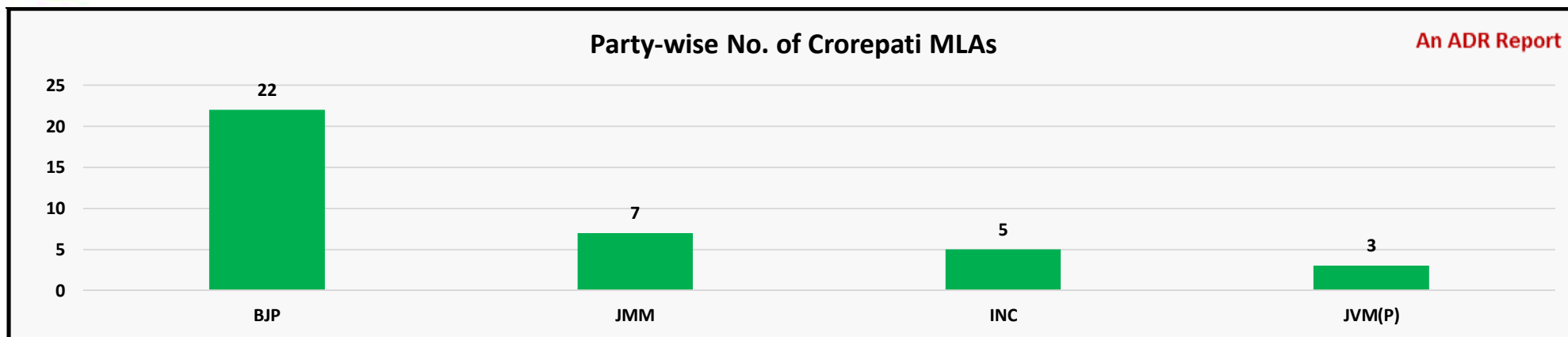

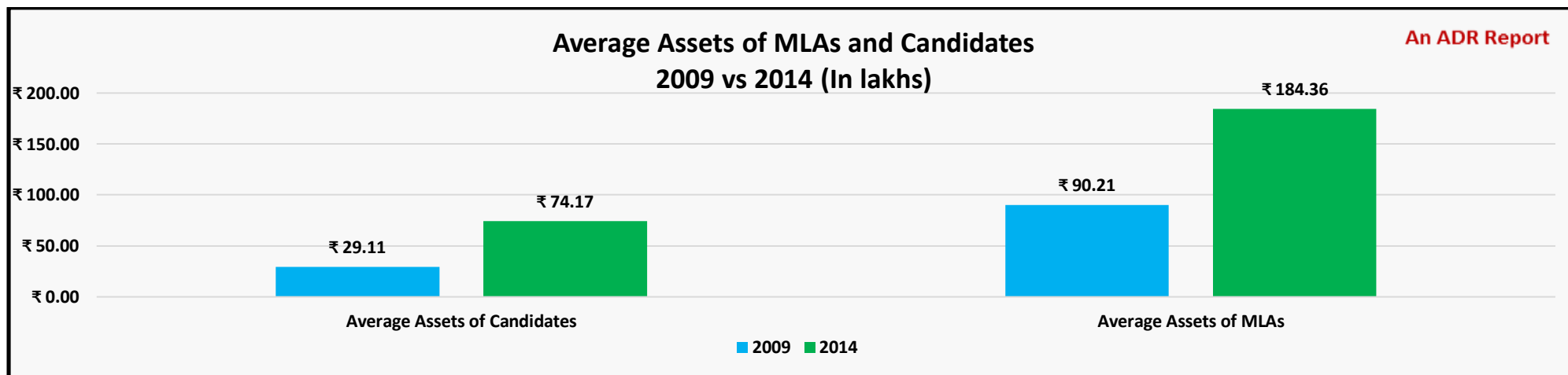

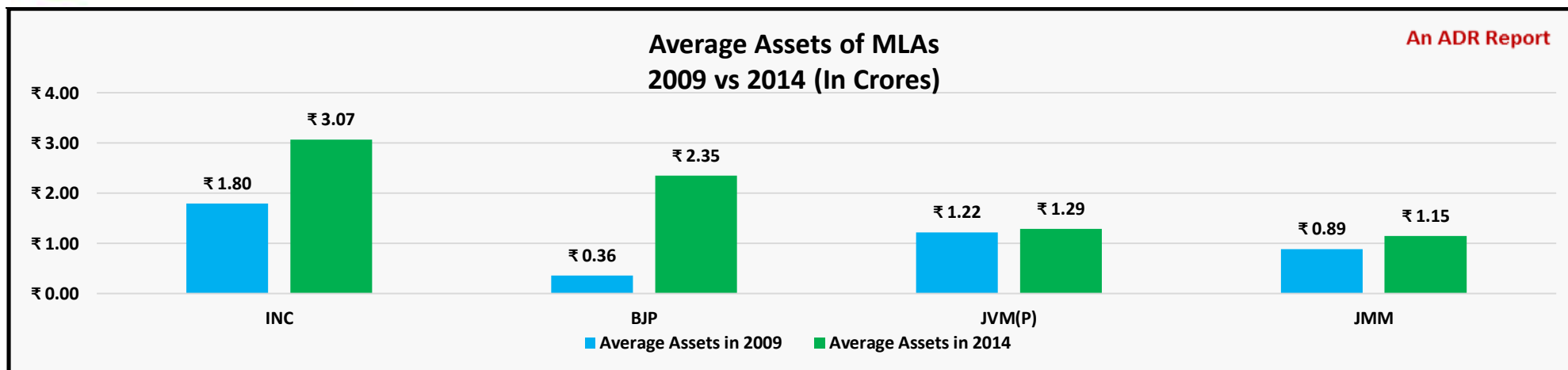
- **Party-wise Crorepati MLAs:** **22 (59%)** out of 37 MLAs in **BJP**, **7 (37%)** out of 19 MLAs in **JMM**, **5 (83%)** out of 6 MLAs in **INC** and **3 (38%)** out of 8 MLAs from **JVM(P)** have declared assets worth more than Rs. 1 crore.



- **Average Assets:** The average assets per MLA for Jharkhand 2014 assembly elections are **Rs. 1.84 crores** whereas the average asset for each candidate was Rs. 74.17 lakhs. In 2009 the average assets per 75 MLAs analyzed was Rs. 90.21 lakhs.



- **Party-wise Average Assets:** Among major parties, the average assets per MLA for **37 BJP** MLAs analysed is **Rs 2.35 crores**, **19 JMM** MLAs have average assets of **Rs.1.15 crores**, **8 JVM(P)** MLAs have average assets worth of **Rs.1.29 crores** and **6 INC** MLAs have average assets of **Rs. 3.07 crores**.



- **Chances of Winning for Crorepati Candidates:** The chances of winning for a crorepati candidate in the Jharkhand Assembly 2014 elections are 21% whereas for a candidate with low assets (<Rs. 1 crore) it is 4%.

Note:

$$\text{Chances of Winning for Crorepati Candidates} = \frac{\text{Crorepati Winners}}{\text{Crorepati Candidates}}$$

$$\text{Chances of Winning for Candidate with Low Assets} = \frac{\text{Winners with Low Assets}}{\text{Candidates with Low Assets}}$$

- **Candidates Asset Position and Chances of Winning:** 57 (70%) MLAs occupy top three highest asset positions in their respective constituency. 16(20%) MLAs have the **highest declared assets** in their constituency. 28 (35%) MLAs have the **second highest declared assets** in their constituency and 13 (16%) MLAs have the third highest declared assets in their constituency.
- **MLAs with High Liabilities:** 2 MLAs have declared liabilities of Rs. 1 crore and above. The details of these MLAs are as follows:

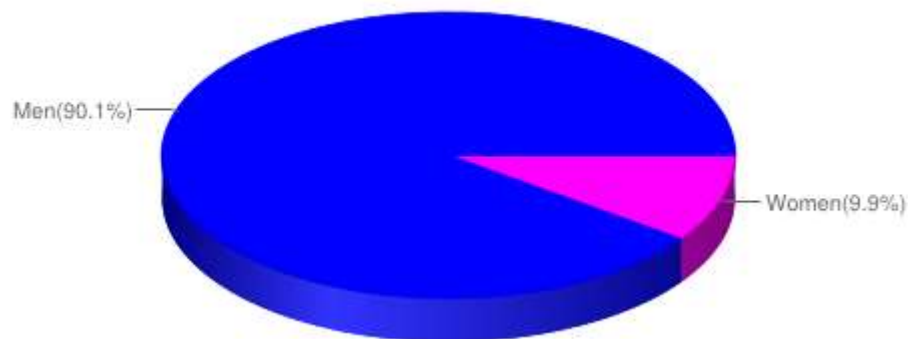
