## रिपोर्ट के मुख्य अंश

एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और झारखंड इलेक्शन वॉच ने झारखंड विधानसभा के 81 में से 74 वर्तमान विधायकों के वित्तीय, आपराधिक एवं अन्य विवरणों का विश्लेषण किया। 03-11-2020 के उपचुनाव में निर्वाचन क्षेत्र बेरमो से चुनाव लड़ने वाले एक INC के विधायक कुमार जयमंगल (अनूप सिंह) का शपथपत्र उपलब्ध ना होने के कारण उनका विश्लेषण नहीं किया गया है। वर्तमान विधानसभा में 6 सीटें रिक्त हैं।

यह विश्लेषण 2019 के विधानसभा चुनावों और उसके बाद हुए उपचुनावों में उम्मीदवारों द्वारा प्रस्तुत शपथपत्रों पर आधारित है।

वर्तमान विधानसभा में निम्नलिखित निर्वाचन क्षेत्रों में 6 सीटें रिक्त हैं।

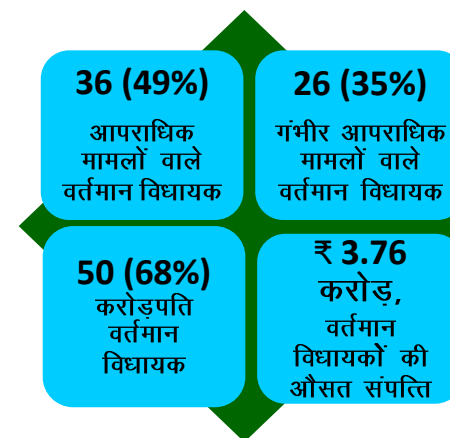

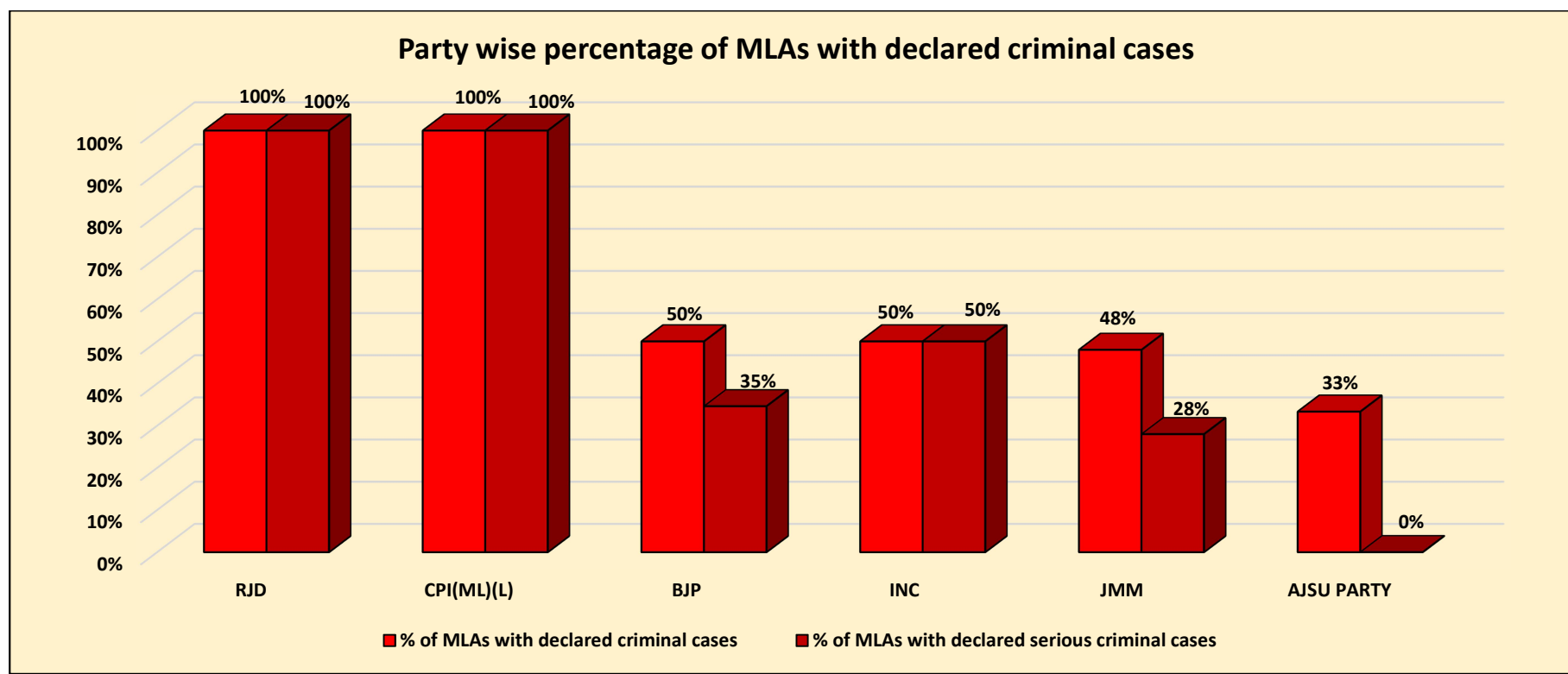
- ☞ विधायकों द्वारा घोषित आपराधिक मामले:— 74 में से 36 (49 प्रतिशत) वर्तमान विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।
- ☞ विधायकों द्वारा घोषित गंभीर आपराधिक मामले:— 26 (35 प्रतिशत) वर्तमान विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।
- ☞ हत्या से सम्बन्धित मामले घोषित करने वाले विधायक: 2 वर्तमान विधायकों ने अपने ऊपर हत्या (आईपीसी-302) से सम्बन्धित मामले घोषित किये हैं।
- ☞ हत्या का प्रयास से सम्बन्धित मामले घोषित करने वाले विधायक: 6 वर्तमान विधायकों ने अपने ऊपर हत्या का प्रयास (आईपीसी-307) से सम्बन्धित मामले घोषित किये हैं।
- ☞ महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित करने वाले विधायक: 2 वर्तमान विधायकों ने महिलाओं के ऊपर अत्याचार से सम्बन्धित मामले घोषित किये हैं। इन 2 में से 1 वर्तमान विधायक ने अपने ऊपर बलात्कार (आईपीसी-376) से सम्बन्धित मामला घोषित किया है।
- ☞ वर्तमान विधायकों द्वारा घोषित आपराधिक मामले—दलवार: BJP के 26 में से 13 (50 प्रतिशत), JMM के 25 में से 12 (48 प्रतिशत), INC के 16 में से 8 (50 प्रतिशत) और 3 में से 1 (33 प्रतिशत) **AJSU Party** के विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।

5. हमला, हत्या, अपहरण, बलात्कार से सम्बन्धित अपराध
6. लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)
7. भ्रष्टाचार निरोधक अधिनियम कानून के तहत अपराध
8. महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध

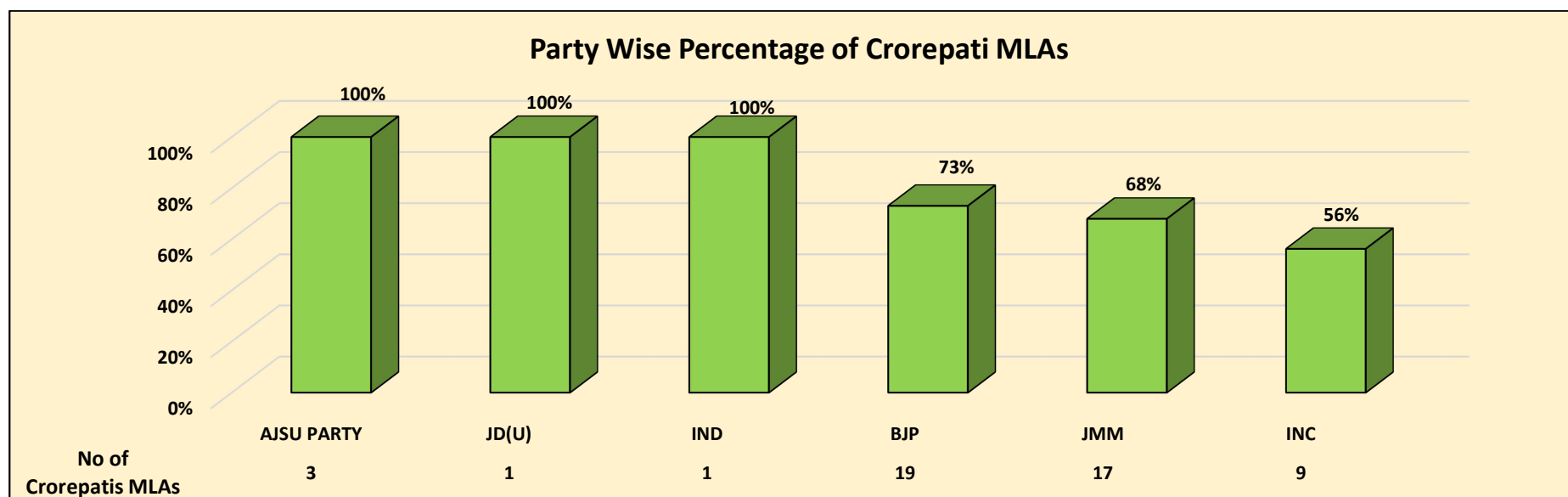
☞ वर्तमान विधायकों द्वारा घोषित गंभीर आपराधिक मामले—दलवार: **BJP** के 26 में से 9 (35 प्रतिशत), **JMM** के 25 में से 7 (28 प्रतिशत) और 16 में से 8 (50 प्रतिशत) **INC** के विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।

## वित्तीय पृष्ठभूमि

- ☞ करोड़पति विधायक: 74 में से 50 (68 प्रतिशत) वर्तमान विधायक करोड़पति हैं।
- ☞ करोड़पति विधायक-दलवार: **BJP** के 26 में से 19 (73 प्रतिशत), **JMM** के 25 में से 17 (68 प्रतिशत), **INC** के 16 में से 9 (56 प्रतिशत) और **AJSU Party** के 3 (100 प्रतिशत) विधायक करोड़पति हैं। (घोषित संपत्ति ₹ 1 करोड़ से ज़्यादा)।

- ☞ शैक्षिक योग्यता: 23 (31 प्रतिशत) विधायकों ने अपनी शैक्षिक योग्यता 8वीं और 12वीं के बीच घोषित की हैं, जबकि 47 (64 प्रतिशत) विधायकों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज़्यादा घोषित की हैं। 2 विधायकों ने अपनी शैक्षिक योग्यता डिप्लोमा धारक घोषित की हैं। 2 विधायकों ने अपनी शैक्षिक योग्यता साक्षर घोषित की हैं।
- ☞ विधायकों की आयु: 48 (65 प्रतिशत) विधायकों ने अपनी आयु 25 से 50 वर्ष के बीच घोषित की हैं, जबकि 26 (35 प्रतिशत) विधायकों ने अपनी आयु 51 से 80 वर्ष के बीच घोषित की हैं।

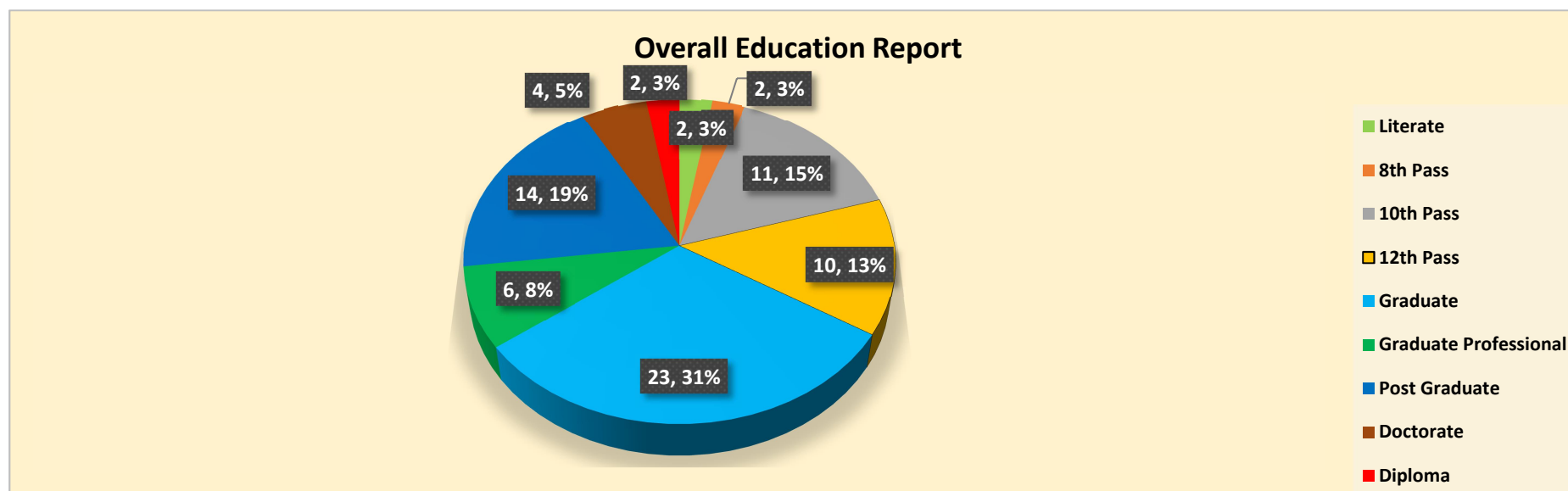

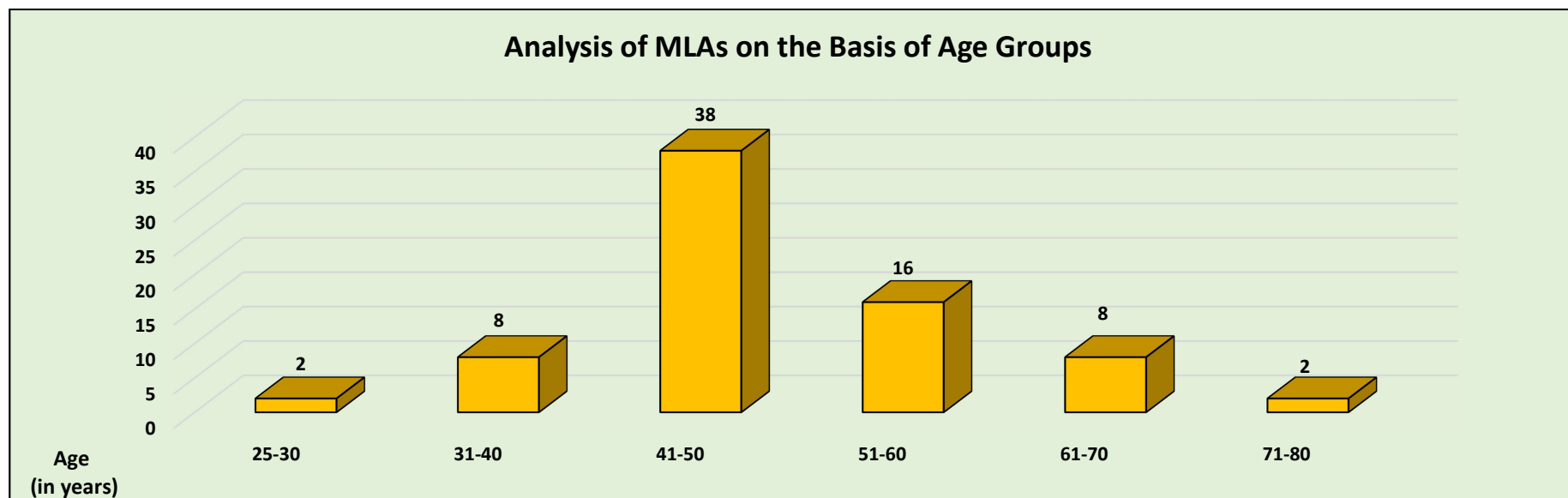

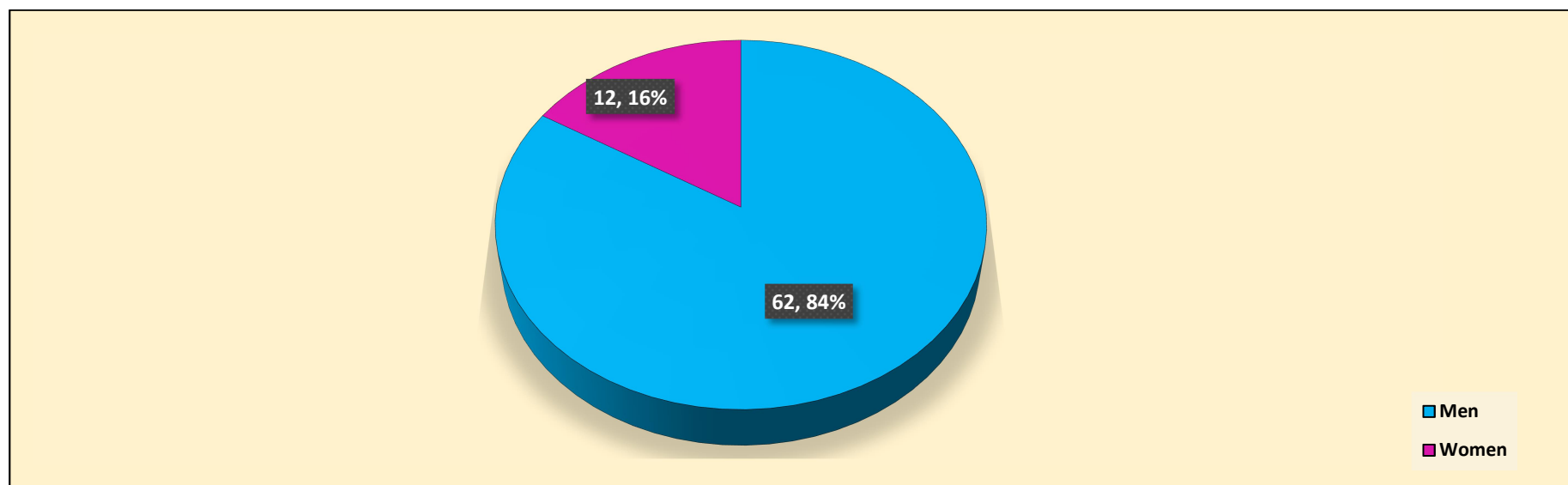
